Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Williams Tank Lines Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Williams Tank Lines Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Williams Tank Lines Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Williams Tank Lines Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan Document, as amended, for a more complete description of the Plan's provisions.

Williams Tank Lines, Inc. (the Company and/or Plan Sponsor), established the Plan effective January 1, 2022. The Plan, as amended, operates as a leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company's ESOP Committee; if no committee has been appointed, the Plan Administrator shall be responsible for administration.

Effective December 27, 2022, the Company entered into a series of transactions (the Transaction) in which all of the issued and outstanding common stock of the Company (1,000,000 shares) was sold to the Williams Tank Lines Employee Stock Ownership Trust (the Trust), a part of the Williams Tank Lines Employee Stock Ownership Plan (the Plan, and, together with the Trust, the ESOP). The Transaction was effected pursuant to an ESOP Stock Purchase Agreement (the Agreement) by and among the ESOP Trustee, the Company, and the common shareholders of the Company as set forth in the Agreement (collectively, the Sellers). The Sellers sold their shares to the Trust for a total aggregate purchase price of \$52,598,547, which equates to a price per share of \$52.60. The Sellers agreed to accept deferred payment from the Trust in the form of promissory notes (the Seller Notes).

Subsequent to the sale of shares to the Trust, the Seller Notes were refinanced subject to an Assumption Agreement whereby the Company assumed the Sellers' Notes and all obligations thereunder from the Trust in exchange for a promissory note between the Company and the Trust in the original principal amount of \$52,598,547. This promissory note and corresponding credit agreement is referred to as the ESOP Note.

In connection with the Seller Notes, the sellers received detachable warrants to purchase 435,000 shares of common stock of the Company. The warrants have certain put and call provisions and expire on the date when the Seller Note is paid off in full or the date the note is scheduled to be paid off.

The ESOP Loan, totaling \$52,598,547, bears interest at the rate of 4.34%. After additional payments on the ESOP Loan in 2023 and 2024, payments of principal and interest, totaling approximately \$2,587,039, are due in 23 equal annual installments beginning December 31, 2025, through December 31, 2047. The loan may be prepaid without penalty.

Shares are released as the debt is repaid and are allocated among participants on the basis of compensation in the year of allocation. Benefits become 100% vested after six years of credited service. Forfeitures of nonvested benefits will be reallocated among remaining participating employees in the same proportion as contributions.

The Consolidated ESOP Loan is collateralized by the unallocated shares of common stock and guaranteed by the Company. The Company has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024, present separately the assets and liabilities, and changes therein, pertaining to:

- a. the accounts of employees with vested rights in allocated common stock (allocated), and
- b. common stock not yet allocated to employees (unallocated).

Eligibility – Each eligible employee employed by the Company on or before December 31, 2021, became a participant on January 1, 2022. Thereafter, employees of the Company are eligible to participate in the Plan immediately upon hire and attainment of age 21.

Participants must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible to receive any employer-paid contributions, such as an allocation of stock. Hours of service requirement is waived in the first year of plan participation. Participants who terminate due to disability, death, or retirement receive an allocation of stock in the year of termination.

Employer contributions – The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted.

Voting rights – Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote any allocated share for which specific instructions have not been given by a participant and is required to vote any unallocated shares on behalf of the collective best interest of the Plan's participants and beneficiaries.

Participant accounts – The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year end with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting – If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. After two to three years of service, participants vest 20% per year, and are 100% vested after completing six or more years of service.

Payment of benefits – On termination of service due to death, disability, or retirement, distributions are made in a lump sum in the plan year following the event. Distributions for other separations from service commence not later than the sixth plan year following the separation from service, and may be made in a lump sum or in annual installments over a five-year period (up to ten years if participant's capital accumulation account exceeds certain limits), at the Company's discretion. The amount to be distributed is based upon the immediately preceding valuation date.

Distributions will be made in cash, shares of Company common stock, or a combination of both, as determined by the Company and the participants' rights under the Plan. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan.

Administrative expenses – As provided in the Plan document, administrative expenses may be paid either by the Plan or by the Company.

Put option – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of stock. The Company can pay for the purchase in a lump sum or in equal annual installments with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage increases to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year end based upon the shares of employer stock in the participant's account at year end.

Forfeitures – Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. Forfeited nonvested accounts to be allocated to participant accounts in future years as of December 31, 2024 were \$0.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Allocations – The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (“allocated”) and (b) stock not yet allocated to employees (“unallocated”), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment valuation and income recognition – The shares of Company common stock are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits – Benefits are recorded when paid.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The valuation process involves the selection of an independent qualified appraiser. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. Plan management, along with the Board of Trustees, review the appraisal report in detail, and approve the valuation methods utilized by the appraiser in determining fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Notes Payable

As disclosed in Note 1, the Plan holds a note payable to the Company. The proceeds of the ESOP loan were used to purchase common stock of Williams Tank Lines, Inc. Unallocated shares are collateral for the loan. Shares of common stock are released from collateral and allocated to participants as payments of principal and interest are made on the loan. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current-year principal and interest payments, divided by the total of the current-year principal and interest payments, plus all future years' principal and interest payments.

Note 6 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore believes, that the Plan is qualified and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets (deficit) available for benefits.

Note 8 – Related Party and Party-in-Interest Transactions

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party-in-interest transactions. As described in Note 1, the Company has historically paid the operating expenses for the Plan. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

Note 9 – Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Employee Benefits Administration Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust established under the Plan will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan's terms and the IRC.

Note 10 – Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets (deficit) available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets (deficit) available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets (deficit) available for benefits, but arose after the statement of net assets (deficit) available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.
