### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Levi Strauss & Co. Employee Long-Term Investment and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Levi Strauss & Co. Employee Long-Term Investment and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Levi Strauss & Co. Employee Long-Term Investment and Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Levi Strauss & Co. Employee Long-Term Investment and Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Levi Strauss & Co. Employee Long-Term Investment and Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**(1) Plan Description**

The following description of the Levi Strauss & Co. Employee Long-Term Investment and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document which contains a complete description of the Plan's provisions.

**(a) General**

The Plan was initially adopted August 1, 1989, and was amended and restated on January 1, 2015, to incorporate all prior amendments. The Plan is a defined contribution employee benefit plan available to eligible employees of Levi Strauss & Co. (the Company) and other participating companies of the affiliated group as defined by the Plan. Eligible employees may participate after six months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan, except for the investment and control of plan assets, is interpreted and administered by the Administrative Committee for the Retirement Plans of Levi Strauss & Co. (the Administrative Committee), which is appointed by the board of directors of the Company (the Board). The Administrative Committee and the Investment Committee for the Retirement Plans of Levi Strauss & Co. (the Investment Committee) are the named fiduciaries with respect to the administration of the Plan and investment of plan assets, respectively. The Plan's custodian and recordkeeper is Fidelity Management Trust Company.

**(b) Contributions and Vesting**

Eligible, active participants in the Plan may make contributions to the Plan in one percent (1%) increments of their covered compensation, as defined by the Plan, without regard to the compensation limit under Code Section 401(a)(17), up to a maximum of fifteen percent (15%). Participants may direct contributions among a series of investments offered by the Plan on a pre-tax, post-tax basis or any combination thereof.

Eligible participants who have attained age 50 before the end of the Plan year may elect to make catch-up contributions to the Plan in accordance with, and subject to the limitations of, Code Section 414(v), if the eligible participants have elected to contribute the maximum pre-tax contributions allowed under the Plan. Catch-up contributions are considered pre-tax contributions, but will not be subject to the maximum deferral percentages as described above.

Contributions are subject to limitations of the Internal Revenue Code (IRC).

The Plan allows the Company to match participant contributions (the Matching Contribution) at its discretion at 50% up to the first eleven percent (11%). Participants must complete one year of service to be eligible to receive a company Matching Contribution. Catch-up contributions are not eligible for matching contributions.

Participant and Company Matching Contributions are one hundred percent (100%) vested at all times. In addition to contributions described above, eligible employees may make roll-over contributions from other qualified plans, subject to certain limitations as defined by the Plan. Roll-over contributions

are one hundred percent (100%) vested at all times and are not eligible for Company Matching Contributions.

**(c) Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's Matching Contribution and an allocation of plan earnings. Allocations are based on participant earnings or account balances as defined by the Plan. Certain administrative expenses are allocated directly to individual participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**(d) Payment of Benefits**

Upon termination of service or retirement, the distribution options vary depending upon the participant's account balance. For account balances greater than \$5,000, payment of the account balance is automatically deferred until age 72. A participant may elect, at any time prior to age 72, to roll-over eligible amounts to an Individual Retirement Account or other qualified plan, to receive a partial or lump sum distribution, or to receive monthly installment payments.

If the participant's balance does not exceed \$1,000 upon termination, the balance will be paid in a single-sum distribution. Participant balances between \$1,000 and \$5,000 will be automatically rolled over into an Individual Retirement Account, assuming that the participant has not yet attained normal retirement age or has not instructed the Plan to directly transfer the distribution to an eligible retirement plan.

**(e) Investments**

Participants may direct Fidelity Management Trust Company (Fidelity) with respect to the investment of amounts allocated to their plan accounts through a set of participant-directed investment vehicles. Participants are allowed to select from a variety of core investment options available or a self-directed brokerage option "BrokerageLink." The BrokerageLink option allows the participant to direct Fidelity to make any investment permitted under the Plan.

**(2) Summary of Accounting Policies**

**(a) Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(c) *Investment Valuation and Income Recognition***

The Plan's investments are held in a master trust and stated at fair value. The Plan's trustee, Fidelity, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

**(d) *Payment of Benefits***

Benefits are recorded when paid.

**(e) *Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(f) *Subsequent Events***

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**(3) Fair Value Measurements**

In accordance with authoritative guidance, the Plan classifies its investments based upon an established fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation techniques are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation techniques include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation techniques are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

All of the Plan's assets are held in the Levi Strauss & Co. Master Trust (Master Trust). See Note 9 for Master Trust information.

**(4) Exempt Transactions with Parties-in-Interest**

Certain Master Trust investments are shares in funds managed by an affiliate of Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Trustee and administrative fees paid to Fidelity by the Master Trust and Plan during the year were not significant.

**(5) Financial Information Certified by the Trustee**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from the trustee of the Plan and Master Trust as of and for the years ended December 31, 2024 and 2023, that all investment information provided by the trustee is complete and accurate. Information included in the accompanying financial statements as to investments in the master trust administered by the trustee and investment income is presented in reliance solely upon these certifications.

**(6) Administrative Expenses**

Substantially all administrative expenses are paid by the Company; however, the Company reserves the right to discontinue paying such fees in which case assets of the Plan would be used to pay administrative expenses.

**(7) Plan Termination**

The Plan has been established with the intention and expectation that it will continue indefinitely. However, the Company retains the right to amend, curtail, or terminate any aspect of the Plan at any time, subject to the provisions of ERISA. In the event of plan termination, each participant's account will continue to be fully vested. The assets of the Plan will be liquidated and participant accounts will be distributed to each participant. This distribution may be in cash, annuity contracts, or in any other form, as directed by the Administrative Committee and in compliance with ERISA regulations.

**(8) Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated April 4, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress.

**(9) Interest in Levi Strauss & Co. Master Trust**

Investments in the Levi Strauss & Co. Master Trust are stated at fair value as certified by Fidelity. The fair value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income (loss) less actual distributions and allocated administrative expenses. Securities traded on the national securities exchange are valued at the last reported sales price on the last business day of the plan year. Investments traded on the over-the-counter market and listed securities for which no sale was reported on that date are valued at the average of the last reported bid and asked prices. Investments for which exchange quotations are not readily available are valued at their estimated fair value based on information deemed appropriate by the investment manager, such as valuations of the underlying private investment funds or audited financial statements of underlying partnerships or pooled funds.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the closing price of shares held by the Plan at year end based on quoted market prices on nationally recognized securities exchanges and have been classified as Level 1 of the fair value hierarchy.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices and have been classified as Level 1 of the fair value hierarchy.

*Separate accounts:* Valued using market-based valuation determined on the basis of last reported sales price or market quotations, if readily available, or fair valuation using evaluated prices provided by the approved pricing service (comprised of third-party pricing vendors and brokers) as an input in determining fair value or internally fair valued by the Committee.

*Collective trusts:* Units held in collective trusts (CT) are valued using the net asset value (NAV) practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

As of December 31, 2024 and 2023, there were no unfunded commitments or redemption restrictions related to the CTs.
