#### 1. Plan Description

The following description of the Bates Electric, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Bates Electric, Inc. ("Company") who have completed three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Eligibility* – The Plan substantially covers all employees of the Company who have completed three months of service and are age eighteen or older. Participants may enroll into the Plan on January 1 or July 1 following the date the age and service requirements are met.
- c) *Employee Contributions* – Each year, participants may contribute annual compensation up to the maximum amount allowed by law of pre-tax compensation as defined in the Plan up to a maximum of \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of \$7,500 for the current plan year. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).
- d) *Company Contributions* – The Company makes safe harbor matching contributions equal to 100% of participant salary deferrals that do not exceed 3% of compensation, plus 50% of participant salary deferrals in excess of 3% and up to 5% of compensation.

The Plan allows additional matching contributions based on up to 6% of participant compensation. No additional matching contributions were made in 2024. The Plan also allows additional Company nonelective contributions. Participants are eligible for nonelective contributions after one year of service and must be employees on the last day of the Plan year. No discretionary Company contributions were made in 2024.

- e) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- f) *Investment Options* – Participants direct the investment of their contributions and the Company’s contribution into various investment options offered by the Plan. Participants may change their investment options at any time online at the recordkeeper’s website.
- g) *Vesting* – Participants are vested immediately in their contributions plus actual earnings thereon. Company safe-harbor contributions are also vested immediately. Other Company contributions are vested 20% after two years of service and 20% each year thereafter (100% vested after 6 years of service).
- h) *Notes Receivable from Participants* – Notes receivable from participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at one percent above the prime rate, as defined. The interest rates on loans outstanding as of December 31, 2024 ranged between 4.25% and 9.5% and mature through 2029. Principal and interest is paid ratably through monthly payroll deductions.
- i) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution payment.
- j) *Forfeited accounts* – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,837 and \$22,651, respectively. No forfeitures were used during 2024 to reduce employer contributions or pay plan expenses.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

The Plan invests indirectly in a fully benefit-responsive investment contract through the Putnam Stable Value Fund (PSVF). The PSVF is a collective trust fund consisting of investments in investment contracts issued by insurance companies and other financial institutions as well as synthetic investment contracts, and is stated at net asset value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of

#### Payment of Benefits

Benefits paid to participants are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### 3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through October 13, 2025, the date the financial statements were available to be issued.

**5. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan's mutual funds are publicly traded and included in Level 1 of the fair value hierarchy.

Stable Value Collective Trust Fund – The Putnam Stable Value Fund (PSVF), a common collective trust, invests directly or indirectly in fully benefit-responsive investment contracts. The PSVF is valued at the NAV as provided by the trustee, which is used as a practical expedient to estimate fair value.

#### 6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

#### 8. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Empower Retirement LLC ("Empower"). Empower obtained its latest opinion letter dated November 14, 2022 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
