NOTES TO FINANCIAL STATEMENTS**

Note 1 - Description of Plan

The following description of the Astro Exterminating Services, Inc. (Company) 401(K) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a multi-employer defined contribution plan covering all full-time employees of the Companies who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions: Participants may elect the option to self-direct their contributions within an individual account. During the year ended December 31, 2024, the Companies contributed one hundred percent (100%) of the participant's deferred contribution up to ten percent (10%) of employee compensation. Deferred contributions in excess of ten percent (10%) were not matched in the Plan. The Companies may make discretionary contributions to the Plan in an amount determined by the Board. Forfeitures of terminated participants' non-vested accounts are used to reduce employer contributions.

Participant Accounts: Each participant's account is credited with an allocation of the participant's contribution, the Companies' contribution, and Plan earnings. Allocations are based on the participant's deferred contribution and participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Companies' contributions is based on years of continuous service. A participant is 100% vested after seven years of credited service.

Payment of Benefits: Upon termination of employment, a participant may elect to receive a lump-sum distribution or installment payments over a specified period of time.

Investment Options: Participants may direct contributions, including employer contributions, into any investment option provided by the Plan.

Coronavirus Aid Relief and Economic Security Act: In response to the COVID-19 pandemic, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was enacted on March 27, 2020. The CARES Act, among other benefits, provides certain relief for retirement plan sponsors and their participants with respect to employer contributions, distributions, and participant loans. The provisions of the CARES Act may be effective and operationalized immediately, prior to amending the Plan agreement. The Plan Administrator has adopted certain relief provisions included in the CARES Act as applicable to the Plan. Specifically, the adopted provisions provide for qualified coronavirus related distributions from the Plan up to \$100,000.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments in registered investment companies are valued at fair value based on quoted market prices which represents the net asset value of shares held by the Plan at year end. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. See Note 8 for discussion of fair value measurements.

Payment of Benefits: Benefits are recorded when paid.

Net Appreciation (Depreciation) in Fair Value of Investments: Realized gains (losses) and unrealized appreciation (depreciation) are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

Contributions: Employee elective contributions are recorded in the period in which the employer makes the deductions from the participants' payroll. Employer matching contributions are recorded within the same Plan year.

Administrative Expenses: Significant costs of plan administration are absorbed by the Companies.

Subsequent Events: The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date on which the financial statements were available to be issued.

Note 3 - Investments

Some of the mutual funds held as investments by the Plan may invest in derivatives to achieve certain investment goals. Derivatives may involve risks different from, and possibly greater than, the risk associated with investing directly in securities and other traditional investments.

Note 4 - Forfeitures

Forfeitures of employer matching contributions are used to reduce matching contributions. During the year ended December 31, 2024, forfeited non-vested matching contributions totaled \$21,456. The unused forfeiture account is included in the net assets available for benefits and contained a balance of \$102,186 and \$75,229 at December 31, 2024 and 2023, respectively. In the year ended December 31, 2024, employer contributions were reduced from forfeited non-vested accounts by \$0.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be one hundred percent (100%) vested in their accounts.

Note 6 - Tax Status

The Internal Revenue Service has informed the Sponsor of the Prototype Plan that is used for the Astro Exterminating Services, Inc. 401(K) Retirement Plan that the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Sponsor was notified by letter dated August 22, 2001. The Internal Revenue Service's opinion on the acceptability of the form of the Plan is not a ruling or determination as to whether an employer's Plan qualified under Code Section 401(a). However, an employer that adopts this Plan may rely on the letter with respect to the qualifications of its Plan under Code Section 401(a). The terms of the Plan must be followed in operation. The Plan has been amended since receiving the determination letter. However, the trustees of the Astro Exterminating Services, Inc. 401(K) Retirement Plan believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, Department of Labor, or Georgia Department of Revenue. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 - Information Prepared and Certified by Trustee

Note 8 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 9 – Rollovers

The Plan provides for the receipt of direct and indirect rollover contributions from certain other qualified plans. Rollover contributions of \$0 were received during the year ended December 31, 2024.

Note 10 – Related Party Transactions and Party In Interest Transactions

Vanguard Fiduciary Trust Company acts as trustee of investments for the Plan. Investments of the Plan are in mutual funds managed by an affiliate of the trustee and, therefore, these transactions qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Astro Exterminating Services, Inc. (the plan sponsor) provides the Plan with certain accounting and administrative services for which no fees are charged.

Note 11 – Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS**

Note 1 - Description of Plan

The following description of the Astro Exterminating Services, Inc. (Company) 401(K) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a multi-employer defined contribution plan covering all full-time employees of the Companies who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions: Participants may elect the option to self-direct their contributions within an individual account. During the year ended December 31, 2024, the Companies contributed one hundred percent (100%) of the participant's deferred contribution up to ten percent (10%) of employee compensation. Deferred contributions in excess of ten percent (10%) were not matched in the Plan. The Companies may make discretionary contributions to the Plan in an amount determined by the Board. Forfeitures of terminated participants' non-vested accounts are used to reduce employer contributions.

Participant Accounts: Each participant's account is credited with an allocation of the participant's contribution, the Companies' contribution, and Plan earnings. Allocations are based on the participant's deferred contribution and participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Companies' contributions is based on years of continuous service. A participant is 100% vested after seven years of credited service.

Payment of Benefits: Upon termination of employment, a participant may elect to receive a lump-sum distribution or installment payments over a specified period of time.

Investment Options: Participants may direct contributions, including employer contributions, into any investment option provided by the Plan.

Coronavirus Aid Relief and Economic Security Act: In response to the COVID-19 pandemic, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was enacted on March 27, 2020. The CARES Act, among other benefits, provides certain relief for retirement plan sponsors and their participants with respect to employer contributions, distributions, and participant loans. The provisions of the CARES Act may be effective and operationalized immediately, prior to amending the Plan agreement. The Plan Administrator has adopted certain relief provisions included in the CARES Act as applicable to the Plan. Specifically, the adopted provisions provide for qualified coronavirus related distributions from the Plan up to \$100,000.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments in registered investment companies are valued at fair value based on quoted market prices which represents the net asset value of shares held by the Plan at year end. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. See Note 8 for discussion of fair value measurements.

Payment of Benefits: Benefits are recorded when paid.

Net Appreciation (Depreciation) in Fair Value of Investments: Realized gains (losses) and unrealized appreciation (depreciation) are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

Contributions: Employee elective contributions are recorded in the period in which the employer makes the deductions from the participants' payroll. Employer matching contributions are recorded within the same Plan year.

Administrative Expenses: Significant costs of plan administration are absorbed by the Companies.

Subsequent Events: The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date on which the financial statements were available to be issued.

Note 3 - Investments

Some of the mutual funds held as investments by the Plan may invest in derivatives to achieve certain investment goals. Derivatives may involve risks different from, and possibly greater than, the risk associated with investing directly in securities and other traditional investments.

Note 4 - Forfeitures

Forfeitures of employer matching contributions are used to reduce matching contributions. During the year ended December 31, 2024, forfeited non-vested matching contributions totaled \$21,456. The unused forfeiture account is included in the net assets available for benefits and contained a balance of \$102,186 and \$75,229 at December 31, 2024 and 2023, respectively. In the year ended December 31, 2024, employer contributions were reduced from forfeited non-vested accounts by \$0.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be one hundred percent (100%) vested in their accounts.

Note 6 - Tax Status

The Internal Revenue Service has informed the Sponsor of the Prototype Plan that is used for the Astro Exterminating Services, Inc. 401(K) Retirement Plan that the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Sponsor was notified by letter dated August 22, 2001. The Internal Revenue Service's opinion on the acceptability of the form of the Plan is not a ruling or determination as to whether an employer's Plan qualified under Code Section 401(a). However, an employer that adopts this Plan may rely on the letter with respect to the qualifications of its Plan under Code Section 401(a). The terms of the Plan must be followed in operation. The Plan has been amended since receiving the determination letter. However, the trustees of the Astro Exterminating Services, Inc. 401(K) Retirement Plan believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, Department of Labor, or Georgia Department of Revenue. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 - Information Prepared and Certified by Trustee

The following information included in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974:

Note 8 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 9 – Rollovers

The Plan provides for the receipt of direct and indirect rollover contributions from certain other qualified plans. Rollover contributions of \$0 were received during the year ended December 31, 2024.

Note 10 – Related Party Transactions and Party In Interest Transactions

Vanguard Fiduciary Trust Company acts as trustee of investments for the Plan. Investments of the Plan are in mutual funds managed by an affiliate of the trustee and, therefore, these transactions qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Astro Exterminating Services, Inc. (the plan sponsor) provides the Plan with certain accounting and administrative services for which no fees are charged.

Note 11 – Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS**

Note 1 - Description of Plan

The following description of the Astro Exterminating Services, Inc. (Company) 401(K) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a multi-employer defined contribution plan covering all full-time employees of the Companies who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions: Participants may elect the option to self-direct their contributions within an individual account. During the year ended December 31, 2024, the Companies contributed one hundred percent (100%) of the participant's deferred contribution up to ten percent (10%) of employee compensation. Deferred contributions in excess of ten percent (10%) were not matched in the Plan. The Companies may make discretionary contributions to the Plan in an amount determined by the Board. Forfeitures of terminated participants' non-vested accounts are used to reduce employer contributions.

Participant Accounts: Each participant's account is credited with an allocation of the participant's contribution, the Companies' contribution, and Plan earnings. Allocations are based on the participant's deferred contribution and participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Companies' contributions is based on years of continuous service. A participant is 100% vested after seven years of credited service.

Payment of Benefits: Upon termination of employment, a participant may elect to receive a lump-sum distribution or installment payments over a specified period of time.

Investment Options: Participants may direct contributions, including employer contributions, into any investment option provided by the Plan.

Coronavirus Aid Relief and Economic Security Act: In response to the COVID-19 pandemic, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was enacted on March 27, 2020. The CARES Act, among other benefits, provides certain relief for retirement plan sponsors and their participants with respect to employer contributions, distributions, and participant loans. The provisions of the CARES Act may be effective and operationalized immediately, prior to amending the Plan agreement. The Plan Administrator has adopted certain relief provisions included in the CARES Act as applicable to the Plan. Specifically, the adopted provisions provide for qualified coronavirus related distributions from the Plan up to \$100,000.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments in registered investment companies are valued at fair value based on quoted market prices which represents the net asset value of shares held by the Plan at year end. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. See Note 8 for discussion of fair value measurements.

Payment of Benefits: Benefits are recorded when paid.

Net Appreciation (Depreciation) in Fair Value of Investments: Realized gains (losses) and unrealized appreciation (depreciation) are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

Contributions: Employee elective contributions are recorded in the period in which the employer makes the deductions from the participants' payroll. Employer matching contributions are recorded within the same Plan year.

Administrative Expenses: Significant costs of plan administration are absorbed by the Companies.

Subsequent Events: The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date on which the financial statements were available to be issued.

Note 3 - Investments

Some of the mutual funds held as investments by the Plan may invest in derivatives to achieve certain investment goals. Derivatives may involve risks different from, and possibly greater than, the risk associated with investing directly in securities and other traditional investments.

Note 4 - Forfeitures

Forfeitures of employer matching contributions are used to reduce matching contributions. During the year ended December 31, 2024, forfeited non-vested matching contributions totaled \$21,456. The unused forfeiture account is included in the net assets available for benefits and contained a balance of \$102,186 and \$75,229 at December 31, 2024 and 2023, respectively. In the year ended December 31, 2024, employer contributions were reduced from forfeited non-vested accounts by \$0.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be one hundred percent (100%) vested in their accounts.

Note 6 - Tax Status

The Internal Revenue Service has informed the Sponsor of the Prototype Plan that is used for the Astro Exterminating Services, Inc. 401(K) Retirement Plan that the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Sponsor was notified by letter dated August 22, 2001. The Internal Revenue Service’s opinion on the acceptability of the form of the Plan is not a ruling or determination as to whether an employer’s Plan qualified under Code Section 401(a). However, an employer that adopts this Plan may rely on the letter with respect to the qualifications of its Plan under Code Section 401(a). The terms of the Plan must be followed in operation. The Plan has been amended since receiving the determination letter. However, the trustees of the Astro Exterminating Services, Inc. 401(K) Retirement Plan believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, Department of Labor, or Georgia Department of Revenue. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 - Information Prepared and Certified by Trustee

The following information included in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974:

Note 8 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 9 – Rollovers

The Plan provides for the receipt of direct and indirect rollover contributions from certain other qualified plans. Rollover contributions of \$0 were received during the year ended December 31, 2024.

Note 10 – Related Party Transactions and Party In Interest Transactions

Vanguard Fiduciary Trust Company acts as trustee of investments for the Plan. Investments of the Plan are in mutual funds managed by an affiliate of the trustee and, therefore, these transactions qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Astro Exterminating Services, Inc. (the plan sponsor) provides the Plan with certain accounting and administrative services for which no fees are charged.

Note 11 – Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
