## INDEPENDENT AUDITORS' REPORT

To the 401(k) Investment Committee and Participants of  
Brayton Purcell, LLP 401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Brayton Purcell, LLP 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). NOTES TO FINANCIAL STATEMENTS

December 31, 2024

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Brayton Purcell, LLP 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was established on January 1, 1990 by Brayton Purcell, LLP (the “Firm” or the “Company”) to provide retirement benefits for its employees. In addition, the employees of Pacific eDocument Solutions, an adopting employer, are eligible to participate in the Plan.

The Plan is a voluntary defined contribution plan covering all employees who have completed three months of service and have reached 21 years of age. Employees become participants of the Plan on January 1, April 1, July 1 and October 1 after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”).

The Investment Committee is responsible for oversight of the Plan which includes, among other matters, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. The Plan provides for a plan administrator who is responsible for keeping accurate and complete records of the Plan’s operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and to government regulations, and providing participants with any reports and documents required by law.

Participant Contributions – Participant contributions are made in the form of pretax deferred salary deductions. A participant may elect to contribute up to a maximum of \$23,000 for the year ended December 31, 2024 in accordance with the IRC. Additionally, participants age 50 and over at the end of the Plan year may make additional catch-up contributions up to \$7,500 for the year ended December 31, 2024. A participant may increase or decrease the amount of contributions quarterly, as defined by the Plan agreement. Effective October 1, 2024, the Plan was amended to include Roth elective deferrals and in-plan Roth rollover contributions, with no transfer of loans permitted.

Employer Contributions – Under the Safe-Harbor contribution rules, the Firm makes mandatory matching contributions of each participant’s contributions up to an amount equal to 100% up to a maximum of 4% of eligible compensation after one year of service, as defined in the Plan. The Company made \$506,700 of Safe-Harbor contributions to the Plan for the year ended December 31, 2024.

Employer Contributions (Continued) – The Firm may, in its sole discretion, elect to make profit-sharing contributions and such contributions are allocated to all participants who either are credited with at least 500 hours of service or are employed on the last day of the Plan year. For the year ended December 31, 2024, the Company made no such discretionary profit-sharing contributions.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, and Firm matching contributions, as well as allocations of the Firm’s profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that may be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions, and employer Safe-Harbor contributions, plus actual earnings thereon. Participants in the Plan vest in the Firm’s discretionary profit-sharing contributions according to the following schedule:

Participant Investment Account Options – The Plan currently offers various pooled separate accounts, a common collective trust, and a fully benefit-responsive investment contract as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Notes Receivable from Participants – Participants may borrow from their vested account balances provided they meet the Plan’s eligibility requirements. The minimum loan amount is \$1,000 and the maximum loan amount is equal to the lesser of 50% of the participant’s vested account balance or \$50,000. The duration of the loan is not to exceed five years, except for loans used to finance the purchase of a primary residence.

Notes Receivable from Participants (Continued) – The notes bear interest at rates comparable to those charged by other lenders for loans which would be made under similar circumstances and remain fixed throughout the life of the note. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans are due upon the earlier of maturity date or date of termination of employment.

Payment of Benefits – Upon termination of service due to death, disability or retirement, a participant may receive either a lump-sum distribution or a direct rollover distribution into a qualified plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may also elect to receive a pre-retirement distribution if the participant is 100% vested in the amount being distributed and has reached 59½ years of age. A participant may also be eligible for a withdrawal due to financial hardship in certain circumstances. The payment of benefits to retired participants is generally required to begin no later than April 1st following the end of the year in which the participant reaches 73 years of age. In accordance with SECURE 2.0 Act, effective January 1, 2024, if a terminated participant's account balance is less than \$7,000, and no instructions have been received from such participant, a distribution of the participant's vested account balance will be made automatically in a single lump-sum distribution. The previous upper limit was \$5,000.

Forfeited Accounts – The non-vested portion of a participant's balance is forfeited upon termination of employment. Forfeitures can be used to pay administrative expenses, applied to reduce employer contributions, or reallocated among eligible participants. As of December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$7,727 and \$7,312, respectively. During the year ended December 31, 2024, no forfeitures were used to fund administrative expenses or reduce employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan prepares its financial statements under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition – Investments, with the exception of the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fully benefit-responsive investment contract is reported at contract value. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisers, custodians, and trustee. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when they are incurred.

Contributions – Contributions from Plan participants and Safe-Harbor matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain administrative expenses of the Plan are paid by the Firm and are excluded from these financial statements, except for those fees funded from forfeitures and participant transaction fees for loans and distributions. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Certain expenses paid from Plan assets, such as fees for investment advisory services are proportionately allocated to the accounts of all participants in the Plan.

Concentrations – As of December 31, 2024 and 2023, three investments accounted for approximately 34% of total investments. Additionally, the target date family of funds utilized by the Plan, in the aggregate, accounted for approximately 40% and 34% of total investments as of December 31, 2024 and 2023, respectively.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this topic are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value ("NAV") of units of the separate account. The NAV, as provided by VOYA Retirement Insurance and Annuity Company ("VOYA Insurance Company"), is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily.

Collective Trust Fund: Valued at the NAV of the units of a collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trusts, the issuer requires thirty business days notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As described above, the fair value of pooled separate accounts and collective trust funds are measured using the NAV practical expedient. In accordance with the fair value measurement guidance, investments that are measured at fair value using the NAV practical expedient are not required to be classified in the fair value hierarchy.

NOTE 4 – INFORMATION CERTIFIED BY VOYA INSTITUTIONAL TRUST COMPANY

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The investment information and notes receivable from participants as of December 31, 2024 and 2023 and for the year ended December 31, 2024, including the information presented in the statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity and interest income reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the Supplemental Schedule H, Line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2024, were obtained from data that has been certified by VOYA Institutional Trust Company (“VOYA”) as of December 31, 2024 and 2023 and for the year ended December 31, 2024, to be complete and accurate.

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

As part of the Voya Fixed Account, the Plan has entered into an investment contract that meets the criteria to be considered fully benefit-responsive and; therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The insurance company maintains the contributions in a general account. Contract values, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan is credited with an annual interest rate of no less than 1.00% for as long as the contract remains in force. Each calendar year, the insurance company will set a floor interest rate which will be declared in writing, to the contract holder prior to its effective date.

The insurance company may terminate the contract after the completion of five contract years by providing the Plan a 90-day written notice to pay out the full value without fees, charges, or Market Value Adjustment (“MVA”).

Certain events may limit the ability of the Plan to transact at contract value with the insurance company. A surrender charge is assessed against contract withdrawals taken for reasons of participant retirement, severance from employment, death, disability, hardship, loan or in-service withdrawals after age 59½. There are restrictions on transfers to and from the Voya Fixed Account and a positive or negative MVA may apply if the contract is terminated by either the insurance company or the Plan sponsor. The plan administrator does not believe that the occurrence of any such events that would limit the Plan’s ability to transact at contract value with participants is probable.

NOTE 6 – TAX STATUS

The Plan is a defined contribution plan designed to qualify as a tax-exempt plan under the IRC. The Plan adopted VOYA Retirement Insurance and Annuity Company Defined Contribution Pre-Approved Plan which received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in accordance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is intended to be designed and is currently being operated in substantial compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

VOYA Insurance Company, an affiliate of VOYA, maintains the Plan’s assets in pooled separate accounts, a common collective trust, and under a fully benefit-responsive investment contract, and, therefore, these transactions qualify as party-in-interest transactions. VOYA Insurance Company provides certain administrative services to the Plan pursuant to a service agreement between the Firm and VOYA Insurance Company. VOYA Insurance Company receives revenue from certain investment service providers for services they provide to the funds.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (Continued)

This revenue is used to offset certain amounts owed to VOYA Insurance Company for its administrative services to the Plan. Because these fees are paid through this revenue sharing arrangement, rather than a direct payment, they are netted against the net appreciation or depreciation in fair value of investments.

Portico Wealth Advisors LLC (“Portico”) provides certain investment advisory services to the Plan pursuant to a service agreement between the Firm and Portico. Because these fees are paid through the Plan, these transactions qualify as related party transactions.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 10 – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, there were unintentional delays by the Firm in remitting employee contributions to Voya amounting to \$2,216, within the period prescribed by the Department of Labor’s regulations. In order to make the participants whole, the Firm has computed the lost earnings for the 2024 delinquent contributions and submitted them to the Plan for the affected participants on October 9, 2025.
