Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan

The following description of Children's Specialists of San Diego, AMG, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established, effective on June 27, 1989, as most recently amended and restated effective on January 1, 2021, to enable eligible employees to make contributions to the Plan, thereby providing employees with an opportunity to accumulate funds for retirement.

The Plan is a defined contribution plan covering all employees of Children's Specialists of San Diego, A Medical Group, Inc. ("Company" or "Plan Administrator"), excluding nonresident aliens and leased employees, who have completed one year of service and at least 1,000 hours of service within that year. Participants may enter the Plan on January 1 or July 1 coincident with or following the date they meet the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation. The Plan's trustee, State Street Bank and Trust Company ("Trustee"), has the authority and responsibility for the management and investment of Plan assets. The Company's Benefits Committee is the Plan's named fiduciary for purposes of Section 402(a) of ERISA.

Contributions

The following types of contributions are allowable under the Plan:

Salary deferral contributions: Participants may contribute up to 80% of their annual pre-tax compensation, as defined in the Plan document, subject to limitations imposed by Internal Revenue Service ("IRS") regulations. Additionally, participants may contribute a percentage of their after-tax compensation and designate it as a Roth elective deferral contribution. The Plan has an auto-enrollment feature that provides for participants in the Plan prior to January 1, 2016 to be automatically enrolled in the Plan at a 3% elective deferral contribution percentage. Participants joining or attaining eligibility in the Plan on or after January 1, 2016 will be automatically enrolled at a 5% elective deferral contribution percentage. Automatically enrolled deferral contribution percentages may be overridden by the participant via an affirmative election.

Safe Harbor Nonelective Employer Contribution: The Company makes a safe harbor nonelective contribution equal to 3% of each non-highly compensated employee's compensation during the Plan year.

Discretionary Nonelective Employer Contribution: The Company may make a discretionary nonelective contribution based on a new comparability formula that provides for a participant group allocation method whereas each participant is in his/her own allocation group.

Contributions, cont'd

Rollover Contributions: Amounts distributed to eligible participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants.

Allocations

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) net Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are made in a manner which recognizes each participant's account balance, investment selection, and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested at all times.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note repayment periods may not exceed five years except for those used to acquire a principal residence. Notes receivable from participants are secured by the balance in the participant's account and bear interest at the Prime Rate plus 1%. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Benefit payments

Benefits to participants or beneficiaries generally are payable as a lump sum, installments, or partial payments equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. Additionally, participants may request in-service withdrawals upon attainment of age 59½ or upon incurring a financial hardship, as defined in the Plan document, if certain criteria are met. Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

1. Description of the Plan, Cont'd

Cash account

The Plan maintains an unallocated cash account that is used to pay administrative expenses of the Plan or is used to credit participants' accounts. The unallocated cash account had a balance of \$65 and \$0 as of December 31, 2024 and 2023, respectively.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, the Plan document provides that participants would become fully vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Interest-bearing cash
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Fair Value Measurement, Cont'd

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The inputs or methodologies used in the valuation of securities are not necessarily an indication of risk associated with investing in those securities.

Investment valuation and earnings

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consisted of the realized gains or losses on sales of investments and the unrealized appreciation or depreciation of those investments.

5. Tax Status

The Plan Administrator has adopted a Transamerica Retirement Solutions, LLC Volume Submitter 401(k) Profit Sharing Plan (“volume submitter plan”). The volume submitter plan received a favorable opinion letter from the IRS on June 30, 2020, which stated that the volume submitter plan is qualified under the applicable sections of the Internal Revenue Code (“IRC”). Although the volume submitter plan has been amended since receiving the IRS opinion letter, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan has an unallocated cash account with State Street Bank and Trust Company, the Plan’s Trustee. Certain officers of the Company are current participants in the Plan. The Plan has notes receivable from certain of its participants. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

7. Risks, Uncertainties and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk.

7. Risks, Uncertainties and Concentrations, Cont'd

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 17% and 16% of the Plan's investments were invested in the Fidelity Total Market Index Fund, respectively.

8. Reconciliation of Financial Statements to Schedule H of Form 5500

There were no differences between the accompanying financial statements and the financial information reported on Schedule H of the Form 5500.

9. Subsequent Events

The Company has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
