Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Lumber One Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audits opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audits does not affect management’s responsibility for the financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

1. Summary of Significant Plan Provisions

The following description of the Lumber One Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Lumber One Home Center of Stuttgart, Inc. and related adopting employers, Lumber One Home Center, Inc., Industrial Crate & Supply Co., Inc., and M3 Millwork & Molding, LLC (collectively, the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

John Hancock Life Insurance Company (“John Hancock”) holds assets related to employee deferrals and Employer safe harbor matching contributions. Raymond James & Associates, Inc. (“Raymond James”) holds assets related to Employer profit sharing contributions.

- b. **Eligibility** – Each employee, except leased employees, nonresident aliens, and employees covered by a collective bargaining agreement, shall be eligible to participate in the Plan provided that the employee has completed 6 months of service during which 1,000 hours are accrued, and the employee has obtained a minimum age of 21 years. Entry dates are the earlier of January 1st or July 1st.
- c. **Contributions** – Participants may contribute through pre-tax payroll deductions and eligible rollover contributions. Effective September 20, 2023, participants may make ROTH contributions. The Employer will make a safe harbor matching contribution of 100% of the participant’s elective contributions up to 3% of the participant’s eligible compensation, plus 50% of the participant’s elective contributions that exceed 3% but do not exceed 5% of the participant’s eligible compensation. The Employer may also make a discretionary profit sharing contribution to the Plan. No such discretionary contributions were made during the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – The interest of a participant in Employer discretionary contributions shall be fully vested and nonforfeitable upon the employee attaining normal retirement age 65 with at least six years of vesting service, death, or disability. If a participant terminates employment other than because of their retirement, they are entitled to the total value of their own contributions, the safe harbor matching contributions, and earnings thereon, plus a vested percentage of other discretionary contributions made by the Employer and earnings thereon.

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct employee elective and Employer safe harbor contributions into any of the investments offered by the Plan. Participants may change these investment selections at any time.
- g. **Forfeitures** – The portion of a participant’s account to which they are not entitled upon termination of participation is deemed a forfeiture. Forfeitures shall be used to pay administrative expenses or offset Employer contributions. No forfeitures were utilized during the year ended December 31, 2024. There were no forfeitures available for future use at December 31, 2024 or 2023.
- h. **Payment of benefits** – Upon separation of service due to death, disability, retirement, or termination, the vested portion of the participant’s account will be paid in a lump sum as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable. Participants, upon termination of employment, may also elect to defer payment on their account balance if it exceeds \$1,000. If a terminated participant’s account balance is equal to or less than \$1,000, the account will be automatically distributed. Any distribution greater than \$1,000 that is made to a participant without the participant’s consent will be rolled over to an individual retirement account designated by the Plan administrator. In-service withdrawals are available from the vested accounts of participants who have attained age 65.
- i. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer accounts.

Notes to Financial Statements**December 31, 2024 and 2023****2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as disclosed in Note 3. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Administrative expenses** – Certain administrative expenses of the Plan were voluntarily paid by the Employer. These expenses are excluded from the financial statements. Fees related to distributions are charged directly to the participant’s account. Other administrative expenses paid by the Plan are allocated to participants’ accounts.

3. Fully Benefit-Responsive Investment Contract

The Plan has entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with John Hancock. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. John Hancock is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

3. **Fully Benefit-Responsive Investment Contract (cont.)**

There are no reserves against the contract value for credit risk of John Hancock or otherwise. Interest rates are established every January 1 and July 1 and will generally be valid for six months. The rate will be dependent on the market condition at the time of the rate setting dates. The interest rate will never be less than 1%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include any Employer originated transfer or distribution out of the contract. The Plan's management does not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

4. **Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by John Hancock, the custodian of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedules:

- a. Total investments as shown on the accompanying statement of net assets available for benefits of \$1,710,957 (excluding \$4,010,770 in investments held by Raymond James) and \$1,231,513 as of December 31, 2024 and 2023, respectively.
- b. Net change in value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$172,920 for the year ended December 31, 2024.
- c. All investment transactions that occurred during the year ended December 31, 2024 related to the GIC and pooled separate accounts.
- d. All information included in the schedule of assets (held at end of year).

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes to Financial Statements**December 31, 2024 and 2023****5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Money market fund: This investment is valued at the fair value of the underlying investments, which are valued based on quoted market prices on the last business day of the Plan year.

Pooled separate accounts: These investments are stated at fair value based on the net asset value ("NAV") of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments, adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Parties-in-Interest Transactions

John Hancock is the custodian and third-party administrator of the Plan. The Plan has a GIC with John Hancock and is invested in John Hancock pooled separate accounts. The Plan pays John Hancock for its services. Inasmuch as John Hancock serves as the custodian and third-party administrator of the Plan’s assets, John Hancock is by definition a party-in-interest and, as a result, all investments and investment transactions with John Hancock were with a party-in-interest. Raymond James holds assets of the Plan. The Plan pays Raymond James for its services. Inasmuch as Raymond James holds Plan assets, Raymond James is by definition a party-in-interest and, as a result, all investments and investment transactions with Raymond James were with a party-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

8. Delinquent Participant Contributions

The Plan sponsor determined that during the 2024 Plan year, certain participant contributions were not remitted within the required time frame specified by the DOL’s regulations, which have been reported on the accompanying Schedule H, line 4a – Schedule of Delinquent Participant Contributions in the amount of \$15,015. The Plan sponsor will make corrections outside of the Voluntary Fiduciary Correction Program.

9. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through October 6, 2025, which is the financial statement issuance date.
