## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees  
CNY Family Care, LLP 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of CNY Family Care, LLP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## NOTES TO FINANCIAL STATEMENTS

### CNY FAMILY CARE, LLP 401(k) PLAN

December 31, 2024 and 2023

#### NOTE A--DESCRIPTION OF THE PLAN

The following description of the CNY Family Care, LLP 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a safe harbor defined contribution plan covering substantially all employees of CNY Family Care, LLP (the "Company" or "Plan Sponsor"). Employees of the Company are eligible to participate in the Plan if they are age 21 or older and have at least 500 hours of service in a 6 month period. An employee is eligible to participate in the elective deferral feature of the Plan on the first day of the first, fourth, seventh or tenth month of the Plan year following the date the employee meets the eligibility requirements. To become eligible to participate in Company matching contributions, an employee must have made elective deferral contributions to the Plan. Additionally, to become eligible to participate in the Company's discretionary profit sharing contributions, an employee must be age 21 or older, be employed on the last day of the Plan year and have completed 500 hours of service during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions: Participants may contribute tax-deferred and after-tax Roth dollars through payroll deductions, up to the maximum in any calendar year as set forth in the Internal Revenue Code ("IRC"). Current tax law limits each participant's total pretax and Roth deferrals to \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Additionally, if a participant has or is projected to attain age 50 before the end of the Plan year, that participant may make "catch-up" contributions of \$7,500 as determined by the Internal Revenue Service ("IRS") for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct their contributions into various investment options offered by the Plan. Contributions are subject to certain individual account and aggregate Plan limitations, as determined by the IRS.

The Plan requires the Plan Sponsor to make a safe harbor matching contribution equal to 100% of the first 3% of a participant's salary deferral plus 50% of the next 2% of salary deferral and these totaled \$434,049 and \$442,726 for the 2024 and 2023 Plan years, respectively.

The Company may also elect to contribute discretionary profit sharing contributions for all eligible participants. Discretionary profit sharing contributions made to the Plan in 2024 and 2023 were \$625,718 and \$595,580, respectively.

NOTE A--DESCRIPTION OF THE PLAN--Continued

Participant Accounts: Each participant's account is credited with the elective deferral contributions, safe harbor matching contributions, Company discretionary profit sharing contributions, as well as an allocation of Plan earnings and losses, loan activity and administrative expenses. Earnings and losses are allocated based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their elective deferral contributions, the employer safe harbor matching contributions and allocations of Plan earnings and losses. Vesting in the Company's discretionary profit sharing contributions and the earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service (20% vesting annually, starting in the second year of continuous service).

Receivables--Notes From Participants: Participants may borrow from their vested accounts a minimum of \$1,000 with the maximum amount being the lesser of 50% of the vested account balance or \$50,000 reduced by the highest outstanding loan balance at any time in the preceding twelve months. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.00%. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years. Participants can only have one outstanding loan with the Plan at any one time.

Payment of Benefits: Upon termination of a participant's employment for any reason, including death, disability or retirement, a participant or beneficiary may elect to receive a lump-sum cash distribution, a direct rollover distribution, or a combination of both equal to the value of the participant's vested interest in his or her account. If a participant's vested account balance is between \$1,000 and \$5,000, and the participant fails to make a distribution election, a lump-sum amount will be rolled over to an individual retirement account. If a participant's vested account balance is \$1,000 or less, and the participant fails to make a distribution election, a lump-sum amount will be paid to the participant without their consent.

Forfeitures: Participants that have terminated employment and who were not fully vested in the employer contributions forfeit the nonvested portion of the employer contribution. Forfeitures are available to reduce subsequent Company discretionary profit sharing contributions or to offset Plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts total \$2,504 and \$15,627, respectively. Forfeitures used to reduce the Company's discretionary profit sharing contributions amounted to \$6,424 and \$21,065 in 2024 and 2023, respectively.

NOTE B--SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note E for discussion of fair value measurements. The Plan's investments in the insurance company general account are reported at contract value (see Note D).

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. All investments are participant directed.

Employer Contributions Receivable: Employer contributions are recorded as a receivable at year end and are remitted to the Plan during the subsequent Plan year. Plan management believes no allowance for credit losses is necessary at December 31, 2024 or 2023.

Receivables--Notes From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded to the extent the loan balance is reduced.

Payment of Benefits: Benefits are recorded when paid.

Events Occurring After Reporting Date: Plan management has evaluated events and transactions that occurred between December 31, 2024 and October 10, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. There were no such events or transactions identified by Plan management.

NOTE C--INFORMATION CERTIFIED AND PROVIDED BY CUSTODIAN (UNAUDITED)

The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the assets below is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year), related to the following assets:

#### NOTE D--INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan's investment contract with Voya is fully benefit-responsive. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, has occurred or is probable.

#### NOTE E--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification Topic 820, "Fair Value Measurements and Disclosures", are described as follows:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: Investments in the pooled separate accounts are investments in registered investment companies and are reported at fair value based on the quoted market price of the fund which represents the net asset value of the shares (participation units) held at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE F--RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan has not considered Company contributions to the Plan or benefits paid by the Plan to participants as party in interest transactions.

The Plan invests in pooled separate accounts managed by Voya who is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules. Fees related to recordkeeping and certain other administrative services are charged directly to the participant's account and are included in administrative expenses. Fees paid by the Plan to Voya for these services amounted to \$5,529 and \$5,977 for the years ended December 31, 2024 and 2023, respectively. These fees are deducted from individual participant accounts.

Administrative expenses for auditing services are provided by parties in interest and are paid by the Plan or directly by the Company. Fees paid by the Plan for auditing services amounted to \$4,700 and \$10,110 for the years ended December 31, 2024 and 2023, respectively, and are included in administrative expenses.

Voya receives revenue from the investment service providers for services Voya provides to the investment funds. This revenue is used to offset certain amounts owed to Voya for its administrative services to the Plan.

NOTE G--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company discretionary profit sharing contributions, in accordance with IRS guidelines.

NOTE H--INCOME TAX STATUS

The Plan uses a non-standardized form of a prototype plan sponsored by DATAIR Employee Benefit Systems, Inc. ("DATAIR"). The prototype plan provider has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE I--RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's Statements of Net Assets Available for Benefits.
