**NOTE 1 – DESCRIPTION OF THE PLAN**

---

The following description of Adirondack Bank 401(k) Plan provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

**General**

Adirondack Bank 401(k) Plan (“the Plan”) is a defined contribution 401(k) profit sharing plan. The Plan covers eligible employees of Adirondack Bank and Adirondack Insurance Service, Inc. (collectively referred to as “the Company” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The 401(k) Trustee Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Trustees.

**Contributions**

Participants may make voluntary, pre-tax contributions in the form of salary reductions subject to certain limitations under the terms of the Internal Revenue Code (IRC) Sections 402(g) and 415. Upon meeting eligibility criteria, participants receive a profit sharing contribution, which is based on their length of employment. Upon meeting eligibility criteria, participants also receive safe harbor contributions equivalent to 3% of their compensation, as defined by the Plan Document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investments of their contributions into various options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, employer profit sharing contributions, employer safe harbor contributions, rollover contributions, as applicable, and actual earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 – DESCRIPTION OF THE PLAN – Continued**

---

**Vesting**

Participants are immediately vested in their voluntary contributions, employer safe harbor contributions, plus actual earnings thereon. Vesting in employer profit sharing contributions plus earnings thereon is based on years of service, as follows:

2	20%

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Terms of the note may not exceed 5 years, except for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at the prevailing rates at the time of issuance, ranging from 5.25% to 10.50% at December 31, 2024. Interest rates are fixed for the duration of the loan. Principal and interest are paid ratably through weekly payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, participants (or their beneficiary) may elect to receive a distribution of their vested account balance in the form of a single lump-sum payment or rollover contribution to another qualified plan. Participants who have either attained age 65 or have been a participant in the Plan for at least 5 years are also eligible for in-service distributions of their vested account balance.

**Hardship Withdrawals**

Hardship withdrawals are permitted and subject to certain limitations imposed by the Internal Revenue Service (IRS) and specified in the Plan Document.

**Forfeitures**

Upon termination, participants' non-vested account balances are forfeited. Forfeitures may be used to reduce employer contributions or pay Plan expenses. There were no forfeitures used to reduce employer contributions in 2024 or 2023. Forfeited non-vested accounts totaled \$47,982 and \$38,992 at December 31, 2024 and 2023, respectively.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

---

**Basis of Accounting**

The Plan's financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES – Continued**

---

**Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the investment advisers and custodians. The 401(k) Trustee Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Administrative Expenses**

Recordkeeping and investment advisory fees are paid from Plan assets. Participants should refer to the Participant Fee Disclosure Statement for a more complete description of fees charged by the Plan's custodian. The Company pays all other administrative expenses and these expenses are excluded from these financial statements.

**Subsequent Events**

Plan management has evaluated subsequent events through September 29, 2025, which is the date the financial statements were available to be issued.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- **Level 2** – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- **Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/Collective Trusts**

Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

---

The Plan’s assets included shares of mutual funds managed by Empower Trust Company, LLC. This entity served as the Plan’s recordkeeper on behalf of the custodians during 2024 and 2023 and, therefore, these transactions qualify as party-in-interest transactions. Transactions involving notes receivable from participants also qualify as party-in-interest transactions. As described in Note 2, the Company or the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA and are exempt from prohibitive transaction rules.

**NOTE 6 – PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the value of their accounts.

**NOTE 7 – TAX STATUS**

---

The IRS has determined and informed the prototype plan sponsor by a letter dated June 30, 2020 that the Plan, which is a prototype plan, and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
