Notes to Financial Statements
Years Ended December 31, 2024 and 2023

Note 1 - Description of the Plan

The following description of the Business Solutions of Perrysburg, LLC 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, as amended and restated January, 2022, is a defined contribution plan of Business Solutions of Perrysburg, LLC (the Plan Administrator) as defined in the Plan document. The Plan is a member of a controlled group and includes the companies of the group as outlined in the Plan document. All employees who have three months of service and have attained the age of 21 are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions, and an allocation of the Plan's earnings (losses) based upon participant account balances. Participants direct the investment of their contributions among the investment funds offered by the Plan. The benefit to which a participant is entitled is the benefit that can provide from the vested value of the participant's account.

Contributions

Participants may elect to defer as contributions, on a tax deferred basis, an amount up to the maximum percentage allowable, as defined in the Plan document. Participants over age 50 may also defer catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company provides a safe harbor match of 100% of the participant contributions up to 3% of gross compensation plus an additional 50% of the participant's contribution between 3% and 5%.

Note 1 - Description of the Plan (continued)

Payment of Benefits

On termination of service, death, disability, or retirement, or upon attainment of age 59 1/2, a participant may receive a payment in the amount equal to the value of the participant's vested interest in his or her account. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump sum payment.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Company matching contributions are fully vested after completing three years of service.

Forfeitures

Forfeited amounts may be used to reduce the Company's future contributions or to pay reasonable Plan expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of a plan termination, participants will become 100% vested in their accounts.

Administrative Expenses

Certain administrative expenses are paid by the Plan or the participant, as described in the Plan document. The Company paid for other costs of administering the Plan, including professional fees. The services are rendered by parties in interest to the Plan.

Note 2 - Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There have been no changes in the valuation methods used.

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value (NAV).

Money market funds are valued using the amortized cost method as permitted by Rule 2a-7 under the Investment Company Act of 1940, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that could affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

New Accounting Pronouncement Adopted

During the year ended December 31, 2023, the Plan adopted the provisions of Accounting Standards Update (ASU) 2016-13, Financial Instruments - Credit Losses (Topic 326). This ASU replaced the incurred loss methodology with an expected loss methodology that is referred as the current expected credit loss (CECL) methodology. The ASU requires nonprofit entities to immediately recognize the estimated expected credit losses over the life of a financial instrument, including trade receivables, employer contributions and benefit rebates. The estimate of expected credit losses considers not only historical information, but also current and future economic conditions and events.

The Plan adopted the ASU effective January 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in additional disclosures.

Note 3 - Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of the unobservable inputs.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value, as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Note 4 - Income Tax Status

The Internal Revenue Service ruled on November 30, 2014 that the Volume Submitter Profit Sharing Plan with CODA qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan has since been amended. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is currently designed in compliance with the applicable requirements of the IRC, and has indicated that it is taking the necessary steps, if any, to bring the Plan's operations into compliance.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.
