Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Milestone Administrative Services LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements
Year Ended December 31, 2024

1. Description of Plan

The following brief description of Milestone Administrative Services LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering substantially all employees of Milestone Administrative Services LLC (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The custodian of the Plan is John Hancock Life Insurance Company (U.S.A.) (the “Custodian”). The Company is the Plan’s trustee and Company management personnel act as the administrator of the Plan.

Eligibility - Employees who are at least twenty-one years of age are eligible to enter the Plan on the first day of the month coinciding with or following the date the eligibility requirement is met. Participants must be employed on December 31 to be eligible for a discretionary nonelective contribution unless the participant terminates due to retirement, disability or death. Certain employee classes are excluded from participation in the Plan, as defined.

Contributions - Eligible employees may authorize the Company to withhold pre-tax and Roth contributions up to the annual limit established by the Internal Revenue Code (“IRC”). All newly eligible employees are automatically enrolled in the Plan with a pre-tax deferral percentage of 2%, unless the employee elects otherwise. A participant’s pre-tax and Roth contributions will be separately accounted for, as will the gains and losses attributable to each. Participants who reach fifty years of age before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing pre-tax and Roth distributions from other qualified retirement plans or individual retirement accounts.

The Company may make a discretionary nonelective contribution although one was not elected for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, the Company’s contributions and an allocation of Plan earnings, and may be charged with an allocation of Plan expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of 1) \$50,000 reduced by the excess, if any, of i) the highest outstanding note receivable balance during the prior twelve-month period, over ii) the outstanding note receivable balance on the date the new note receivable is made or 2) 50% of their vested account balance, whichever is less. Participant notes receivable are secured by the vested balance in the participant's account and bear interest at the prime rate plus 2%. Participants may have one note receivable outstanding at a time. Notes receivable repayments are deducted through after tax payroll deductions over a period generally not to exceed five years, unless the note receivable is for the purchase of a participant's primary residence, in which case the repayment period may not exceed thirty years.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are 100% vested in the Company's contributions plus actual earnings thereon after six years of credited service, which is earned in 20% increments annually beginning after two years of service, or upon reaching retirement age, if they become disabled while employed with the Company or terminate employment due to death. Participants are credited with a year of service for each Plan year in which they complete 1,000 hours of service based on the equivalency method, as defined.

Payment of Benefits - Benefits are generally payable upon age 59.5, disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance may be paid to a participant or beneficiary by lump sum or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions are made to applicable participants in the absence of adequate distribution elections. Generally, if no longer employed by the Company, participants must either take a lump sum distribution or begin systematic, actuarially determined withdrawals by April 1 of the year following the year in which the participant turns 73 years of age. The Plan administrator may, without the participants' consent, distribute separated participants' account balances that are less than \$1,000 in a lump sum or transfer separated participants' account balances that are at least \$1,000 but less than \$5,000 into an individual retirement account. In-service distributions of rollover contributions may be taken at any time. Other in-service distributions, including hardship distributions, are permitted if certain criteria are met.

Forfeitures - Forfeitures by participants of unvested Company contributions may be used to pay administrative expenses and reduce future employer contributions. There was not a forfeiture balance as of December 31, 2024 or 2023, and no forfeitures were used during the year ended December 31, 2024.

Current Legislation - The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date, and any SECURE 2.0 amendments must be adopted by the Plan no later than December 31, 2026, although it may operate under the new provisions as required or elected prior to amending the Plan document. The Company is currently evaluating the impact of the remaining required and voluntary provisions of SECURE 2.0 on the Plan and its participants.

2. Significant Accounting Policies

Basis of Accounting - The Plan's financial statements are prepared on the accrual basis of accounting.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

Contributions - Contributions from participants are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants - Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. The Plan distributes each year's excess contributions to the applicable participants prior to March 15 of the following year.

Benefits Paid to Participants - Benefits are recorded when paid.

Expenses and Revenue Sharing - The Company may pay certain administrative and operating costs of the Plan at no obligation to the Plan. Fees related to the administration of notes receivable from participants and distributions, and certain other fees paid to service providers, are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, such as management fees and operating expenses, are deducted from earnings recorded to net appreciation in fair value of investments.

The Plan has revenue sharing arrangements whereby certain investment managers return a portion of the investment fees to the recordkeeper. These amounts are used by the recordkeeper to offset the Plan's administrative expenses or to allocate to participant accounts, as defined, with any excess amounts held in an unallocated account to be used in future years. The unallocated account balance was not significant as of December 31, 2024 and 2023.

Risks and Uncertainties - Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contribution portion of their accounts.

Subsequent Events - The Company evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued, and no events have occurred through that date that would impact the financial statements.

3. Information Certified by the Custodian

Certain information in the accompanying financial statements, notes and supplemental schedules related to the Plan's investments and notes receivable from participants held as of December 31, 2024 and 2023, and the related net appreciation and interest income on notes receivable from participants during the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution.

4. Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

Pooled separate accounts: Separate accounts are accounts maintained by an insurance company that are used for the collective investment of funds from multiple employee benefit plans. The fair values of these investments have been estimated using the net asset values per unit as a practical expedient, as provided by the insurance company, and are based on the fair value of the underlying assets of each separate account less accrued operating expenses. This practical expedient would not be used if it is determined to be probable that the insurance company will sell the investments for an amount different from the reported net asset values.

All of the Plan's investments at fair value as of December 31, 2024 and 2023 are measured at net asset value; therefore, they are not leveled within the fair value hierarchy.

The following table details the fair value of the separate accounts by class, which is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. The investment strategies for each class are also listed below.

* Participant transactions (purchases and sales) may occur daily in the John Hancock Stable Value Fund. However, participant withdrawals may be subject to a delay of up to thirty additional calendar days, as defined in the Declaration of Trust. In addition, the fund's Declaration of Trust provides that withdrawals for purposes other than normal benefit payments or plan permitted investment option transfers may be subject to a market value adjustment, as defined, or effected no later than twelve months after the request.

^A This asset class is designed to provide a balance of growth, income and capital conservation through a mix of equity and fixed income exposures based on a participant's age and projected retirement date, adjusting asset allocations and associated risk levels with the objective of becoming more conservative as the target date approaches.

^B This asset class pursues long-term growth and appreciation by utilizing domestic, international or emerging country equity markets and market capitalizations.

^C This asset class seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

^D This asset class pursues long-term capital appreciation by investing in equity securities in domestic markets and across certain market capitalizations.

^E This asset class seeks current income by broadly investing in fixed income securities through various sectors of the bond market.

5. Tax Status

The Company has adopted a pre-approved plan document from The Retirement Advantage Inc. that received an Internal Revenue Service (“IRS”) opinion letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest and Related Party Transactions

Plan investments are units of separate accounts held by the Custodian. Fees incurred by the Plan for recordkeeping and related investment management services are included in administrative expenses and net appreciation in fair value of investments. Certain investment managers return a portion of the investment fees to the recordkeeper, which are used to offset administrative expenses or to allocate to participant accounts, as defined. Transactions such as these, as well as notes receivable from participants, qualify as exempt party-in-interest transactions. The Company pays directly certain other fees related to the Plan’s operations.

7. Prohibited Transactions

During the year ended December 31, 2024, the Company failed to remit certain participant contributions and notes receivable payments to the Plan on a timely basis. These funds were remitted to the Plan soon after the required timeframe established by the Department of Labor. The Company has yet to remit lost earnings to the Plan for the affected participants.
