## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Maryland Emergency Medicine Network 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 11, 2024 (in liquidation) and December 31, 2023 (ongoing), the related statement of changes in net assets available for benefits in liquidation for the year ended December 11, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 11, 2024, and December 31, 2023, and for the year ended December 11, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by a qualified institution and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter—Plan Termination and Liquidation Basis**

As discussed in Notes 1 and 6 to the financial statements, On April 24, 2024, the Board of Directors of Maryland Emergency Medicine Network, Inc., the Plan's sponsor, passed a resolution to terminate the Plan effective June 30, 2024. Management determined that liquidation was imminent as of April 24, 2024. As a result, the Plan has changed its basis of accounting from the ongoing concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description

The following description of Maryland Emergency Medicine Network 401(k) Profit Sharing Plan and Trust (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering the employees of Maryland Emergency Medicine Network, Inc., Eastern Shore Emergency Medicine Physicians, LLC, Maryland Emergency Medicine Network Physicians, LLC, MEMN Hospitalists, LLC, Upper Chesapeake Emergency Medicine Physicians, LLC and Emergency Medicine Network Management, LLC (collectively, the Organization) who are age 21 or older and are not covered by a collective bargaining agreement, a nonresident alien or a leased employee. The Board of Directors of the Organization is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On April 24, 2024, the Board of Directors of the Plan passed a resolution to terminate the Plan, with an effective date of June 30, 2024.

**Contributions:** There were no contributions made to the Plan after June 30, 2024. Prior to that, participants could contribute up to 95% of pretax annual compensation, as defined by the Plan. Participants were also permitted to contribute Roth after-tax deferrals to the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Organization made safe harbor matching contributions equal to 100% of the first 3% of participants' eligible compensation and 50% of the next 2% of participants' eligible compensation. The Organization could elect to make a discretionary nonelective employer contribution, which is allocated based on participants eligible compensation. Participants must be credited with 1,000 service hours during the plan year to be eligible for the employer nonelective contributions. The Organization made no discretionary non-elective employer contribution for the year ended December 11, 2024.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Investment options:** Upon enrollment in the Plan, a participant could direct all contributions to selected investment options as made available and determined by the Plan Administrator in 1% increments or into self-directed brokerage accounts. Participants could change their investment options daily.

**Participant accounts:** Each participant's account was credited with the participant's contributions and the Organization's safe harbor matching contributions, as well as allocations of any employer non-elective contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Payment of benefits:** Prior to the Plan's termination, participants were permitted to make withdrawals when they terminated employment, retired or became disabled or deceased. In-service withdrawals were also permitted for certain financial hardship (as defined by the Plan) or when the participant attained age 59½. Benefits were payable in lump-sum payments with certain exceptions allowed. Due to the decision to terminate the Plan effective June 30, 2024, all participants were paid out their accounts in lump sum payments.

#### Note 1. Plan Description (Continued)

**Vesting:** immediately vested in their contributions and safe harbor matching contributions plus earnings thereon. Vesting in the organizations non-elective contributions plus earnings thereon is based on years of continuous service.

**Forfeitures:** Forfeitures may be used to pay administrative expenses or reduce employer contributions under the Plan. At December 11, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$91,142, respectively. During 2024, \$125,030 of forfeiture were used to reduce employer contributions and none were used to pay administrative expenses.

**Notes receivable from participants:** Prior to the decision to terminate the Plan, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms could not exceed five years unless such loan was for the purchase of a participant's primary residence, in which case the repayment period could be no more than 10 years. The loans were collateralized by the vested balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions. As a result of the Plan's termination, during 2024 all unpaid loans were deemed distributed by the Plan Administrator and recorded as benefit payments.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** Due to the decision in 2024 to terminate the Plan, management determined that liquidation of the Plan was imminent, and the 2024 financial statements have been prepared using the liquidation basis of accounting. The 2023 financial statements were prepared on the going concern basis using the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value as of December 31, 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing the information provided by the trustee. Investments at December 11, 2024, are reported at liquidation value due to the Plan termination discussed in Note 6. Fair value approximates liquidation value. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the liquidation basis, including amounts expected to be earned through the final liquidation. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed as incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan.

**Contributions:** Contributions from Plan participants and the contributions from the employer are recorded in the year in which the underlying compensation is paid.

**Excess contributions payable:** Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefit payments are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable from participants that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

**Adoption of accounting pronouncement:** In April 2013, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) 2013-07, *Presentation of Financial Statements (Topic 205): Liquidation Basis of Accounting*. This ASU requires an entity to prepare its financial statements using the liquidation basis of accounting when liquidation is imminent. The ASU requires disclosures about an entity's plan for liquidation, the methods and significant assumptions used to measure assets and liabilities, the type and amount of costs and income accrued, and the expected duration of the liquidation process. The amendment is effective for entities that determine liquidation is imminent during annual reporting periods beginning after December 15, 2013, and interim reporting periods therein. Entities should apply the requirements prospectively from the day that liquidation becomes imminent. As the Plan liquidation was determined to be imminent effective April 24, 2024, the Plan adopted this ASU for the 2024 plan year, and the impact of adopting this ASU is reflected throughout the 2024 financial statements.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified or Provided by Fidelity Management Trust Company (Fidelity)

Fidelity also certified to the completeness and accuracy of \$6,796,370 of net appreciation in fair value of investments, \$533,973 of interest and dividends and \$15,122 of interest income on notes receivable from participants to the aforementioned plan assets for the year ended December 11, 2024.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 11, 2024 and December 31, 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self-directed brokerage accounts:** Accounts primarily consist of mutual funds, common stocks and exchange-traded funds that are valued on the basis of readily determinable market prices.

**Common collective trust stable value fund:** A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

(a) Seeks current income consistent with maintaining liquidity and preserving capital. The account invests primarily in high-quality short-term investments.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### Note 5. Related-Party and Party-in-Interest Transactions

Fidelity is the trustee of the Plan; therefore, transactions with the trustee qualify as party-in-interest transactions. The Organization also paid certain administrative expenses of the Plan.

The Plan's service agreement with Fidelity includes an Administrative Budget provision. At the end of each calendar quarter, Fidelity credits the Plan's Administrative Budget an amount equal to 12 basis points of the Plan's total investments, excluding forfeitures. These amounts may be used to pay plan-related expenses approved by the Organization, and to the extent not used to pay such plan expenses, shall be allocated, as determined by the Plan Administrator. Amounts received by the Plan related to a revenue sharing arrangement totaled \$24,311 for the year ended December 11, 2024, and are reported as a reduction of administrative expenses on the statement of changes in the net assets available for benefits in liquidation.

#### Note 6. Plan Termination

On April 24, 2024, a resolution was passed to terminate the Plan with an effective date of June 30, 2024. As a result, management determined liquidation was imminent. During 2024, all of the Plan's assets were distributed to participants.

#### Note 7. Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, FMR LLC, received on June 30, 2020, an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
