Basis for Opinion

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) and Schedule of Delinquent Participant Contributions as of and for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

Other Matter — Supplemental Schedules Required by ERISA (Continued)

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the Clifty Group, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a 401(k) salary reduction plan which was established on January 1, 2017 and last restated effective May 1, 2023. The Plan covers substantially all employees (other than certain nonresident aliens, leased employees and employees covered by a collective bargaining agreement) of Clifty Group, LLC, Clear Arc Industries, LLC, Bore One, LLC (effective May 1, 2024) and Voyageur Management Services, LLC (collectively, the Plan Sponsor or the Company) who have met the service requirements as defined in the Plan document. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administration

The Custodian of the Plan's assets is Principal Financial Group. The Plan is administered by an advisory committee (the Committee) made up of members of the Plan Sponsor's management. The Committee has the authority to control the operation, management and administration of the Plan.

Participation

All employees other than nonresident aliens, collectively bargained employees, leased employees and certain other classes of employees (as defined in the Plan document) are eligible for all aspects of the Plan on the first day of the calendar month following two months of employment and 167 hours of service. Employees who do not meet the 167 hour requirement in their first two months of employment but would otherwise be eligible, will become eligible after attaining 1,000 hours of service in a Plan year. Once employees are admitted into the Plan, they remain in the Plan until termination of employment and/or withdrawal of their individual account balance from the Plan. An employee's initial eligibility carries over to when the employee is rehired, if applicable (thus rehired employees may be eligible for participation immediately).

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Contributions

Each year, participants may contribute up to the maximum allowable not to exceed the limits of Internal Revenue Service (IRS) Code Section 401(k), as defined in the Plan document. Contributions to the Plan are allowable on a pre-tax basis and/or on an after-tax basis (Roth contributions). Participants who have attained the age of 50 before the end of the plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan.

The Plan includes a provision for automatic salary deferrals. Absent an election otherwise, 4% of each eligible participant's compensation is contributed to the Plan as an employee deferral.

The Company contributes to the Plan a safe harbor matching contribution of 100% of the participant's contribution on the first 4% of a participant's compensation. In addition, each year the Company may contribute a discretionary non-elective contribution to the Plan. A participant is entitled to employer discretionary non-elective contributions if employed on the last day of the plan year and having completed 1,000 hours of service during the plan year. Employees who die, become disabled, or reach normal retirement age during a Plan year will be eligible to share in employer discretionary non-elective contributions regardless of service hours or whether or not they are employed on the last day of the Plan year. There were no discretionary non-elective contributions made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant elective deferrals, employer matching contributions, employer non-elective contributions (if any) and an allocation of plan earnings. Allocations of plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. Participants' accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions, regular matching contributions, and any discretionary non-elective contributions, plus actual earnings thereon.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Notes Receivable from Participants

Within the limits of the IRC, a loan may be requested electronically by a participant. The minimum loan amount is \$1,000. The maximum loan amount may not exceed the lesser of (1) the amount which could be loaned tax-free under the applicable provisions of the IRC or (2) 50% of the loan participant's nonforfeitable account balance, reduced by the outstanding principal balance of any existing loan.

The loan repayment period is set at a maximum of 60 months. For loans used to purchase the participant's principal place of residence, the loan repayment period is set at a maximum of 180 months. The rate at which loans are issued plan-wide is the Wall Street Journal prime rate at the time of the loan plus 1.00%. No exceptions to this rate are allowed. Refinancing to secure a more favorable rate during the scheduled amortization of the loan is not allowed. Interest rates on loans outstanding as of December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Upon termination of employment, disability, death, or retirement, participants may receive the value of the participant's vested interest in the form of a lump-sum payment or if the balance exceeds \$5,000, elect to defer the benefit payment in accordance with plan guidelines. If the participant's account balance is between \$1,000 and \$5,000, the participant's balance will be paid in the form of a direct rollover to an IRA if no other election is made by the participant. Participant balances that are less than \$1,000 will be paid to the participant in the form of a lump-sum distribution with or without the participant's consent.

The Plan allows for in-service distributions from all accounts when a participant reaches normal retirement age (59 ½). Distribution from the rollover portion of participants' accounts are allowed at any time. The Plan also allows for hardship withdrawals from all accounts.

Benefit payments are recorded upon distribution to participants.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Certification of Investments

In May 2023, the Board of Directors appointed Principal Financial Group (Principal) as the custodian of the Plan's assets. The Plan Sponsor has elected to invest the assets of the Plan by means of an investment program offered by Principal and has appointed them as a recordkeeper to the Plan under a separate plan services agreement and to provide brokerage services to the Plan. Under the terms of the custodial agreement, the Custodian manages investment funds on behalf of the Plan. The Custodian acts at the direction of the Plan Sponsor and plan participants when initiating purchases and sales of the investments in the investment funds.

Principal Life Insurance Company has provided the plan administrator with certifications as to the completeness and accuracy of certain investments of the Plan held by them aggregating \$3,640,672 and \$3,178,757 as of December 31, 2024 and 2023, respectively, and the related investment income of \$406,084 and \$230,666, respectively, for the years then ended.

Principal Trust Company has provided the plan administrator with certifications as to the completeness and accuracy of certain investments of the Plan held by them aggregating \$497,599 and \$48,600, as of December 31, 2024 and 2023, respectively, and the related investment income of \$30,242 and \$181,431, respectively, for the years then ended.

Great-West Trust Company, LLC (Great West) was a custodian of a portion of the Plan's assets through March 2024. Great West has supplied the plan administrator with certifications as to the completeness and accuracy of certain investments of the Plan invested by them aggregating \$0 and \$95,079 as of December 31, 2024 and 2023, respectively, and the related investment income of \$237 and \$1,266, respectively, for the years then ended.

Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedules of the Plan based on such certifications from the Custodians.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

3. Fair Value Measurements (Continued)

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

General account investment: Fair value represents the value the Plan would receive if the various contracts were terminated, which is book value less any early withdrawal charges.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

3. Fair Value Measurements (Continued)

Investments in common/collective trust: The collective trust fund is valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above and on the previous page may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will retain 100% vesting in all accounts.

5. Plan Tax Status

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

5. Plan Tax Status (Continued)

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal tax returns generally remain open for three years.

6. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Principal Financial Group and Great West are the Custodians of a portion of the Plan's assets and manage certain Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

The Plan issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations.

Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.
