Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the e-TeleQuote Insurance 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the e-TeleQuote Insurance 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the e-TeleQuote Insurance 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the e-TeleQuote Insurance 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note A - Description of Plan

General - The e-TeleQuote Insurance 401(K) Plan (the Plan), as effective January 1, 2015, and restated July 31, 2022, is a defined contribution plan covering eligible employees of e-TeleQuote Insurance, Inc. (the Company). During 2024, the Company was acquired by GoHealth, Inc. There has been no effect on the Plan as a result of the acquisition as of the financial statement issuance date. The Plan document is the governing instrument and should be referred to for a full description of the Plan and its provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees are eligible to participate upon completion of one month of service and after the attainment of age 21. Prior to May 1, 2024, employees were eligible to participate upon completion of six consecutive months of service and after the attainment of age 21. A nonresident alien who received no earned income from the Company and certain employees covered by a collective bargaining agreement, as outlined under the terms of the Plan, are not eligible to participate in the Plan.

Employee Contributions – Participants may contribute pre-tax and Roth amounts as defined by the Plan, up to 100% of eligible compensation, in accordance with the Internal Revenue Code (the IRC) section 415 limits. Employees may also elect to make catch-up contributions provided they have reached age 50 by the end of the current calendar year. Participants may also contribute rollovers from other qualified plans. Eligible compensation is defined as W-2 wages and certain other employer contributions made pursuant to a salary reduction agreement that are not includible in the gross income of the employee, as outlined under the terms of the Plan. Bonuses, overtime pay, commissions, differential wage payments, and reimbursements or other expense allowances are not considered eligible compensation. Eligible compensation is subject to annual limitations prescribed by the IRC.

Employer Contributions – The Company contributes a safe harbor 401(K) matching contribution in an amount equal to 100% of a participant's elective deferral up to 3% of eligible compensation and 50% of a participants' elective deferral on the next 2% of eligible compensation. Participants are immediately 100% vested in this contribution. The safe harbor 401(K) matching contribution amounted to \$336,319 for the year ended December 31, 2024.

The Company may make an ACP safe harbor 401(K) matching contribution or a qualified nonelective contribution, if necessary, under the terms of the Plan, as determined annually. There were no such contributions during 2024.

Participants may direct their own contributions, as well as the Company's employer contributions, into any of a number of separate mutual funds or a money market fund maintained by Ascensus Trust Company (the Trustee).

Participant Accounts - Each participant's account is credited with the employee's contribution, the Company's matching and qualified nonelective contributions, Plan earnings, and certain administrative fees, as appropriate.

Vesting - Participants are fully vested in the value of their contributions and all employer company contributions at all times.

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to a maximum of 50% of the vested account balance or \$50,000, whichever is less. Loans, which bear interest at a rate of prime plus 1%, are collateralized by the vested portion of the participant's account and repayments are made through payroll deductions. Interest rates ranged from 4.25% to 9.50% at December 31, 2024 and 2023. Participant loans are considered assets of the Plan and are valued based on the unpaid principal balance plus accrued but unpaid interest.

Note A - Description of Plan (continued)

Benefit Payments - Individual accounts can be distributed upon the death, disability, retirement, or termination of employment of the Plan participant. In-service distributions are available at all times from a participant's rollover account balance. They are also available as long as the participant has attained the age of 59 ½ and can be taken from the participant's pre-tax or Roth accounts. Distributions to satisfy certain financial burdens, as defined under the terms of the Plan, may also be taken. The Plan provides for both lump sum or installment payments and account balances less than \$1,000 are distributed upon termination.

Note B - Summary of Significant Accounting Policies

Basis of Presentation - The financial statements of the Plan have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America. The following are the significant accounting policies followed by the Plan.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

Contributions - Employee contributions and Company contributions are recognized as additions to Plan assets in the year designated by the employee and Company, respectively.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value (Notes D and E). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the Trustee of the Plan's assets. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments - Benefits are recorded when paid.

Administrative Expenses - All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Employer.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. An allowance for notes receivable from participants has not been recorded as delinquent notes receivable from participants are recorded as a distribution and reduction of the participant loan balance based upon the terms of the Plan document.

Subsequent Events - Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note C - Tax Status

The Internal Revenue Service has determined by a letter dated June 30, 2020, that the Prototype Non-Standardized Profit Sharing Plan used to set the guidelines of the Plan is qualified under Section 401(a) of the IRC, as amended, and the regulations thereunder, and the Plan is thereby tax-exempt within the meaning of Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and to recognize a tax benefit if it is more likely than not the tax position would be sustained upon examination by the applicable authorities. The remainder of the tax position is required to be recorded as a tax liability. The Plan's tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed. The Plan currently has no uncertain tax positions and, therefore, no liabilities have been recorded.

Note D - Investments (Certified)

For the years ended December 31, 2024 and 2023, the plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Ascensus, LLC, an authorized representative of Ascensus Trust Company, the trustee of the Plan, as complete and accurate, except for comparing such information certified by Ascensus, LLC to information included in the Plan's financial statements and supplemental schedule:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment earnings and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

Note E - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, "Fair Value Measurements and Disclosures," establishes a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs into three broad levels. Level 1 inputs are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are quoted prices for similar assets in active markets or inputs that are observable for the asset, either directly or indirectly through market corroboration, for substantially the full term of the asset. Level 3 inputs are unobservable and significant inputs developed by the plan sponsor based on the best information available about the assumptions market participants would use in pricing the asset. A financial asset's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used in measuring Plan assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – The fair value of mutual funds are obtained by the Trustee from quoted market prices available on active markets.

Money Market Fund – The fair value of the money market fund is obtained by the Trustee from the quoted market price available on active markets.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F - Party-in-Interest

The Plan's assets are invested and maintained by the Trustee. Additionally, expenses in the amount of \$22,606 were paid to the Trustee for the year ended December 31, 2024. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under Section 408(b) of ERISA regulations.

Note G – Risks and Uncertainties

The Plan provides for various investment options into any number of mutual funds and a money market fund. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note H – Plan Termination

Although there is not a present intent to do so, the Company has reserved the right to terminate or partially terminate the Plan.

Note I – Plan Amendment

Effective May 1, 2024, the plan was amended to change the service requirement for eligibility purposes from six consecutive months of service to one month of service.
