The following description of Best Friends Pet Care Holdings, Inc. (the “Company”) Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Company established the Plan effective as of December 21, 2018. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (“ESOP”) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the “Code”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). GreatBanc Trust Company (“Trustee”) is the Plan’s Trustee.

To establish the ESOP, the Plan purchased Company stock using proceeds of a Promissory Note (“Note”) from the Company (See Note 6). The Note is to be repaid over a period of 20 years by fully deductible Company contributions to the trust fund. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

The Plan and Best Friends Pet Care Holdings, Inc. ESOP Trust (“Trust”) established under the Plan have entered into a Pledge Agreement where the Plan and Trust have agreed to pledge unallocated shares of Company stock back to the Company to secure the payments under the Note. Each Plan year, shares will be released from the Pledge Agreement equal to the number of shares allocated to participants’ accounts. The Company has no rights against shares once they are allocated under the Pledge Agreement. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, present separately the assets and liabilities and changes therein pertaining to:

- (A) the accounts of employees with vested rights in allocated stock (allocated) and
- (B) stock not yet allocated to employees (unallocated).

Eligibility

Employees of the Company are generally eligible to participate in the Plan after one year of service providing they worked at least 1,000 hours during such plan year and are age 21 or older on the fixed entry dates of January 1st or July 1st. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of contributions for such year. An eligible employee will still receive an allocation of the Company contributions for a plan year if employment is terminated on account of retirement, death, or disability in such year.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan’s dividends or distributions paid to the Plan, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on the exempt loan. Employee contributions are not permitted. The contributions are allocated according to the pro rata share of each participant’s compensation to total eligible compensation. See Note 6.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of shares of the Company's common stock released by the Trustee and forfeitures of terminated participants' non-vested accounts, in such an amount as determined at the sole discretion of the Company and in accordance with the plan document. Only those participants who meet the requirements outlined in the Eligibility section above will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

Employer contributions and plan forfeitures are allocated to each participant's account based on the proportion of a participant's covered compensation, as defined by the Plan, to covered compensation for all participants each plan year. There were 8,769 and 9,286 shares of Company stock in other accounts forfeited by participants in 2024 and 2023, respectively.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service in the Plan. A participant is 20% vested after two years of credited service and are 100% vested after six years of credited service.

Payment of Benefits

Distributions of benefits may be made in cash or Company stock or both. In the event of retirement, total disability or death of a participant, benefits will commence no later than the last day of the Plan year following the Plan year on which a participant retires, suffers a disability, or dies while employed by the Company. Distributions related to terminations may commence no later than one year after the end of the fifth plan year following the plan year in which the participant separated from service. The full benefits will be paid in either a lump sum, in five substantially equal annual installments, or in as many substantially equal annual installments as permitted under Code Section 409(o)(1)(C)(ii). Distribution to a participant shall not include any Company stock acquired with the proceeds of an exempt loan until the close of the plan year in which such loan is repaid in full.

Voting Rights

The Trustee shall vote all Company stock held by it as part of the plan assets. Provided, however, that if any agreement entered into by the Trust provides for voting of any shares of Company stock pledged as security for any obligation of the Plan, then such shares of Company stock shall be voted in accordance with such agreement. If the Trustee does not timely receive voting directions from a participant or beneficiary with respect to any Company stock allocated to that participant's or beneficiary's Company stock account, the Trustee shall vote such Company stock. Notwithstanding the foregoing, if the Company does not have a registration-type class of securities, each participant or beneficiary in the Plan shall be entitled to direct the Trustee as to the manner in which voting rights on shares of Company stock which are allocated to the Company stock account of such participant or beneficiary are to be exercised with respect to any corporate matter which involves the voting of such shares with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction as prescribed by law.

Plan Termination

The Company reserves the right to terminate or amend the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Company shall direct the trustees to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

Put Option

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase in substantially equal annual installments over a period not to extend beyond five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified. Participants who have 10 years of plan participation and who have attained age 55 are eligible to diversify a portion of the employer securities held in their ESOP accounts. Participants will be eligible to diversify following the December 31, 2027 plan year end.

Note 2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (“allocated”) and (b) stock not yet allocated to employees (“unallocated”), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded upon distribution.

Administration of Plan Assets

The Plan's assets, which consist principally of Company common shares, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal of the loan, which is reimbursed to the Trustee through contributions as determined by the Company.

Administrative Expenses

Plan expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net asset available for benefits. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Sponsor Company Common Stock

The fair value of the Company common stock is determined by an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 6. Note Payable

On December 21, 2018, the Plan entered into a \$14,091,000 promissory note with the Company. The proceeds of the note were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 48,134 and 173,807 shares being released and allocated for the Plan years ended December 31, 2024 and 2023, respectively.

The balance due on the note payable as of December 31, 2024 and 2023, was \$8,314,825 and \$8,899,295, respectively. The loan agreement bears interest at 3.31% and provides for the loan to mature on December 31, 2039. The scheduled amortization of the loan for the next five years and thereafter is as follows:

Note 7. Exempt Party-In-Interest Transactions

Note 8. Tax Status

The Internal Revenue Service (the “IRS”) has determined and informed the Company by letter dated April 7, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the “IRC”). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets (Deficit) Available for Benefits.
