### NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Exclusive Wireless, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has been restated for the final Cycle 3 regulations effective February 15, 2022. The Plan's purpose is to provide employees of Exclusive Wireless, Inc., and its participating affiliates and locations (the Company), the opportunity to accumulate funds for their retirement. The Plan's Trustee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Trustee.

#### Eligibility

An employee of the Company normally becomes eligible to participate in the Plan after completing one year of service with the Company and after attaining age twenty-one. Employees may elect to participate in the Plan on the first day of January, or the date six months thereafter, following completion of all eligibility requirements. Nonresident aliens and union employees are excluded from the Plan.

#### Employee Contributions

Participants may contribute a percentage of their annual compensation through salary deferrals up to the maximum dollar amount determined by the Internal Revenue Service (IRS) each year. If the participant is age 50 or older, the participant may elect to defer additional amounts as defined by the law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

#### Employer Contributions

Upon fulfillment of the eligibility requirements, participant accounts will accrue a safe harbor match of 100% of employee deferrals up to 4% of eligible compensation. For the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions of \$307,743 and \$251,671, respectively.

Each year the Company may determine discretionary non-elective and matching contributions to the Plan. Contributions will be allocated to participants in proportion to each participant's compensation for the plan year to total compensation for all participants for that year. For the years ended December 31, 2024 and 2023, the Company did not make a non-elective or matching discretionary contribution.

Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are allowed to direct their contributions and the employer discretionary and safe harbor matching contributions by the Company into any of the various investment options offered by the Plan.

### NOTE 1 – DESCRIPTION OF PLAN (continued)

#### Vesting

Participants contributions, employer safe harbor match and actual earnings thereon are immediately 100% vested. Discretionary contributions by the Company vest on a pro rata basis over six years. In the event of death, disability or normal retirement age, a participant's interest in employer discretionary contributions becomes fully vested.

#### Payment of Benefits

Upon retirement, death, disability or termination of service due to other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A partial or installment distribution may be permitted if needed to satisfy the required minimum distribution rules. In certain circumstances, participants may request "hardship withdrawals" as defined in the Plan.

A participant who has attained age 59-1/2 and who has not separated from service may obtain an in-service distribution of their vested benefits.

#### Forfeitures

Forfeitures may be used to pay administrative expenses of the Plan or to reduce any employer contributions. At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

### NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors and insurance company. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled separate accounts:* Pooled separate accounts invest in mutual funds, domestic equity securities, or fixed maturity securities. More than one source may be used to generate unit prices. The market price of the fund and the unitized pricing model are both used.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### NOTE 6 – TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### NOTE 7- ALLOCATION OF ASSETS

Net assets available in the amount of \$367,354 and \$277,151, for the years ended December 31, 2024 and 2023, respectively, have been allocated to the accounts of employees who have separated service with the Company.

At December 31, 2024 and 2023, no accounts included nonvested amounts to be forfeited in later years.

### NOTE 8 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan assets were managed by John Hancock Life Insurance Company (USA). Plan management includes recordkeeping and investment services related to contributions received, plan earnings and distributions. The services to the Plan qualify as party-in-interest transactions. Third party administrative services are paid for by the Plan.

John Hancock investment advisory expenses totaled \$32,768 and \$22,887, for the years ended December 31, 2024 and 2023, respectively. Third party administrative services and compensation reported by John Hancock related to the Plan totaled \$14,101 and \$6,899, for the years ended December 31, 2024 and 2023, respectively.

Administrative functions are jointly performed by employees of the Company and Economic Group Pension Services, Inc. (EGPS). No employee receives compensation from the Plan. The independent auditor's fees are paid directly by the Company.

### NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 10 - SUBSEQUENT EVENTS

Plan management has evaluated events and transactions for potential disclosure through October 13, 2025, the date these financial statements were available to be issued.
