Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jim Hawk Truck Trailers, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. Plan Description

The following brief description of the Jim Hawk Truck Trailers, Inc. 401(k) Savings Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides retirement benefits for the employees of Jim Hawk Truck Trailers, Inc. and Subsidiaries (the Company).

Employees are eligible to make pre-tax salary deferral contributions and receive discretionary matching contributions and discretionary profit-sharing contributions after completing three months of service. Eligible employees may become participants on the first day of the month following their date of eligibility.

Participants are eligible for discretionary profit-sharing contributions if they complete 500 hours of service and are employed as of the last day of the Plan year.

Eligible employees are automatically enrolled in the Plan, with pre-tax salary deferral contributions starting at 3% of their eligible compensation. Employees have the option to choose their own salary deferral percentages and whether to participate in the Plan before their respective automatic enrollment period begins and at any subsequent time during the Plan year.

Contributions

Participants may make voluntary pre-tax salary deferral contributions up to the maximum dollar limits allowed by law. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching contributions and discretionary profit-sharing contributions. Participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of a) the Company's discretionary matching contributions b) the Company's discretionary profit-sharing contributions and c) Plan earnings or losses. Company discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. Company discretionary profit-sharing contributions are allocated on the basis of the participant's eligible compensation for the Plan year. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant.

For the period from July 1, 2024 to December 31, 2024, investments were maintained in individual member accounts managed by Matrix Trust Company (Matrix). Prior to July 1, 2024, investments were maintained in individual member accounts managed by United of Omaha Life Insurance Company (United of Omaha). Effective January 1, 2025, investments will be maintained by Ascensus Trust Company.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions credited to participant accounts is based on years of continuous service. Participants are 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are made on a nondiscriminatory basis and are secured by the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination, death, disability or retirement, the participant or beneficiary may elect to receive a lump sum, partial payments, or installment payment equal to the value of the vested funds allocated to the participant's account. Distribution payments between \$1,000 and \$5,000 are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 are paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement or death, the portion of their Company's contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to reduce Plan expenses or Company contributions. As of December 31, 2024 and 2023 there were \$38,105 and \$8,318, respectively, non-vested accounts available. During 2024 and 2023, the Company used \$8,571 and \$39,339, respectively, of forfeitures to reduce Company contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting - Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts were reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. During 2023, the Plan invested in investment contracts through a guaranteed interest account. At December 31, 2024, the Plan no longer invests in the guaranteed interest accounts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Other

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Record-keeping and other administrative expenses are paid by the Plan and are included in administrative expenses.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 8, 2025. See the "Participant Accounts" section of Note 1 for a description of a subsequent event.

3. Information Certified by Matrix and United of Omaha

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Matrix and United of Omaha, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures* provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required

Pooled Separate Accounts: Valued at (NAV) of its underlying investments. The accounts include investments in fixed securities, mutual funds, common stocks, or real estate which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets FASB ASC 820, *Fair Value Measurement and Disclosure*, allows NAV to estimate the fair value as a practical expedient as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements. Since the participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis. There were no unfunded commitments as of December 31, 2023. There are no pooled separate accounts at December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with United of Omaha

The Plan entered into an investment contract with United of Omaha which maintained contributions in pooled separate accounts and a guaranteed interest account. The accounts were credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by United of Omaha.

The pooled separate accounts, as reported to the Plan by United of Omaha, are included in the financial statements at December 31, 2023 at fair value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses).

As the guaranteed interest account was fully benefit-responsive, contract value was the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by United of Omaha, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

6. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

8. Related-Party Transactions

Certain Plan investments at December 31, 2023, included a guaranteed interest account managed by United of Omaha. United of Omaha was the custodian of the Plan and therefore, these transactions qualified as party-in-interest transactions. There are no investments at December 31, 2024, that qualify as party-in-interest transactions with the current custodian, Matrix.
