***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Image Options Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Image Options Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. DECEMBER 31, 2024 AND 2023**

**1. Description of Plan**

The following description of the Image Options Retirement Savings Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a savings and profit sharing plan organized by Image Options (the “Company”) – established February 1, 2008 and restated June 8, 2022 – to encourage and assist eligible employees of the Company to adopt a regular program of savings to provide additional security for retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

b. Administration

The Plan is overseen by the Retirement Plan Committee appointed by the Company which includes the trustees of the Plan. The Plan’s contract administrator is Hicks Pension Services (“Hicks”). The Plan’s recordkeeper, third-party trustee and custodian is Empower Trust Company, LLC. The Company has the discretion to appoint or remove any trustees or agent of the Plan.

The Plan was amended and restated effective January 1, 2022 to incorporate certain provisions required by rulings adopted by the IRC.

c. Eligibility

Employees of the Company and its subsidiary are eligible to participate in the Plan, except for members of a collective bargaining agreement and nonresident aliens, provided they have completed three months of service and are age eighteen or older.

The Plan includes an automatic enrollment feature. Employees meeting the eligibility requirements are automatically enrolled in the Plan with a deferral rate of 3% unless the participant affirmatively elects otherwise. Each participant having automatic enrollment contributions made on their behalf will have their deferral rate increased annually by 1%, up to a maximum of 6% unless elected otherwise. The increase in the annual deferral percentage will be effective as of the first day of the Plan year, beginning after the initial percentage has been in effect for a full Plan year. If the participant decides to stop the automatic contributions to the Plan, a request for the withdrawal of those contributions may be done within the first 90 days of the first automatic contribution.

d. Participant Contributions

Participants may contribute to the Plan up to 100% of eligible compensation through elective, pre-tax and post-tax (“Roth”) salary deferrals, subject to the IRC limit of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Upon reaching the age of 50, participants may make additional catch-up contributions limited to \$7,500 for the years ended December 31, 2024 and 2023.

Rollover contributions meeting certain guidelines detailed in the Plan document may be made to the Plan and are invested in the participants’ accounts according to their specific allocations of investment fund options as of the date of the contribution.

e. Employer Contributions

The Company may make a discretionary matching contribution to participants’ accounts, as defined by the Plan. For the years ended December 31, 2024 and 2023, the Company elected to not make any matching contributions.

The Plan provisions also permit the Company to make a discretionary qualified non-elective contribution (“profit sharing contributions”) to eligible participants, as defined by the Plan, in the ratio that each participant’s compensation bears to the total compensation of all participants for such plan year. For the years ended December 31, 2024 and 2023, there were no profit sharing contributions made by the Company.

All contributions are invested in the participants’ accounts according to their specified investment allocations as of the date of the contribution.

f. Participant Accounts

Separate accounts are maintained for each participant. Participants direct the investment of their account balances. Earnings or losses from investments are allocated to the participant account balances on a daily basis using a weighted average of participant account balances. Plan administration fees are deducted from participant accounts on a quarterly basis. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant’s vested account.

g. Vesting

Participants are immediately vested in their elective salary deferrals, catch-up contributions, rollover contributions and the earnings thereon. Participants vest in employer matching contributions and profit sharing contributions and the earnings thereon based on years of service.

Effective July 1, 2018, participants vest in discretionary employer matching and discretionary profit sharing contributions and the earnings thereon as follows:

Additionally, participants become 100% vested in all Employer contributions and the earnings thereon upon Plan termination, death, disability, or upon reaching normal retirement age.

h. Payment of Benefits

Upon retirement, total or permanent disability, termination, or death, participants or their beneficiaries are entitled to receive their vested balances in a lump sum distribution or in accordance with other options. In addition, the Plan permits in-service distributions for participants who are age 59 ½ or older. Distributions paid prior to the participant attaining age 59 ½ and not rolled into another retirement account are subject to certain federal income tax penalties.

Vested account balances less than \$7,000, but more than \$1,000 may be distributed as a lump-sum cash payment or in the form of a direct rollover to an individual retirement account or eligible retirement plan at the consent of the participant or beneficiary. Vested account balances less than \$1,000 are distributed in a single lump-sum cash payment to the participant or beneficiary.

i. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single lump sum, a portion of their vested account balance. These conditions include the payment of unreimbursed medical expenses, postsecondary education tuition for immediate family members, funeral or burial costs of immediate family members, natural disaster clean-up on the participant's primary home, the purchase of the participant's primary home, or to prevent eviction or foreclosure from the participant's primary residence.

j. Notes Receivable from Participants

Participants may borrow from their accounts the lesser of a) \$50,000, reduced by the highest outstanding note balance during the prior year, or b) 50% of their vested account balance. Notes are subject to a \$1,000 minimum and are secured by the vested balance in the participant's account. Note payments are made through payroll deductions over periods up to five years, unless the note is used to acquire a principal residence, in which case the term may be extended at the discretion of the Plan administrator. New notes bear interest at the prime rate plus 1% per annum and are fixed at inception of the note. As of December 31, 2024, notes mature through 2029 and bear interest at rates ranging from 4.25% - 9.50% per annum, which is commensurate with local prevailing rates as determined by the Plan administrator at the time of the note.

k. Forfeitures

Unvested discretionary employer matching and discretionary profit sharing contributions forfeited by an employee that terminates from the Plan are retained in the Plan and used to reduce Plan expenses or may also be used to reduce future employer contributions. As of December 31, 2024 and 2023, forfeitures totaling \$4,579 and \$4,453, respectively, were available to pay Plan expenses or to reduce future employer contributions.

l. Administrative Expenses

All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Company. For the years ended December 31, 2024 and 2023, direct expenses totaling \$31,277 and \$27,709 were paid by the Plan, respectively. Expenses that relate solely to a specific participant, such as fees for notes receivable or benefit payments, are assessed to the participant. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified

## 2. **Summary of Significant Accounting Policies**

a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") as set forth by the Financial Accounting Standards Board (the "FASB").

b. Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Guaranteed Investment Contract Account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of investment contracts and Note 5 for discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

c. Payment of Benefits

Benefits are recorded when paid.

d. Use of Estimates

The preparation of the Plan's financial statements in conformity with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

e. Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available for issuance.

### **3. Information Certified by the Custodian (Unaudited)**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(c) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC.

The classification of the investments into the appropriate fair value hierarchy levels (1, 2 or 3) as disclosed in Note 5 is not certified by the Custodian and is the responsibility of the Plan's management.

### **4. Investments**

The Plan's investment assets are held by Empower Trust Company, LLC. Participants can direct their accounts among various pooled separate accounts and a guaranteed investment contract with an insurance company.

*Investment Contracts:* The guaranteed investment contract is a fully benefit-responsive investment contract. Investment contracts held by a defined contribution plan are required to be reported at contract value.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contributions under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

There are no unfunded commitments. Under the terms of the contract, the Plan sponsor must provide a minimum of 90 days' notice to the custodian prior to redemption of the contract.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

## **5. Fair Value Measurements**

ASC 820, *Fair Value Measurements*, establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 — inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — inputs to the valuation methodology are unobservable and significant to the fair value.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Pooled Separate Accounts:* Investments in pooled separate accounts are valued on a net asset value ("NAV") per unit basis which approximates their fair value. Redemptions may occur on a daily basis. The use of net asset value as the fair value is deemed appropriate as the pooled separate accounts do not have a finite life, unfunded commitments relating to investments, or significant restrictions on redemptions.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

## **6. Party-in-Interest Transactions**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned.

Plan investments are sponsored by Empower Trust Company, LLC, serving as a custodian of the Plan. Therefore, any investment transactions executed with the custodian qualify as party in-interest transactions.

Additionally, the Plan sponsor, Image Options, is a party-in-interest to the Plan. The transactions between the Plan and the Plan sponsor included funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

## **7. Tax Status**

The Company adopted the Volume Submitter Adoption Agreement for the Hicks Pension Services Profit Sharing Plan which received a favorable opinion letter from the Internal Revenue Services (“IRS”) dated December 17, 2021, stating that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since Hicks received the opinion letter. However, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan is qualified and the related trust is tax exempt as of December 31, 2024 and for the year then ended.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all of their account balances.

## **9. Risks and Uncertainties**

The Plan is exposed to market and credit risk due to the various investment securities that may be selected by a participant in any combination. Investment securities are exposed to various risks, such as interest rate risk and market and credit risk. In addition, certain investment options invest in foreign-denominated securities. As such, funds invested in those investment options are exposed to changes in value arising from fluctuations in currency exchange rates.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values may result in the near term due to the risks discussed above that would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.





