NOTES TO FINANCIAL STATEMENTS
YEAR ENDED DECEMBER 31, 2024**

DESCRIPTION OF PLAN

The following description of the Big Dutchman, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

GENERAL - The Plan is a defined contribution plan covering all full-time employees of the Company. There are no age or service requirements for employee contributions. Participants are eligible to receive employer contributions after one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS - Each year, participants may contribute pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan. The Company’s maximum annual matching contribution per participant is \$4,500. Additional amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations.

PARTICIPANT ACCOUNTS - Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution, (b) Plan earnings, and (c) forfeitures of terminated participants’ nonvested amounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

VESTING - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

PAYMENT OF BENEFITS - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

INVESTMENT OPTIONS - The Plan provides that all contributions to the Plan will be invested in certain individual funds as directed by each participant. Participants may change their investment options at any time.

PAYMENT OF EXPENSES - Administrative expenses of the Plan are deducted from investment income of the Plan. Administrative expenses were \$39,101 and \$34,443 for the years ended December 31, 2024 and 2023, respectively.

FORFEITED ACCOUNTS – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$266 and \$2,730 respectively. These accounts will be used to reduce future administrative expenses.

SUMMARY OF ACCOUNTING POLICIES

BASIS OF ACCOUNTING - The financial statements of the Plan have been prepared in conformity with generally accepted accounting principles, using the accrual method of accounting. All investments are stated at market value.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under terms of the plan. At December 31, 2024 and 2023, the Plan had no fully benefit-responsive investment contracts.

ESTIMATES - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION - Investments are reported at fair value, except for benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS - Benefits are recorded when paid.

FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 consist of observable inputs other than quote prices for identical assets; and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

All investments are stated at market value using Level 1 inputs. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Investment income includes unrealized gains and losses.

RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Greenleaf Trust. Greenleaf Trust is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Greenleaf Trust amounted to \$39,101 for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right to terminate the plan subject to the provisions set forth in ERISA. In the event of Plan termination, participant accounts will be 100% vested and nonforfeitable.

TAX STATUS

Effective March 25, 2021, the Plan has adopted the Greenleaf Trust Non-Standardized Defined Contribution Pre-Approved Plan. The Greenleaf Trust Non-Standardized Defined Contribution Plan's most recent determination letter is dated June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan's most recent amendment was effective March 25, 2021. The Plan administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

RISKS AND UNCERTAINTIES

The Plan invests in publicly traded securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

SUBSEQUENT EVENTS

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to adopt automatic enrollment for newly hired employees.
