NOTE A - DESCRIPTION OF PLAN

The following description of the Monumental Sports and Entertainment 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The purpose of the Plan is to provide a profit-sharing plan for employees of Lincoln Holdings, LLC, d/b/a Monumental Sports and Entertainment (hereinafter referred to as "Plan Sponsor"). The Plan is a defined contribution plan covering all full-time employees of the company and part-time employees who have reached age 21 and have completed at least 1,000 hours of service. Employees of the Plan Sponsor who are not eligible to participate in the Plan include employees covered by collective bargaining agreement, leased employees, non-resident aliens who do not receive earned income from the Plan Sponsor which constitutes United States source income, and employees who participate in other league-sponsored plans. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan committee is responsible for oversight of the Plan. Fidelity Management Trust Company ("Fidelity" or "Trustee") is the trustee and custodian of the Plan. The last amendment to the Plan document was effective September 16, 2022.

Contributions

Each year, participants may contribute up to 90% of pretax and/or after-tax annual compensation as defined in the Plan, subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). An initial pre-tax deferral contribution of 3% will be made for newly eligible employees 35 days after such employee's date of hire. Participants with a deferral rate greater than 0% will have that deferral increased annually by 1% as a pre-tax deferral contribution up to a maximum of 6%.

Participants must complete six months of eligible service to receive any non-discretionary matching employer contribution. The Plan Sponsor contributes 50% of the deferral contribution subject to a maximum of 6% of eligible compensation contributed to the Plan.

Participants must complete six months of eligible service and at least 1,000 hours of services during the Plan year to receive discretionary nonelective employer contributions. There were no such contributions for Plan years ended 2024 and 2023.

Participants who become disabled or are deceased are exempted from any last day or hours of service requirement. All contributions are subject to certain limitations.

Investment Options

Participants direct the investment of their contribution and the Plan Sponsor matching contributions into various investment options offered by the Plan and may make changes to their investment direction on a daily basis. In the event a participant fails to direct his or her investment election, his or her account will be invested 100% in the T. Rowe Price Retirement Funds based upon the participant's date of birth.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, the Plan Sponsor's non-discretionary matching contributions, Plan earnings (losses) as well as allocations of the company's discretionary non-elective employer contribution, if any, and is charged with administrative expenses. Investment earnings and losses are allocated based upon

the investment performance of each investment in the participant's account. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in all contributions and employer contributions to the Plan and any earnings thereon.

Payment of Benefits

Benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions and earnings thereon allocated to such participant's accounts. On termination of service due to retirement, disability, termination of employment, death or after a participant reaches age 59½, a participant may elect to receive either installment distributions paid over a period of time or a lump-sum amount equal to the value of the participant's vested account. Reservists called to active duty for more than 179 days or for an indefinite period may elect to withdraw penalty-free deferral contributions during the active duty period. Any death benefits under the Plan will be paid to the participant's beneficiary. The Plan also provides for minimum required distributions in which the participant reaches age 73 or the calendar year the participant retires.

If the total vested value is below \$1,000 in a participant's account at the time of termination, then a distribution will be made to the participant regardless of whether he or she consents to receive it. If the total vested value is greater than \$1,000, but less than \$7,000, the participant has the option of either 1) rolling over his or her balance into a qualified individual retirement account, or 2) receiving a distribution. If the vested value is greater than \$7,000, the participant may remain in the Plan.

Hardship distributions to employees are permitted if certain conditions are met. The minimum hardship withdrawal is \$500.

Forfeiture Account

Forfeitures may be used to reduce the Plan Sponsor's matching contribution or to offset Plan expenses. As of December 31, 2024 and 2023, the balance of the non-vested forfeiture account totaled \$961 and \$4,664, respectively. During the year ended December 31, 2024, no forfeiture was used to reduce the employer matching contribution.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments presented in the statement of changes in net assets available for benefits includes realized gains or losses and unrealized appreciation on those investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Costs

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the Trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss), as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023 or transfers between levels.

Mutual funds: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are actively traded open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price.

Collective trust: Valued at the daily closing price as reported by the fund. This fund publishes their daily NAV and transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Levels 1, 2 or 3.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA.

NOTE F - TAX STATUS

The Plan is a prototype plan which received an opinion letter on June 30, 2020, in which the IRS stated that the form of the Plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has since been amended, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity. Fidelity is paid administrative fees from the Plan. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

Scope and nature of the ERISA Section 103(a)(3)(C) audit

NOTE A - DESCRIPTION OF PLAN

The following description of the Monumental Sports and Entertainment 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The purpose of the Plan is to provide a profit-sharing plan for employees of Lincoln Holdings, LLC, d/b/a Monumental Sports and Entertainment (hereinafter referred to as "Plan Sponsor"). The Plan is a defined contribution plan covering all full-time employees of the company and part-time employees who have reached age 21 and have completed at least 1,000 hours of service. Employees of the Plan Sponsor who are not eligible to participate in the Plan include employees covered by collective bargaining agreement, leased employees, non-resident aliens who do not receive earned income from the Plan Sponsor which constitutes United States source income, and employees who participate in other league-sponsored plans. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan committee is responsible for oversight of the Plan. Fidelity Management Trust Company ("Fidelity" or "Trustee") is the trustee and custodian of the Plan. The last amendment to the Plan document was effective September 16, 2022.

Contributions

Each year, participants may contribute up to 90% of pretax and/or after-tax annual compensation as defined in the Plan, subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). An initial pre-tax deferral contribution of 3% will be made for newly eligible employees 35 days after such employee's date of hire. Participants with a deferral rate greater than 0% will have that deferral increased annually by 1% as a pre-tax deferral contribution up to a maximum of 6%.

Participants must complete six months of eligible service to receive any non-discretionary matching employer contribution. The Plan Sponsor contributes 50% of the deferral contribution subject to a maximum of 6% of eligible compensation contributed to the Plan.

Participants must complete six months of eligible service and at least 1,000 hours of services during the Plan year to receive discretionary nonelective employer contributions. There were no such contributions for Plan years ended 2024 and 2023.

Participants who become disabled or are deceased are exempted from any last day or hours of service requirement. All contributions are subject to certain limitations.

Investment Options

Participants direct the investment of their contribution and the Plan Sponsor matching contributions into various investment options offered by the Plan and may make changes to their investment direction on a daily basis. In the event a participant fails to direct his or her investment election, his or her account will be invested 100% in the T. Rowe Price Retirement Funds based upon the participant's date of birth.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, the Plan Sponsor's non-discretionary matching contributions, Plan earnings (losses) as well as allocations of the company's discretionary non-elective employer contribution, if any, and is charged with administrative expenses. Investment earnings and losses are allocated based upon

the investment performance of each investment in the participant's account. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in all contributions and employer contributions to the Plan and any earnings thereon.

Payment of Benefits

Benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions and earnings thereon allocated to such participant's accounts. On termination of service due to retirement, disability, termination of employment, death or after a participant reaches age 59½, a participant may elect to receive either installment distributions paid over a period of time or a lump-sum amount equal to the value of the participant's vested account. Reservists called to active duty for more than 179 days or for an indefinite period may elect to withdraw penalty-free deferral contributions during the active duty period. Any death benefits under the Plan will be paid to the participant's beneficiary. The Plan also provides for minimum required distributions in which the participant reaches age 73 or the calendar year the participant retires.

If the total vested value is below \$1,000 in a participant's account at the time of termination, then a distribution will be made to the participant regardless of whether he or she consents to receive it. If the total vested value is greater than \$1,000, but less than \$7,000, the participant has the option of either 1) rolling over his or her balance into a qualified individual retirement account, or 2) receiving a distribution. If the vested value is greater than \$7,000, the participant may remain in the Plan.

Hardship distributions to employees are permitted if certain conditions are met. The minimum hardship withdrawal is \$500.

Forfeiture Account

Forfeitures may be used to reduce the Plan Sponsor's matching contribution or to offset Plan expenses. As of December 31, 2024 and 2023, the balance of the non-vested forfeiture account totaled \$961 and \$4,664, respectively. During the year ended December 31, 2024, no forfeiture was used to reduce the employer matching contribution.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments presented in the statement of changes in net assets available for benefits includes realized gains or losses and unrealized appreciation on those investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Costs

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the Trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss), as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023 or transfers between levels.

Mutual funds: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are actively traded open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price.

Collective trust: Valued at the daily closing price as reported by the fund. This fund publishes their daily NAV and transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Levels 1, 2 or 3.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA.

NOTE F - TAX STATUS

The Plan is a prototype plan which received an opinion letter on June 30, 2020, in which the IRS stated that the form of the Plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has since been amended, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity. Fidelity is paid administrative fees from the Plan. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
