Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 - Description of Plan

The following description of Silver Springs Bottled Water Co. Employees Savings Trust (the Plan) provides only general information. Participants should refer to the Plan document and adoption agreement for a more comprehensive description of the Plan's provisions.

General

The Plan, originally effective January 1, 2007, and most recently amended June 1, 2025, is a defined contribution plan covering all eligible employees of Silver Springs Bottled Water Co., Crossroads Beverage Group, LLC, Hickory Springs Bottling, Inc., and RealPure Bottling, Inc. (the Companies) who have six consecutive months of service. Eligible employees, which exclude non-resident aliens and leased employees, may enroll on the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with, or next following, the date eligibility requirements have been met. The Plan is organized as a profit-sharing plan under section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As further discussed in Note 6, subsequent to December 31, 2024, Silver Springs Bottled Water Co. (the Plan Employer) adopted an amendment to the Plan to formally terminate the Plan, effective September 30, 2025.

Contributions

Each year, participants may contribute up to 85% of eligible compensation, as defined in the Plan, up to the maximum of \$23,000 allowed under IRC limitation for calendar year 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 to the Plan in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Companies make safe harbor contributions each pay period equal to 100% of employee salary deferrals that do not exceed 3% of compensation, plus 50% of contributions between 3% and 5% of compensation. The Companies may also make discretionary profit-sharing contributions. A participant must have completed 500 hours of service during the Plan year and must be employed on the last day of the year to be eligible to receive an allocation of the discretionary profit-sharing contributions. If a participant dies or becomes disabled during the Plan year, the participant will still be eligible to receive an allocation of the discretionary profit-sharing contributions. The Companies did not elect to make a profit-sharing contribution in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of: (a) the Companies' safe harbor contributions, (b) the Companies' discretionary profit-sharing contribution, (c) Plan earnings and losses, (d) any available forfeitures of terminated participants' non-vested accounts, and (e) administrative expenses. Allocations are based on participant earnings or account balances as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investments of their accounts into various options offered by the Plan. Participants may change their investments periodically, as permitted by the Plan sponsor.

Vesting

Participants are immediately vested in their voluntary contributions, the Companies' safe harbor matching contributions, and rollover contributions, plus actual earnings thereon. Vesting in the Companies' discretionary profit-sharing contributions plus earnings thereon are based on years of continuous service. A participant becomes 20% vested in profit-sharing contributions after two years of service, with an additional 20% vested each year thereafter until 100% is vested after six years of credited service. A participant will also become 100% vested due to death or disability before retirement and attainment of normal retirement age.

Payment of Benefits

In-service distributions from a participant's vested account balance may be made provided the participant has reached the age of 59 ½. Upon termination of employment due to death, disability, retirement, or any other reason, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in partial payments or systematic installments as elected by the participant.

Participant Loans

The Plan does not allow loans to participants or beneficiaries.

Forfeitures

Any non-vested amounts of Companies' profit-sharing contributions that remain after the distribution of a terminated participant's vested account balance are forfeited. Forfeitures are reallocated as a reduction of Companies' contributions to the participants remaining in the Plan, or as a reduction of Plan expenses. There were no forfeited amounts outstanding as of December 31, 2024 and 2023, or used during the year ended December 31, 2024.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for the guaranteed investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by investment advisors and trustees. See Note 3 for discussion of fair value measurements. The Plan's investment in the guaranteed investment contract is valued at contract value, as discussed in Note 4.

Investment transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Companies and are excluded from these financial statements. Administrative expenses paid by the Plan include investment management and recordkeeping fees. Certain transaction fees for distributions are charged directly to the accounts of the participants who incur those fees and are also included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Any costs associated with the investment of a participant's account are charged to that participant.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds are valued at the daily closing price reported by the fund on the active market on which the individual securities are actively traded. The mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission.

Pooled Separate Accounts consist of units of participation in the separate accounts, which are valued daily at their accumulation unit value. Accumulation unit value is determined based on the net asset values of the underlying funds, which are generally quoted in active markets, and the contract's separate account charges. The pooled separate accounts allow one transfer per 30-day period. Contributions into the investment option are not impacted. There are no unfunded commitments on these investments.

Collective Investment Trusts are valued at the fair value per share (unit) as determined by using estimated fair value of the underlying assets held in the fund as reported by the investment manager of the trust. The Plan considers the fair value per share (unit) to be a readily determinable fair value which is disclosed and used as the basis for current transactions. All redemptions of collective investment trusts are at the redemption date's computed net asset value and are considered to have readily available fair value.

Note 4 - Guaranteed Investment Contract

The Plan invests in the Principal Fixed Income Guaranteed Option, a traditional fully benefit-responsive guaranteed investment contract. Principal Life Insurance Company maintains the contributions in a general account. Under the terms of the existing contract, the Composite Crediting Rate is reset semi-annually and will never be less than the Guaranteed Minimum Interest Rate.

The Fixed Income Guaranteed Option is a single group annuity contract with a fixed rate of interest. The average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract. The investment account allows participants to direct permitted withdrawals and/or transfer transactions at contract value, which represents contributions plus credited interest, less participant withdrawals and fees. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Employer initiated events, such as premature termination of the contract by the Plan, could limit the fund's ability to transact at contract value with the Plan. Plan management believes that the occurrence of events that would cause the Plan to transact at less than the contract value is not probable. The issuer is contractually obligated to pay the principal and interest that is guaranteed to the fund as stated in the group annuity contract. The contract value of the Fixed Income Guaranteed Option was \$552,536 and \$511,671 as of December 31, 2024 and 2023, respectively.

Note 5 - Party-in-Interest Transactions

Certain Plan investments are managed by Principal Life Insurance Company, Principal Trust Company, and Principal Global Investors Trust Co. These transactions qualify as exempt party-in-interest transactions.

The Plan incurred administrative expenses of \$23,096 for the year ended December 31, 2024. Of this amount, \$11,377 was paid for by the Plan to the Plan's third-party administrator, and \$11,719 was paid for or accrued by the Companies.

Note 6 - Plan Termination

In September 2025, the Plan's Employer adopted an Amendment for Terminating Defined Contribution Plan, terminating the Plan effective September 30, 2025 (Effective Date). No employees are allowed to enter the Plan, and no contributions will be allowed, after the Effective Date. The Plan Administrator shall direct that distributions be made to participants and beneficiaries within a reasonable period of time after the Effective Date. Participants became 100% vested in their accounts as of the Effective Date. These financial statements have been prepared under the assumption of a going concern at December 31, 2024 and 2023, and for the year ended December 31, 2024.

Note 7 - Information Certified by Principal Life Insurance Company, Principal Trust Company, and Principal Global Investors Trust Co.

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Principal Life Insurance Company, Principal Trust Company, and Principal Global Investors Trust Co. as of December 31, 2024 and 2023, and for the year ended December 31, 2024, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

Note 8 - Income Tax Status

The Plan adopted a non-standardized defined contribution pre-approved Plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, in which the IRS stated that the pre-approved plan, as designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and the related trust is tax exempt. Accordingly, no provision for taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Subsequent Events

As discussed in Note 6, effective September 2, 2025, the Companies were sold. As a result of the sale, a Plan amendment was adopted to terminate the Plan effective September 30, 2025. The Plan Administrator anticipates that the distribution of Plan assets to participants will be completed by December 2025; however, the exact timing and final amount of assets to be distributed are subject to the completion of the termination process, including any required regulatory approvals.

The Plan has evaluated subsequent events through December 31, 2024, as of October 9, 2025, the date the financial statements were issued. No other material events have occurred since December 31, 2024 that require recognition or disclosure in the financial statements.
