**INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees  
Channell Commercial Corporation 401(k) Plan  
Rockwall, Texas

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Channell Commercial Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Channell Commercial Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Channell Commercial Corporation 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Channell Commercial Corporation 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the

aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Channell Commercial Corporation 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Channell Commercial Corporation 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4I - Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the

financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### NOTE A - Description of Plan

The following description of the Channell Commercial Corporation (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and has both 401(k) traditional and Roth feature plus a discretionary profit-sharing option for the sponsor as well as provides for safe harbor contributions. It covers all full-time employees when they meet the eligibility requirements of three consecutive months of service or a year of service and have attained 18 years of age.

**Contributions.** 401(k) contributions to the Plan are composed of employee and employer portions. Employees can elect to contribute up to \$23,000 through salary reduction. Employees eligible for catch-up deferrals may contribute up to an additional \$7,500. For the year 2024, the Company elected the safe harbor match equal to 100% of the employee deferrals that do not exceed 3% of compensation plus 50% of the employee deferrals between 3% and 5% of compensation. For 2024 and 2023, the Company elected to match but to not make a profit-sharing contribution for both years. The plan also allows for employer safe harbor contributions and employee rollover contributions.

**Participant Accounts.** Each participant’s account is credited with the employer matching, participant’s contribution, employer non-elective contribution, and investment earnings. Each participant’s account is charged with investment losses, benefits paid, and administrative expenses. Participants have direct control over the investing of their account, meeting the requirements of ERISA 404(c). Changes in investment market values and income are allocated to each participant account depending on the performance of funds in which they have elected to invest. The vested portion of the participant’s account is the benefit to which the participant is entitled.

**Vesting.** Participants are fully vested in their elective deferrals, the employer safe harbor contributions, the employer safe harbor contributions, and any rollover contributions. Profit sharing and regular employer matching is vested over a period of five years of vesting service. When years of vesting service are determined, the elapsed time method is used.

## NOTE A - Description of Plan – continued

**Payment of Benefits.** A participant's vested interest is distributed when they retire, die, or terminate employment with the Company. Participants may elect to receive their vested interest in the form of a lump-sum payment or installment payments. The Plan allows hardship distributions as well as in-service distributions for participants that have obtained the age of 59 ½. Participant loans may be distributed in-kind. Normal retirement age under the Plan is sixty-five (65).

**Notes Receivable from Participants.** Participants may borrow the lesser of 50% of their vested Plan account balance as measured at the time of the loan or \$50,000. Loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 9.5%, which are commensurate with local prevailing rates as determined by the plan administrator at the time. Principal and interest are generally paid ratably through regular payroll deductions.

**Forfeited Accounts.** When a participant terminates employment with the Company or incurs a "break in service" a portion of the participant's interest in the Plan may be forfeited depending on the number of years of service. Forfeitures can also be generated by excess employer match. As of December 31, 2024 and 2023, the forfeited non-vested accounts and excess employer match totaled \$8,897 and \$8,474, respectively. Forfeitures may be used to reduce future employer contributions or to pay expenses. For the year ended December 31, 2024, total increase is \$424 and none utilized.

## NOTE B - Summary of Significant Accounting Policies

The financial statements and notes are representations of the trustees, who are responsible for their integrity and objectivity.

**Basis of Accounting.** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates.** The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition.** Most investments are reported at fair value based upon current published market prices. The difference between the current value and cost of the investments is reflected in the statement of changes in net assets available for plan benefits. The investment in the stable value fund is reported at contract value.

**Contribution Receivable.** Employer contributions authorized but not received by year end are accrued as a receivable.

## NOTE B - Summary of Significant Accounting Policies – continued

***Payments of Benefits.*** Benefits are recorded when paid.

***Notes Receivable from Participants.*** Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Loan balances become due and payable in their entirety upon severance of employment unless directly rolled over to another employer's plan.

***Administration Expenses.*** Some of the expenses of maintaining the Plan are paid by the Company. The participants paid record keeping fees and costs incurred specifically by participants at their direction. For example, if participants choose to obtain a loan, their individual accounts are charged the custodian's fee for setting up the loan. Other fees possibly charged directly to participant accounts are elective advisory fees, wire fees, express mail service charges, and mutual funds fees charged at the fund level. Fund fees are netted with fund income and can be determined by viewing the fund prospectus. For the year ended December 31, 2024, fees paid by the Plan are \$76,163 of which \$21,132 is paid for out of revenue share.

***Subsequent Events.*** Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

## NOTE C – Distributions

Distributions made during the year fall into the three categories of corrective distributions, benefit payments, and deemed distribution of loans. The corrective distributions are required to meet discrimination testing. Benefit payments include distributions allowed under the Plan's hardship provision as well as those relating to retirement, disability, termination, and death. When payments are not being received on participant loans, the plan administrator makes the determination if the loan is uncollectible and if a deemed distribution needs to occur. The criteria for a default loan being a deemed distribution for tax purposes is different than the criteria for being uncollectible under Generally Accepted Accounting Principles. For 2024, distributions include \$44,050 for distributed loans including imputed interest which are repaid by offset.

#### **NOTE D - Cash Balances and Interest-bearing Accounts**

Noninterest-bearing cash are funds in the process of being invested. Interest-bearing cash has been placed by participants in money market funds and short-term certificates of deposit. Periodically throughout the year, balances may be in excess of federally insured limits or maintained in money market funds that are not federally insured.

#### **NOTE E - Income Tax Status and Plan Amendments**

Effective January 1, 2023, the Plan has been restated for continued compliance with the regulatory restatement cycle for pre-approved plans under IRS Notice 2017-37. The Internal Revenue Service (IRS) issued an opinion letter dated June 30, 2020, that the plan is acceptable under section 401 of the Internal Revenue Code. The trustees and plan administrator believe the Plan is designed and is currently being operated to be in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan can be subject to examinations by the Internal Revenue Service or the Department of Labor (DOL). These governing agencies have different periods for statutes of limitations. The common statutes are three years for the IRS from date of filing and six years for the DOL. The Plan is not subject to any current examinations.

#### **NOTE F – Investments at Contract Value**

The Plan holds an investment in a single stable value fund which is also referred to as a guaranteed investment contract. The contract allows participants to transfer money into and out of the account without any restrictions. The contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

#### **NOTE G - Risks and Uncertainties**

The Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits. As an ERISA section 404(c) plan, such risk is borne by the participant and not the trustees.

## NOTE H – Investments and Fair Value Measurements

The investments are held by the custodian trustees and certified as described in Note I. The trustee invests plan funds in the manner directed by the participant. The selection of funds from which to choose offers a range of potential returns and corresponding risks.

The Plan’s investments, except for those described in Note F, are reported at fair value in the accompanying statement of net assets available for benefits. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. For the years presented, no Level 2 or 3 inputs are required. There have been no changes in the fair value methodologies used as of December 31, 2024 and 2023. Also, the methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value hierarchy levels used by the Plan are described as follows:

**Level 1** - Inputs to this valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan.

#### **NOTE J - Disclosures Required by ERISA and the Department of Labor**

ERISA and DOL regulations require that supplemental schedules be presented when certain conditions are met. The trustees have determined that the Plan only meets conditions that require a schedule of assets held for investment purposes at the end of year to be presented.

#### **NOTE K - Reconciliation of Financial Statement to Schedule H of Form 5500**

There are currently no reconciling differences. However, as of December 31, 2024, there are \$60,769 loans currently in default beyond the cure period.

#### **NOTE L - Related Parties and Transactions**

The Plan has contracted with T. Rowe Price to provide recordkeeping services along with related companies of Reliance Trust Company to function as outside Trustees for the Plan. Certain Plan investments are in shares of mutual funds or stable contracts managed by T. Rowe Price. These investment transactions qualify as party-in-interest transactions. However, they are not compensated by the plan for the investment management service other than the typical mutual fund fees charged at the fund level, such as 12B-1 fees, or fees charged directly to participants for specific services, see Note B. The mutual fund fees are netted with income at the fund level. The Company generally pays most of the administration costs. All of these transactions are exempt from the prohibited transaction rules of ERISA and the Internal Revenue Code.

#### **NOTE M - Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE N - Insurance and Bonding**

Insurance and bonding requirements are met by general insurance carried by the Company.

#### **NOTE O – Revenue Sharing and Other Income**

The Plan received a total of \$21,132 for revenue sharing and \$424 of other income during the year 2024.
