### Note 1: Description of Plan

The following description of the Hendricks Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Hendricks Holding Company, Inc. covering substantially all employees who, through July 31, 2024, are age 18 or older and have attained three months of service with Participating Employers (collectively the "Employer") who execute a Participation Agreement, however, Blackhawk Transportation, Inc., Blackhawk Logistics, LLC, and BHT Holdings, LLC ("Blackhawk") require six months of service. Effective August 1, 2024, the Plan's eligibility requirement was amended for all participating Employers to remove the three and six month service requirements for employee deferral contributions and implement a six month service requirement for Employer discretionary matching contributions for Blackhawk; the remaining Participating Employers continued to elect safe harbor matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following Participating Employers joined the Plan prior to January 1, 2024:

During 2024, two additional Employers joined the Plan (H7 Capital Management, LLC and Henry Doorbaker) but did not transfer any assets into the Plan.

#### Contributions

Each year, participants may contribute pre-tax or after tax compensation, as defined in the Plan, subject to certain Internal Revenue Service (IRS) regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants direct the investment of their contributions into various investment options offered by the Plan.

Through July 31, 2024, a Participating Employer may make discretionary matching contributions on behalf of each participant who makes salary deferrals during the Plan Year, and may also make discretionary profit sharing and qualified non-elective contributions. Effective August 1, 2024 a Participating Employer (except Blackhawk) may make safe harbor Employer matching contributions equal to 100% of the first 3% of eligible compensation plus 50% of a participant's deferral contribution up to the next 2% of eligible compensation or discretionary Employer matching contributions (subject to the participant working 1,000 hours during the plan year and being employed on the last day of the year). During the year ended December 31, 2024, one Employer, Blackhawk, made discretionary Employer matching contributions equal to 50% of the first 5% of eligible compensation. In addition, all participating Employers may make an additional non-elective discretionary Employer contribution, however none were made during 2024. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's discretionary matching and safe harbor matching contributions (if applicable), as well as allocations of Employer non-elective discretionary contributions (if applicable) and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions plus actual earnings thereon is based on years of continuous service. Through July 31, 2024, participants vest according to the Years of Vesting-Service schedule, specified by each Participating Employer.

Effective August 1, 2024, the Plan's vesting schedule was amended. Participants are immediately vested in the Employer safe harbor matching contributions and Employer nonelective discretionary contributions. Participants become 20% vested in Employer discretionary matching contributions each year over a five year vesting period.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the plan administrator. Interest rates on existing loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments if the account balance is greater than \$5,000 (increased to \$7,000 during 2024 under the SECURE Act 2.0). If the participant's vested account balance does not exceed \$7,000, it can be distributed only in a single lump-sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service distributions are permitted in the event of financial hardship or attainment of age 59½.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Employer before becoming 100% vested in the Employer's contributions. These forfeitures may be used to offset Employer contributions or may be used to pay administrative expenses in accordance with the plan document. At December 31, 2024 and 2023, unallocated forfeitures from nonvested accounts totaled \$9,289 and \$7,797. During the year ended December 31, 2024, \$20,407 of forfeitures were used to reduce Employer contributions.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts "FBRICs"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to benefit payments, the administration of notes receivable from participants, and certain recordkeeping and investment management fees are charged directly to the participant's account and are included in administrative expenses.

#### Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### **Note 4: Fully Benefit-Responsive Investment Contract**

The Plan invests in a FBRIC with Transamerica Life Insurance Company (Transamerica) in the form of a guaranteed investment option that invests in traditional investment contracts. Transamerica maintains the contributions in a general account. The account is credited with earnings on investments and charged for participant withdrawals and administration expenses. The guaranteed investment option fund is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events may limit the ability of the Plan to transact at contract value with Transamerica including plan termination and other events as specified in the guaranteed investment option fund. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

### **Note 5: Information Prepared and Certified by Trustees**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank from December 31, 2023 through July 31, 2024 and State Street Bank and Trust Company from August 1, 2024 through December 31, 2024, the Trustees of the Plan.

### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Certain legal and accounting fees and certain administrative fees relating to the maintenance of employee records are paid by Hendricks Holding Company, Inc. Certain plan investments are managed by Transamerica Life Insurance Company from August 1, 2024 through December 31, 2024 and were managed by Charles Schwab Trust Bank, the Plan's recordkeeper from January 1, 2024 through July 31, 2024. These transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for the recordkeeping, investment management, and audit services were \$226,327 for the year ended December 31, 2024 and are considered party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

### Note 8: Tax Status

The Employer adopted a nonstandard pre-approved document with an Internal Revenue Service notification letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
