## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### 1. Description of Plan

The following description of the Furnitureland South, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Furnitureland South, Inc. and The Design Network, LLC, companies related through common ownership (collectively, the “Company” or “Employer”), who have completed 60 days of service and are age 21 or older, with entry on the first day of the month coinciding with or following the date the eligibility requirements are met . The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Participants may elect to contribute a percentage of their pre-tax and/or after-tax (“Roth”) annual compensation, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 during the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company will make a safe harbor matching contribution equal to 100% of the first 3%, plus 50% of the next 2% of compensation that each participant contributes to the Plan. The Company may also make a discretionary contribution that is determined annually by the Board of Directors. However, no discretionary contributions were made for 2024 or 2023.

Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and Company’s contributions and allocations of plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. As of January 1, 2018, participants are immediately vested in the Company’s safe harbor matching contributions. Vesting in the Company’s matching (prior to January 1, 2018) and discretionary contributions, plus any earnings thereon, is based on years of continuous service according to the following schedule:

### 1. Description of Plan (Concluded)

#### ***Notes Receivable from Participants***

Participants may borrow from the Plan a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are generally up to five years. The notes are secured by the balance in the participant's account and bear interest at rates charged by local lending institutions for similar notes under similar conditions. Principal and interest are primarily paid ratably through direct payments to the custodian, or in some instances through payroll deductions.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, participants may receive a partial distribution, installment payments, or a lump-sum amount equal to the value of their vested account balance. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with plan provisions.

#### ***Forfeitures***

Forfeitures from non-vested participant accounts are used to offset plan expenses or Company contributions. During 2024 and 2023, forfeitures of approximately \$5,800 and \$7,600 were used to offset plan expenses or Company matching contributions. Forfeitures of approximately \$0 and \$4,000 were available at December 31, 2024 and 2023.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including custodian and asset fees, are paid by the Plan. Note receivable and distribution fees are paid out of affected participants' accounts.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through the Guaranteed Return Account.

### 2. Summary of Significant Accounting Policies (Concluded)

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated events occurring subsequent to the date of the financial statements through October 10, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company ("The Standard") and Minnesota Life Insurance Company ("Minnesota Life"), the custodians of the Plan.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Tax Status

The Plan has adopted a prototype plan document sponsored by Minnesota Life. The IRS has determined and informed Minnesota Life by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

All of the Plan's investments are shares of pooled separate accounts and a guaranteed investment contract managed by StanCorp Financial (an affiliate of The Standard) and Minnesota Life, the custodians of the Plan. Fees paid by the Plan to The Standard were approximately \$27,600 for 2024 and \$9,600 for 2024 and 2023. The 2024 fees are net of approximately \$51,700 in other compensation paid to StanCorp Financial as a reduction of earnings.

Fees paid by the Plan to RPA Financial LLC for Plan-level investment advisory services were approximately \$33,700 and \$32,100 for 2024 and 2023.

### 8. Investments at Contract Value

The Plan holds certain benefit-responsive investment contracts with Minnesota Life. Contract value is determined by the issuer and is considered to approximate fair value. Minnesota Life maintains the contributions in a general account, the Guaranteed Return Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Minnesota Life is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.5%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rates as of December 31, 2024 and 2023, are 2.18% and 2.08%.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events limit the ability of the Plan to transact at contract value with the contract issuer. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### 9. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled separate accounts:* These investments are stated at the net asset value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. These investments are classified within Level 2 of the valuation hierarchy.

**9. Fair Value Measurements (Concluded)**

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.



