Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Wilson & Martino Dental, PLLC 401(K) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note A - Description of Plan

General - The Wilson & Martino Dental, PLLC 401(K) Profit Sharing Plan (the Plan), as amended and restated effective January 1, 2021, is a defined contribution plan covering eligible employees of Wilson & Martino Dental, PLLC (the Company). The Plan document is the governing instrument and should be referred to for a full description of the Plan and its provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Employees are eligible to participate upon completion of one year of service and after the attainment of age 18. Employees at the call center and certain doctors as outlined in the provisions of the Plan are not eligible to participate in the Plan.

Employee Contributions – Participants may contribute pre-tax and Roth amounts as defined by the Plan, up to 100% of eligible compensation, in accordance with the Internal Revenue Code section 415 limits. Employees may also elect to make catch-up contributions provided they have reached age 50 by the end of the current calendar year. Participants may also contribute rollovers from other qualified plans. Eligible compensation is defined as wages, tips and other compensation on Form W-2. Eligible compensation is subject to annual limitations prescribed by the IRC.

Employer Contributions – The Company will contribute an ADP Safe Harbor Non-elective contribution in the amount of 3% of each eligible participant's compensation. Participants are immediately 100% vested in this contribution. The Company safe harbor non-elective contribution for the year ended December 31, 2024 amounted to \$203,435.

The Company may contribute a discretionary nonelective profit sharing amount to the Plan. This amount is decided annually by management and is allocated to all participants. The Company profit sharing contribution for the year ended December 31, 2024 amounted to \$113,257.

The Company may also make a discretionary matching contribution equal to a percentage of the employee's elective deferrals, not to exceed 4% of eligible compensation and a qualified nonelective contribution (if necessary to satisfy certain IRC requirements) equal to a percentage of the employee's eligible compensation. There were no discretionary matching contributions made in 2024.

Participants may direct their own contributions, as well as the Company's employer contributions, into any of a number of pooled separate accounts maintained by Voya Retirement Insurance and Annuity Company (the Custodian).

Participant Accounts - Each participant's account is credited with the employee's contribution, the Company's matching and discretionary contributions, Plan earnings, and certain administrative fees, as appropriate.

Vesting - Participants are fully vested in the value of their contributions, as well as employer safe harbor contributions, and qualified nonelective contributions at all times. Participants are vested in the value of employer discretionary nonelective profit sharing and employer discretionary matching contributions as follows:

Forfeitures - Forfeitures, which represent the unvested balances from terminated participants, may be used to reduce Company contributions or pay administrative fees of the Plan. In 2024, forfeitures of \$5,600 were used to reduce employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$844 and \$3,807, respectively.

Notes Receivable from Participants - The Plan does not permit notes receivable from participants.

Benefit Payments - Individual accounts can be distributed upon the death, disability, retirement, or termination of employment of the Plan participant. In-service distributions are also available as long as the participant has attained the age of 59 ½ from accounts that are fully vested. If the participant's account balance is greater than \$5,000, the participant has the option to receive a distribution of their account balance in the form of either a lump-sum distribution, installment payments, or various annuity payments. If the participant's account balance is less than \$5,000, a lump sum payment is the only form of payment. For terminating employees, distributions are mandatory in an amount of \$5,000 or less and participant consent is not required.

Termination - Although there is not a present intent to do so, the Company has reserved the right to terminate or partially terminate the Plan and, upon termination, all participants will become fully vested in any funds which have been allocated to them.

Note B - Summary of Significant Accounting Policies

The financial statements of the Plan have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America. The following are the significant accounting policies followed by the Plan:

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

Contributions - Employee contributions and Company contributions are recognized as additions to Plan assets in the year designated by the employee and Company, respectively.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value (Note E). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the Custodian of the Plan's assets. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments - Benefits are recorded when paid.

Administrative Expenses - All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Employer.

Subsequent Events - Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note C - Tax Status

The Internal Revenue Service has determined by a letter dated June 30, 2020 that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan used to set the guidelines of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), as amended, and the regulations thereunder, and the Plan is thereby tax-exempt within the meaning of Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and to recognize a tax benefit if it is more likely than not the tax position would be sustained upon examination by the applicable authorities. The remainder of the tax position is required to be recorded as a tax liability. The Plan's tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed. The Plan currently has no uncertain tax positions and, therefore, no liabilities have been recorded.

Note D - Investments (Certified)

The investment assets of the Plan, as well as the information contained in the supplemental schedule and the unaudited investment income or loss, including net appreciation (depreciation) and fair value measurements of investments (Note E) have been certified by Voya Retirement Insurance and Annuity Company, the Custodian, as of and for the years ended December 31, 2024 and 2023, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

At December 31, 2024 and 2023, the investments were held by Voya Retirement Insurance and Annuity Company, the Custodian of the Plan, in an annuity contract. Participants may direct their investments into pooled separate accounts. The Plan's investments are stated at fair value. The investment strategies of these pooled separate accounts vary among growth, income, and equity objectives. A prospectus describing each pooled separate account is available from the plan administrator.

Note E - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, “Fair Value Measurements and Disclosures,” establishes a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs into three broad levels. Level 1 inputs are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are quoted prices for similar assets in active markets or inputs that are observable for the asset, either directly or indirectly through market corroboration, for substantially the full term of the asset. Level 3 inputs are unobservable and significant inputs developed by the plan sponsor based on the best information available about the assumptions market participants would use in pricing the asset. A financial asset’s classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used in measuring Plan assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts - Pooled Separate Accounts (PSAs) invest in mutual funds and equity securities. PSAs are valued daily at their accumulation unit value multiplied by number of units held. The accumulation unit value is determined daily based on the net asset value of shares of the underlying fund as provided by the Custodian.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F - Party-in-Interest

The Plan’s assets are invested in pooled separate accounts managed by the Custodian who holds all of the Plan's investment assets in an annuity contract. Additionally, expenses paid by the Plan to the Custodian and third party administrator are party-in-interest transactions. These expenses, relating to transactions fees and administrative services, amounted to \$14,899 for the year ended December 31, 2024.

Note G – Risks and Uncertainties

The Plan provides for various investment options into any number of pooled separate accounts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
