## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the  
Wacker Services Corp 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of the Wacker Services Corp 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ##### *General*

The Plan is a defined contribution plan covering all employees of Wacker Services Corp (the Company) who have completed three months of service, have attained at least 21 years of age, and who are not union employees, nonresident aliens, or leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### *Contributions*

Each year, participants may contribute up to 99% of their annual compensation, as defined by the Plan, as pretax 401(k) contributions and/or after-tax Roth contributions, subject to current statutory limitations. A participant may also make a special non-recurring bonus deferral election, which shall only apply to the participant's bonus payment. Contribution percentages may be changed at any time. Participants may also contribute amounts rolled over from other qualified retirement plans. The Plan includes an automatic enrollment feature whereby all existing and newly hired employees are automatically enrolled in the Plan on the first day of the month coinciding with or next following the meeting of the eligibility requirements, with a contribution of 2% of eligible compensation, unless they affirmatively decline to participate in the Plan or otherwise change the level of contribution. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for fixed employer matching contributions to participants. The Company matches 100% for each elective deferral contribution made by an employee up to the lesser of 4% of annual compensation or \$4,000. For the year ended December 31, 2024, the Company made fixed employer matching contributions of \$329,320 to the Plan. The Plan also provides for discretionary employer profit-sharing contributions to participants. The Company did not make any discretionary employer profit-sharing contributions for the year ended December 31, 2024. All Company contributions are subject to certain IRS limitations.

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses resulting from their participant-directed investments and is charged with an allocation of administrative expenses. Allocations are based on a participant's compensation or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE 1 – DESCRIPTION OF PLAN (Continued)

#### *Vesting*

Participants are immediately vested in their salary deferral contributions (including catch-up) and rollover contributions, plus actual earnings thereon. Vesting in the Company's fixed matching contribution and discretionary profit-sharing contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service as follows:

However, upon death, disability (as defined), or attainment of age 65 while an employee of the Company, participants become 100% vested in their accounts.

#### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Up to two loans per participant may be outstanding at any time. Loan transactions are treated as a transfer between the investment fund and the participant loan fund. The loan repayment period ranges from one to five years; however, the term for loans used to purchase a primary residence may be up to ten years. The loans are collateralized by the participant's account balance and bear interest at 1% over the prime interest rate. Principal and interest are generally paid ratably through monthly payroll deductions. Outstanding loans totaled \$34,611 and \$10,808 as of December 31, 2024 and 2023, respectively. Interest on loans totaled \$1,698 for the year ended December 31, 2024.

#### *Payment of Benefits*

In general, on termination of employment with the Company for any reason, a participant will be entitled to receive a distribution of the total vested amount credited to his or her account under the Plan. All such distributions are made in a lump sum, except that partial withdrawals are permitted for participants who must receive required minimum distributions. If the participant does not elect to receive a distribution, the vested account balance will be distributed after he or she has reached age 65. In-service distributions and hardship withdrawals are also permitted, subject to certain limitations.

#### *Forfeitures*

Forfeitures may be used to either pay administrative expenses of the Plan or to reduce future employer contributions. There were forfeitures of \$148,532 and \$8,374 available at December 31, 2024 and 2023, respectively. No forfeitures were used to reduce employer contributions or pay Plan expenses for the year ended December 31, 2024.

#### NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

##### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the financial statements and related disclosures. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

As of January 1, 2023, the Plan adopted a new accounting standard under U.S. GAAP that replaced the incurred loss model for measuring the allowance for credit losses with a new model that reflects current expected credit losses (CECL) that are expected to occur over the lifetime of the underlying receivable. The CECL methodology is applicable to financial assets that are measured at amortized cost, including notes receivable from participants. The Plan adopted the change in accounting for credit losses using a modified retrospective method which requires recognition of a cumulative effect adjustment, if any, to the opening balance of net assets as of January 1, 2023. The adoption of the new standard did not require a cumulative effect adjustment to net assets as of January 1, 2023.

Loans to participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Related fees are recorded as administrative expenses and charged to expense as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments as required by the Plan, and the Plan administrator deems the participant loan to be in default, the participant loan balance may be reduced and a benefit payment recorded. During 2024, no loan balances were determined to be in default.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding reduction to contributions and net appreciation in fair value of investments.

##### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of loans to participants and participant distributions, if any, are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in investments.

##### *Subsequent Events*

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

#### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 – Inputs include unadjusted quoted prices for either identical or similar assets or liabilities in both active and inactive markets;

Level 2 – Inputs other than quoted prices that are observable for the asset or liability, including inputs derived principally from, or corroborated by, observable market data by correlation or other means; and

Level 3 – Includes valuation methods in which unobservable inputs are used that are significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

Following is a description of the valuation methodologies used for assets. There have been no changes in the methodologies used from December 31, 2023 to December 31, 2024.

Pooled Separate Accounts (PSAs) – Valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). The majority of the underlying net assets have observable Level 1 and/or Level 2 quoted pricing inputs which are used to determine the unit value of the PSA; however, the PSA itself is not publicly quoted. The PSAs held by the Plan provide for daily redemptions at net asset value (NAV) with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments. Since the PSAs are reported at NAV as a practical expedient to estimate fair value, they have not been classified within the fair value hierarchy.

Common/Collective Trust Funds (CCTs) – A fund that is comprised primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments. Since the CCTs are reported at NAV as a practical expedient to estimate fair value, they have not been classified within the fair value hierarchy.

The amounts presented in this table are intended to reconcile the fair value hierarchy table to the amounts presented in the Statement of Net Assets Available for Benefits.

During 2024, the Plan's investments (including investments bought, sold, and held during the year) increased in net value by \$1,365,102, of which \$544,804 was attributable to the Plan's pooled separate accounts and \$820,298 was attributable to the Plan's common/collective trust funds.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY QUALIFIED INSTITUTION

Voya Retirement Insurance and Annuity Company (Voya) was the trustee of all Plan assets as of December 31, 2024. In accordance with Regulation 2520.103-5 of the Department of Labor (DOL), the trustee has provided a certified statement regarding the completeness and accuracy of the investments and investment income (loss). Accordingly, the Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Voya, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplementary schedules.

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Voya.

#### NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During 2024, certain Plan investments were shares of pooled separate accounts and common/collective trust funds managed by Voya. Voya is the trustee as defined by the Plan and, therefore, those transactions qualified as party-in-interest transactions. Voya received a total of \$1,251 of direct compensation from the Plan in 2024. Certain Plan expenses not paid by the Plan are paid by the Company. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain employees of the Company provide administrative and trustee services to the Plan, but receive no compensation from the Plan for such services.

#### NOTE 6 – PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contribution portion of their accounts.

#### NOTE 7 – TAX STATUS

The Plan has adopted a volume submitter plan sponsored by Ascensus LLC. The Internal Revenue Service (IRS) issued an opinion letter stating that the volume submitter plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The volume submitter plan opinion letter has been relied upon by the Plan. The Plan has been amended since the adoption date. The Company believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. For the year ended December 31, 2024, Plan management has determined that there were no material uncertain tax positions. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in process for any tax periods. The Plan administrator believes the Plan is no longer subject to tax examinations for years prior to 2021.

#### NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 9 – DELINQUENT CONTRIBUTIONS

During 2024, certain employee contributions totaling \$37,183 were not remitted to the Plan within the timeframe required by the Department of Labor. The Company is in the process of determining the extent of the lost earnings and excise tax resulting from the delinquent contributions.
