### Note 1 - Plan Description

The following description of Revere Plastics Systems, LLC 401k Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Revere Plastics Systems, LLC (the "Company") who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in January 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during February 2024. The Company has not yet remitted related lost earnings to the Plan.

The Plan provides for safe harbor matching contributions equal to 100 percent of the participant's elective deferrals up to 3 percent of the participant's compensation, plus 50 percent of the participant's elective deferrals that exceed 3 percent of the participant's compensation but do not exceed 4 percent of the employee's compensation.

The Company, at its discretion, may make annual profit-sharing contributions. There were no discretionary contributions made in 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary, safe harbor matching, and rollover contributions and any income or loss thereon. Vesting in the Company's discretionary profit-sharing portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in discretionary profit-sharing contributions made by the Company 40 percent after two years of service and an additional 20 percent per year thereafter until they become fully vested after five years of service.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### **Benefit Payments**

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount or distributions equal to the value of the participant's vested interest in his or her account. If a participant reaches age 59½ and is still an employee of the Company, the participant may withdraw all or a portion of his or her account balance.

## Note 1 - Plan Description (Continued)

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions.

### ***Party-in-interest Transactions***

At December 31, 2024, certain plan assets were in investment funds managed by Fidelity Management Trust Company and The Standard Insurance Company. Fidelity Management Trust Company and The Standard Insurance Company are, collectively, the custodians of the Plan; therefore, these transactions qualify as party-in-interest transaction, as defined under ERISA guidelines.

During the year ended December 31, 2024, prior to the change in custodian to Fidelity Management Trust Company and The Standard Insurance Company, and at December 31, 2023, certain plan assets were in investment funds managed by Nationwide Trust Company, FSB and Nationwide Life Insurance Company or their affiliates. Nationwide Trust Company, FSB and Nationwide Life Insurance Company are, collectively, the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

In addition, the Company paid certain administrative expenses on behalf of the Plan. These transactions, as well as participant notes receivable, also qualify as party-in-interest transactions.

### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

## Note 2 - Summary of Significant Accounting Policies

### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contracts are valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Administrative Expenses***

Various administrative costs are paid by the Company.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 1, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

In 2024, the Plan changed its custodian from Nationwide Trust Company, FSB and Nationwide Life Insurance Company to Fidelity Management Trust Company and The Standard Insurance Company (collectively, the "Custodians"). The Custodians of the Plan held the Plan's investments and executed all investment transactions during the period under audit. The investment balances and related investment results included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians. Additionally, Fidelity Management Trust Company held and executed participant notes receivable and certified the related balances and interest income as of December 31, 2024 and for the period from December 1, 2024 to December 31, 2024.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Note 5 - Fair Value Measurements (Continued)**

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan’s investments:

**Mutual Funds**

Mutual funds are considered Level 1 investments valued at quoted prices reported in active markets.

**Common Collective Trust Fund**

The common collective trust fund is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund’s underlying assets. There are no redemption restrictions or unfunded commitments on this investment.

**Note 6 - Investment Contracts**

The Plan had a benefit-responsive investment contract with Nationwide Life Insurance Company that was terminated in December 2024. The investment contract was liquidated at contract value. Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. During 2024, the Plan entered a benefit-responsive investment contract with The Standard Insurance Company that is reported at contract value. The Standard Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 0.50 percent for the investment contract with Nationwide Life Insurance Company and no less than 1.00 percent for the investment contract with The Standard Insurance Company. When establishing interest crediting rates for this product, Nationwide Life Insurance Company and The Standard Insurance Company consider many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or contract value paid over time in the case of The Standard Insurance Company investment product. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
