We have performed audits of the financial statements of the Tax Deferred Annuity Plan for Employees of Jefferson Regional Medical Center, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Tax Deferred Annuity Plan for Employees of Jefferson Regional Medical Center's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

The following description of the Tax Deferred Annuity Plan for Employees of Jefferson Regional Medical Center (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Jefferson Hospital Association, Inc. (Company) and its related participating employers, including Jefferson Regional Medical Center and Jefferson Management Services Incorporated, for the benefit of its full-time employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Mutual of America Life Insurance Company (Mutual) serves as plan custodian.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make contributions of eligible compensation as defined by the plan document through salary deferrals. Contributions are subject to certain limitations. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. The Plan allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service. Rollover contributions are also permitted. Employer contributions are not allowed by the Plan.

Participant Investment Account Options

The Plan provides participants with options to invest in various investment accounts. Each participant has the option of directing their contributions into any of the separate investments accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participants' contributions and plan earnings and is charged with an allocation of administrative expenses based on the participant's account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon.

Payment of Benefits

Upon termination of service, retirement, or death, participants may elect to receive either a single lump-sum payment in cash, rollover, installments, or an annuity option as elected by the participant. Hardship distributions are allowed subject to the terms of the plan document.

Notes Receivable From Participants and Group Annuity Loans

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. A participant may obtain a loan in an amount no less than \$1,000 and up to the lesser of 50% of their vested account balance or \$50,000. All loans are covered by demand notes and are repayable over a period not to exceed five years except for loans for the purchase of a principal residence. Interest on the loans is based on local prevailing rates as determined by the plan administrator. At December 31, 2024 and 2023, there were no loans outstanding held in the Plan.

Mutual may also issue loans outside of the Plan referred to as group annuity loans. For a group annuity loan, the amount borrowed is secured and reserved against the participant's accrued benefit invested in the Interest Accumulation Account (IAA) held by the Plan. Principal payments are applied to reduce the amount secured and

reserved by assets held in the IAA, and a portion of the interest paid by the participant is retained by Mutual as compensation. The interest rate is variable and subject to change at the beginning of each quarter. At December 31, 2024 and 2023, group annuity loans outstanding held outside of the Plan were \$870. The amount pledged as collateral for the group annuity loans was \$1,044 at December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. General unallocated and pooled separate account funds are valued at estimated fair value as provided by Mutual.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans may be reclassified as distributions upon the terms of the plan document.

Group annuity loans obtained directly from Mutual are not deducted from the participant's account balance and, therefore, do not appear in the accompanying statements of net assets available for benefits. The loan proceeds come directly from Mutual's general assets (see Note 1, Notes Receivable From Participants and Group Annuity Loans) and are held outside of the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the accompanying statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are managed by the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. The Company provides certain administrative services at no cost to the Plan.

Group annuity loans are held outside of the Plan by Mutual. Principal payments are applied to reduce the amount secured and reserved by assets held in the IAA, and a portion of the interest paid by the participant is retained by Mutual as compensation (see *Note 1, Notes Receivable From Participants and Group Annuity Loans*).

Note 6. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 8. Tax Status

The Plan is intended to be a tax-sheltered plan under Section 403(b) of the Internal Revenue Code (IRC) of 1986, as amended. The Plan has not requested or obtained a determination letter, as the Internal Revenue Service does not currently provide that service for 403(b) plans. However, the plan administrator believes that the Plan is currently designed and being operating in compliance with the applicable requirements of the IRC and not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

Note 1. Description of Plan

The following description of the Tax Deferred Annuity Plan for Employees of Jefferson Regional Medical Center (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Jefferson Hospital Association, Inc. (Company) and its related participating employers, including Jefferson Regional Medical Center and Jefferson Management Services Incorporated, for the benefit of its full-time employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Mutual of America Life Insurance Company (Mutual) serves as plan custodian.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make contributions of eligible compensation as defined by the plan document through salary deferrals. Contributions are subject to certain limitations. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. The Plan allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service. Rollover contributions are also permitted. Employer contributions are not allowed by the Plan.

Participant Investment Account Options

The Plan provides participants with options to invest in various investment accounts. Each participant has the option of directing their contributions into any of the separate investments accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participants' contributions and plan earnings and is charged with an allocation of administrative expenses based on the participant's account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon.

Payment of Benefits

Upon termination of service, retirement, or death, participants may elect to receive either a single lump-sum payment in cash, rollover, installments, or an annuity option as elected by the participant. Hardship distributions are allowed subject to the terms of the plan document.

Notes Receivable From Participants and Group Annuity Loans

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. A participant may obtain a loan in an amount no less than \$1,000 and up to the lesser of 50% of their vested account balance or \$50,000. All loans are covered by demand notes and are repayable over a period not to exceed five years except for loans for the purchase of a principal residence. Interest on the loans is based on local prevailing rates as determined by the plan administrator. At December 31, 2024 and 2023, there were no loans outstanding held in the Plan.

Mutual may also issue loans outside of the Plan referred to as group annuity loans. For a group annuity loan, the amount borrowed is secured and reserved against the participant's accrued benefit invested in the Interest Accumulation Account (IAA) held by the Plan. Principal payments are applied to reduce the amount secured and

reserved by assets held in the IAA, and a portion of the interest paid by the participant is retained by Mutual as compensation. The interest rate is variable and subject to change at the beginning of each quarter. At December 31, 2024 and 2023, group annuity loans outstanding held outside of the Plan were \$870. The amount pledged as collateral for the group annuity loans was \$1,044 at December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. General unallocated and pooled separate account funds are valued at estimated fair value as provided by Mutual.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans may be reclassified as distributions upon the terms of the plan document.

Group annuity loans obtained directly from Mutual are not deducted from the participant's account balance and, therefore, do not appear in the accompanying statements of net assets available for benefits. The loan proceeds come directly from Mutual's general assets (see Note 1, Notes Receivable From Participants and Group Annuity Loans) and are held outside of the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the accompanying statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are managed by the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. The Company provides certain administrative services at no cost to the Plan.

Group annuity loans are held outside of the Plan by Mutual. Principal payments are applied to reduce the amount secured and reserved by assets held in the IAA, and a portion of the interest paid by the participant is retained by Mutual as compensation (see *Note 1, Notes Receivable From Participants and Group Annuity Loans*).

Note 6. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 8. Tax Status

The Plan is intended to be a tax-sheltered plan under Section 403(b) of the Internal Revenue Code (IRC) of 1986, as amended. The Plan has not requested or obtained a determination letter, as the Internal Revenue Service does not currently provide that service for 403(b) plans. However, the plan administrator believes that the Plan is currently designed and being operating in compliance with the applicable requirements of the IRC and not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
