General: The Plan is a defined contribution plan available to all eligible employees who are age twenty-one or older, have completed one year of service of at least 1,000 hours, and are not members of a collective bargaining agreement, a nonresident alien or a leased employee, as defined by the Plan agreement. The participating employers of the plan include Christy Sports, LLC and Ski PNW LLC (collectively, the "Company" or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrative Committee is responsible for oversight of the Plan, and, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's executive team.

Contributions: Participants may contribute up to 100% of their pre-tax annual compensation and after-tax Roth 401(k) contributions subject to IRS limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollover) including designated Roth 401(k) accounts. Participants who are age 50 before the end of the Plan year are eligible to make catch-up contributions.

For the Plan year ended December 31, 2024, the Company made an ADP Safe Harbor (Safe Harbor) contribution to the account of each participating employee equal to 1) 100% of the amount of the employee's elective deferrals that do not exceed 3% of the employee's compensation, plus 2) 50% of the amount of the employee's elective deferrals that exceed 3% of the employee's compensation, but does not exceed 5% of the employee's compensation.

The Company may make an annual discretionary profit-sharing contribution to the Plan in an amount to be determined at Plan year end by the Company's Board of Directors. No such profit-sharing contribution was made for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's Safe Harbor contributions and discretionary profit sharing contributions, if any, (b) Plan earnings or losses, and (c) forfeitures of Company discretionary profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions and the Company's ADP Safe Harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portions of their account, plus actual earnings, thereon, are based on years of continuous service. A participant is 100% vested after six years of credited service.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits: Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump sum cash distribution or a direct rollover distribution to another qualified retirement plan or to an individual retirement account, in an amount equal to the value of the participant's vested interest in his or her account. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Loans: Loans are not permitted under the Plan.

Forfeitures: Forfeitures represent the portion of the Company's discretionary profit-sharing contributions that is lost by a participant who terminates employment prior to becoming fully vested under the Plan's vesting schedule. At December 31, 2024 and 2023, forfeited non-vested accounts were not significant. Forfeitures are used to offset future Company contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company's discretionary contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date in the Plan's principal or most advantageous market for the asset or liability. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments. There were no changes in the methodologies used at December 31, 2024 and 2023.

Interest Bearing Cash, Money Market Fund - The fair value of the money market fund investment is based upon the closing net asset value per share of the fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Mutual Funds - The fair values of mutual fund investments are based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Ascensus, LLC and Ascensus Trust Company are service providers to the Plan and, therefore, the Plan's payment of fees to these entities qualify as party-in-interest transactions. UBS Financial Services, Inc. provides investment management services to the Plan and therefore, the Plan's payment of fees to this entity qualifies as party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated January 1, 2018, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended from the original prototype document; however, plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE 6 – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued. There are no significant events subsequent to December 31, 2024 that require disclosure.
