Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of EMA 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefit as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1: PLAN DESCRIPTION

The following description of the EMA 401(k) Retirement Plan (formerly known as EMA Group, Inc. Profit Sharing Plan) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan with a 401(k) provision covering all employees except those who are: covered by a collective bargaining agreement; nonresident aliens who receive no earned income from sources within the United States; or leased employees.

Employees shall be eligible to participate in employer discretionary profit sharing and/or matching contributions as of the first day of the Plan Year provided that with certain exceptions, they complete at least 1,000 hours of service and are employed on the last day of the Plan Year.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute a certain percentage of compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may also make rollover contributions from other qualified plans, including rollovers of diversification transfers from the EMA Group, Inc. Employee Stock Ownership Plan. The Plan provides for automatic salary deferrals of 6% for all employees who become eligible and do not make a contrary salary Reduction Agreement election. Each April 1st the Plan provides for automatic increases of 1% annually up to 15% unless the employee makes a contrary salary Reduction Agreement election.

Each year, the Company Board of Directors determines an amount, if any, of a discretionary profit sharing and/or matching contribution to the Plan. Discretionary profit sharing contributions are allocated to participants based on relative compensation. No Company discretionary profit sharing and/or matching contributions were made to the Plan for the years ended December 31, 2024 and 2023. Total plan contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, forfeitures, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account balance.

NOTE 1: PLAN DESCRIPTION (Continued)

Vesting and Forfeitures

Participants are immediately 100% vested in any salary deferral contributions, diversification transfers from EMA Group, Inc. Employee Stock Ownership Plan, and related earnings. Participants vest in the Company's discretionary profit sharing and/or matching contributions and related earnings based on years of service and become 100% vested after five years of service. If an employee dies or becomes disabled while employed by the employer, the employee will become 100% vested in the Company's discretionary profit sharing and/or matching contributions. Forfeitures are first used to pay expenses of the Plan, then are allocated to participants. Forfeitures are allocated to eligible participants in a manner similar to contributions.

Investment Options

Participants direct the investment of contributions among numerous investment funds. Each fund has a different investment objective. Participants may change their investment choices daily.

Notes Receivable for Participants

Participants may borrow from their investment account balances amounts from a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan Fund. Loan terms could range up to 5 years or up to the lesser of 15 years or the repayment period currently in effect for a commercial home loan for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination, participants with vested account balances exceeding \$5,000 may elect to receive a distribution of their entire vested balance as soon as administratively possible or may receive it at a future date subject to certain minimum distribution rules. Participants may elect to receive installment payments. Participant vested account balances less than \$5,000 will be distributed as soon as administratively possible after termination. The Plan does allow in-service distributions in some circumstances. Certain minimum distribution rules apply as defined by the Plan.

Administration Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies of the Plan are summarized below to assist the reader in reviewing the financial statements.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contribution Payable

Excess contributions payable are recorded for refunds to participants resulting from contributions made in excess of amounts allowable as defined in the Plan document and set forth in Internal Revenue Service regulations.

Subsequent Events

The Company evaluated for the occurrence of subsequent events through October 14, 2025, the date which the financial statements were available for issue.

NOTE 4: FAIR VALUE OF FINANCIAL INVESTMENTS

U.S. generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4: FAIR VALUE OF FINANCIAL INVESTMENTS (Continued)

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered Investment Companies: These investments are public investment securities valued using the Net Asset Value (NAV). The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

Pooled Separate Accounts: These investments are investment securities valued using the NAV provided by Principal Life Insurance Company. The pooled separate accounts generally provide for daily redemptions at reported net asset values per share, with no advance notice requirements. The NAV is quoted on a private market that is not active. The unit price is based on underlying investments which are traded on active market with quoted market prices and investments not traded on active markets in which various methodologies and unobservable inputs are used to determine fair value.

Principal Trust Company Target Date (common collective trust): Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the market value of the underlying investments held by the fund less liabilities. The practical expedient is not used when it is determined that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a fixed income guaranteed option account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The fixed income guaranteed option account is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0 percent. The crediting rate is reviewed on a quarterly basis for resetting. The declared interest rate at December 31, 2024 was 4.75%.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

NOTE 7: CONCENTRATIONS

The Plan had two funds whose cumulative balances accounted for approximately 43% of total plan investments at December 31, 2024. The Plan had two funds whose cumulative balances accounted for approximately 38% of total plan investments at December 31, 2023.

NOTE 8: TAX STATUS

The Plan was restated as of February 18, 2022 using Principal Financial Group's preapproved plan. The preapproved plan received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service has to the plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan sponsor and administrator believe the Plan is designed and is being cooperated in compliance with the applicable provisions of the Internal Revenue Code therefore, believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

NOTE 9: PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Certain plan investments represent shares of collective trust, registered investment, and guaranteed interest funds managed by the trustee. These transactions are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to Principal Trust Company amounted to \$2,196 and \$2,091 for the year ended December 31, 2024 and 2023, respectively. No fees were due to Principal Trust Company at December 31, 2024 and 2023.

NOTE 10: RISKS AND UNCERTAINTIES

Investment securities are exposed to various risks including but not limited to, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible the changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
