**1. Plan Description**

The following description of Laing Companies Cash Balance Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan Administrator oversees the governance of the Plan. The Plan was effective on January 1, 2024.

**General**

The Plan is a non-contributory defined benefit cash balance plan sponsored by Eugene Welders Supply Co. (the Employer) to provide retirement benefits for eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate in the Plan upon completing one year of service, defined as at least 1,000 hours worked within a 12-month period. There are no age requirements for eligibility. The following categories of employees are excluded from participation: union employees, leased employees, non-resident aliens, and individuals classified as part-time, temporary, or seasonal. Eligible participants enter the Plan January 1 or July 1 after meeting the eligibility requirements.

**Contributions and Funding Policy**

The Plan is funded solely by the Employer. The Plan's funding policy is to make contributions to the Plan that are available for deduction under the Internal Revenue Code and meet the minimum funding requirements as determined by an independent actuary. The Plan has met the minimum funding requirements of ERISA for the Plan year ended December 31, 2024. A participant's principal credit allocation is made annually on the first day of each Plan Year, with eligible participants in Group 1 and Group 2 receiving a principal credit equal to 29% of annual Plan Compensation up to \$100,000, and participants in Group 3 receiving 2.5% of annual Plan Compensation. Participants must have at least 1,000 hours of service to receive a principal credit allocation.

**Participant Accounts**

Under the Plan provisions, amounts are credited by the Employer to the participants' hypothetical accounts. The accounts are allocated principal credits and interest credits each Plan year. The principal credits are allocated based on a percentage of the participants' compensation as defined in the plan document. Hypothetical account balances earn interest credits annually at a fixed rate of 5%.

**Vesting and Forfeitures**

Participants are 100% vested if they were employed on or before December 31, 2024. For participants employed on or after January 1, 2025, vesting in the participant's accrued benefit is as follows:

**Vesting and Forfeitures**, continued

Participants who terminate employment due to death or disability, or who reach normal retirement age, become fully vested in their retirement benefit.

Forfeitures represent the non-vested portion of a participant's account. These amounts may be used to pay Plan administrative expenses or offset future Employer contributions. There were no forfeitures in 2024.

**Benefits**

Benefits are determined based on the participants' hypothetical account balances. Upon attainment of Normal Retirement Age (age 62) or termination of employment, the annual benefit accrual is equal to the greater of (1) the Principal Credits earned for such Plan Year or (2) the actuarial adjustment required for the Plan Year. Benefit distributions generally commence as soon as administratively practicable following termination of employment. In the event of death, distributions reflect the participant's vested present value of accrued benefits, including applicable life insurance proceeds less the cash surrender value.

Distributions may be made in the form of a single-life annuity, joint and survivor annuity (50% or 75%), or a lump sum equal to the vested hypothetical account balance. For participants with account balances less than \$5,000, the Plan may automatically distribute the benefit as a lump sum, consistent with consent requirements for Qualified Joint and Survivor Annuities.

The maximum annual benefit under the Plan is limited to the lesser of \$280,000 or the participant's three-year average compensation, in accordance with applicable regulatory limitations. If benefit payments begin after age 65, the maximum benefit may be subject to actuarial increase.

Required beginning dates for benefit distributions are determined based on ownership status in the Plan and date of birth. Benefits must commence no later than April 1 following the calendar year in which the participant reaches age 70.5 (for those born before July 1, 1949), age 72 (for those born between July 1, 1949 and December 31, 1950), age 73 (for those born between January 1, 1951 and December 31, 1959) and age 75 (for those born on January 1, 1960 and after). For participants other than those who are 5% or greater owners, benefit distributions may also begin the calendar year in which the participant retires.

**Administrative Expenses**

At the Employer's discretion, expenses of the Plan may be paid either directly by the Employer or by the Plan. No expenses were incurred by the plan in 2024. Any expenses paid by the Employer are excluded from these financial statements.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid.

**3. Risks and Uncertainties**

Plan contributions are determined and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**4. Actuarial Present Value of Accumulated Plan Benefits**

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the services employees have rendered. Accumulated Plan benefits include benefits expected to be paid to the following: (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of deceased employees, and (c) present employees or their beneficiaries. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included to the extent that they are deemed attributable to employee service rendered through the valuation date.

The actuarial present value of accumulated Plan benefits is determined by the Plan's actuary, Prime Retirement Solutions, LLC. The actuarial present value of accumulated Plan benefits is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant assumptions underlying the actuarial computations were as follows. The plan did not have any other activity, aside from Employer receivables, therefore, some actuarial computations and related assumptions are not applicable and are excluded from the notes.

*Actuarial Value of Assets:* Determined using the fair value method. No asset smoothing techniques or valuation corridors were applied.

*Funding Target Discount Rates:* Split into three segments. Segment 1 is discounted at 5.01%; Segment 2 is discounted at 5.26%; Segment 3 is discounted at 5.59%.

*Funding Interest Crediting Rate:* 5%.

As required in the Worker, Retiree, and Employer Recovery Act of 2008, the target normal cost is increased by expenses expected to be paid from Plan assets.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan was to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

**5. Plan Termination**

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years or that employees eligible to retire for that 3-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under provisions of the Plan in effect at any time during the five years preceding the termination of the Plan.
- b. Other vested benefits insured by PBGC (a U.S. government agency) up to the applicable limitations (as discussed below).
- c. All other vested benefits (that is, vested benefits not insured by PBGC).
- d. All non-vested benefits.

Certain benefits under the Plan are insured by PBGC if the Plan terminates. Generally, PBGC guarantees most vested normal-age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, PBGC does not guarantee all types of benefits under the Plan and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed by PBGC at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit PBGC guarantees.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Employer, the level of benefits guaranteed by PBGC, and the financial condition of PBGC.

**6. Income Tax Status**

The IRS has issued an opinion and informed Prime Retirement Solutions, LLC, the sponsor of the non-standardized pre-approved defined benefit plan, by a letter dated May 31, 2023, that the Plan effective January 1, 2024, was properly qualified, indicating that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in process.

**7. Subsequent Events**

Plan management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
