### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the LARSEN MANUFACTURING, LLC 401(K) PROFIT SHARING PLAN AND TRUST (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1—PLAN DESCRIPTION**

The following description of the Larsen Manufacturing, LLC (the Company) 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was restated effective January 1, 2022.

**GENERAL**

The Plan is a defined contribution plan covering substantially all employees who are at least 21 years old and have completed one year of service, except those covered by a collective bargaining agreement and non-resident aliens. An eligible employee will become a participant on the first day of the quarter following the satisfaction of the aforementioned requirements. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). The Plan includes an income deferral option which qualifies under Section 401(k) of the Internal Revenue Code (IRC) and a safe harbor non-elective contribution feature.

The Company acquired the assets of Tella Tool & Manufacturing Co. on December 16, 2022. Effective January 31, 2023, years of service for the acquired employees will be based on their original hire date with Tella Tool & Manufacturing Co.

**CONTRIBUTIONS**

Participants may choose to make pre-tax deferrals up to 100% of their compensation, to a maximum of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023. Participants over the age of 50 may elect to contribute additional funds up to the annual "catch-up" contribution limit of \$7,500 for each of the years ended December 31, 2024 and 2023. Roth deferrals are also permitted, effective April 15, 2022.

The Plan may also accept rollover contributions made on behalf of any eligible employee, regardless of whether the employee has met the age and service requirements of the Plan.

The Company may elect to make a safe harbor contribution to the Plan at the end of each Plan year equal to 3% of eligible compensation to all employees who were eligible to make elective deferrals during the Plan year. The Company elected to make safe harbor contributions in the amounts of \$388,195 and \$361,174 for the years ended December 31, 2024 and 2023.

The Company may make discretionary matching contributions for those participants that made elective deferrals for the Plan year. There were no discretionary matching contributions for the years ended December 31, 2024 and 2023.

The Company may also elect to make a discretionary profit-sharing contribution for those participants who completed at least 1,000 hours of service during the Plan year and were employed by the Company on the last day of the Plan year. The Company did not elect to make a discretionary profit-sharing contribution for the years ended December 31, 2024 and 2023.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings, net of fees. Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

**NOTE 1—PLAN DESCRIPTION (Continued)**

**VESTING**

Participants are 100% vested in their voluntary contributions, rollover contributions and Company safe harbor contributions plus actual earnings thereon. Participants' vesting in the Company's matching and profit-sharing contributions, plus actual earnings thereon, is determined in accordance with a schedule based on the participant's years of service. A participant is 100% vested after the completion of six years of vesting service.

Employees from the Tella Tool & Manufacturing Co. acquisition who were hired by July 1, 2022, will be fully vested in all Plan accounts.

**FORFEITED ACCOUNTS**

Forfeited non-vested accounts totaled \$22,113 and \$-0- at December 31, 2024 and 2023. Forfeitures of non-vested amounts are used to reduce future Company contributions and/or to reduce Plan expenses. No forfeitures were utilized to pay Plan expenses for the years ended December 31, 2024 and 2023. Forfeitures in the amount of \$-0- and \$46,859 were used to fund Company contributions during the years ended December 31, 2024 and 2023.

**PARTICIPANT LOANS**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Repayments of principal and interest are made in equal installments over the specified loan period through regular payroll deductions. Loan terms range from 1-5 years except loans for the purchase of a primary residence, which may be up to 15 years. The loans are secured by the vested balance in the participant's account. The interest rate charged is computed based on the prime rate in effect at the time the loan is issued plus 2% and is fixed over the life of the loan.

**PAYMENT OF BENEFITS**

If a participant becomes entitled to receive a benefit for any reason other than death, their account will be distributed from the Plan in a lump sum payment. Partial or installment distributions may be permitted if needed to satisfy the required minimum distribution rules. Participants may receive hardship distributions from the vested portions of their accounts should they have an immediate and heavy financial need when they lack other available resources.

Effective November 1, 2024, vested balances of terminated participants that do not exceed \$7,000 are subject to force-out distributions from the Plan. Participants may elect to receive the distribution in cash or roll over the distribution to an individual retirement account. If election forms are not returned by the participant in a timely manner, the following will apply: If the participant's vested balance is more than \$-0-, the Plan Administrator will transfer the balance to an IRA established in the participant's name. The consent of the terminated participant is needed to initiate a distribution for vested balances over \$7,000 unless the distribution is required under federal law.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**ADMINISTRATIVE EXPENSES**

The significant administrative expenses of the Plan are paid by the Company.

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared under the accrual method of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

At December 31, 2024 and 2023, the Plan's investments were held by its trustee, Ameritas Life Insurance Corp. (Ameritas).

All investments, except for money market funds which are valued at net asset value (NAV), are valued at fair value as of December 31, 2024 and 2023.

Cash surrender value of life insurance as of December 31, 2024 and 2023 was determined by Ameritas.

Purchases and sales of securities are reflected on a trade-date basis. Realized gains and losses on the sale of securities are computed on a specific identification basis.

Dividend and interest income are recognized when received. Differences between that method and the accrual method are immaterial. Net appreciation on investments held represents the change in fair value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year. Net appreciation on life insurance represents the change in the cash surrender value of the policies from the beginning of the Plan year (or date the policies were purchased, if later) to the end of the Plan year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are valued at unpaid balances which approximate fair value. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**BENEFITS**

Benefit payments to participants are recorded when paid.

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted NAV of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements*

Such instruments are not applicable to the Plan as of and for the years ended December 31, 2024 and 2023.

*Level 3 Fair Value Measurements*

Life insurance policies are valued at the cash surrender value of the individual policies.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes that the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

However, withdrawals prompted by certain events (e.g., termination of the managed income portfolio, changes in laws and regulations) may restrict a participant’s ability to redeem the investment at its NAV.

**NOTE 4—INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES**

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 6—TAX STATUS**

The Plan has adopted the CCH Incorporated Non-Standardized Pre-Approved Profit Sharing Plan with CODA. Such CCH plan obtained its latest opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, in which the IRS stated that the form of the Plan is acceptable for use by employers for the benefit of their employees under IRC Section 401. The Plan has been amended since receiving the letter. The Company has not applied for its own determination letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7—PARTY-IN-INTEREST TRANSACTIONS**

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. In addition, the majority of expenses of the Plan are paid by the Company, except loan fees which are paid by the borrowing participants.

The Plan's investments are managed by Ameritas. The Plan's third-party administrator is Shore Tompkins, Inc. These companies are considered to be parties-in-interest.

None of the transactions with parties-in-interest were prohibited by the Department of Labor.

**NOTE 8—SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 9, 2025, the date which the financial statements were available for issuance. There were no subsequent events which require disclosure in the financial statements.
