The Plan is a participant-directed, defined contribution 401(k) plan, which covers all eligible employees of H & M Fashion USA, Inc. previously known as H & M Hennes & Mauritz, LP (Plan Sponsor or Employer) who elect to participate, excluding employees covered by a collective-bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Voya Retirement Insurance and Annuity Company (Voya) serves as the investment custodian and recordkeeper of the Plan.

#### *Eligibility Requirements*

All employees who are not excluded employees, as defined by the Plan document, are eligible to participate in the Plan on the first day they attain 12 months of service, with at least 1,000 hours of service and the attainment of age 21.

#### *Plan Contributions*

Each year, participants may contribute any amount of their eligible compensation, not to exceed the federal limitation, as defined in the Plan. Effective January 1, 2024, the Plan also allows for Roth contributions. Participants also may contribute amounts representing distributions from other qualified plans (rollover).

Participants direct the investment of their contributions into various options offered by the Plan. The Plan operates as a traditional safe harbor 401(k) plan. For every dollar contributed by participants, the Employer makes matching contributions of 100% up to the first 3% of eligible compensation plus 50% of the amount that exceeds 3% of eligible compensation, but not to exceed 5% of eligible compensation. Participant contributions will automatically cease when the participant reaches the federal limitation in any calendar year. Participants who attain age 50 before the close of the Plan year are eligible to make catch-up contributions, as defined in the Plan.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions, as well as allocations of Plan earnings, and charged for withdrawal-related fees. Participant accounts are charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are at all times 100% vested in their account balance, including any earnings thereon.

### ***Payment of Benefits***

Employees participating in the Plan are eligible to receive a benefit, without penalty, upon suffering a hardship or after reaching age 59½, equal to the amount in their individual account. Employees may elect to receive the value of their account as a lump-sum distribution, in substantially equal installment payments over a ten-year period, or in partial withdrawals upon retirement, death, disability, or termination of services, as defined.

### ***Cash-Outs of Accounts and Consent to Distribution***

If the value of a participant's vested interest in their account is \$7,000 or less, the participant's account will be cashed out by distributing the participant's vested interest by a single-sum payment, or by direct rollover to an individual retirement account or other eligible retirement plan as soon as reasonably practicable following the date the participant's employment terminates. The participant's account will be cashed out even if the participant does not consent to the distribution. If the value of the participant's vested interest is more than \$7,000, distribution of the account balance cannot be made before the participant's normal retirement date without the participant's written consent.

### ***Notes Receivable from Participants***

Participants are eligible to borrow from their vested accounts in accordance with the Plan provisions. The participant loans are secured by the balance in each participant's account and bear interest at a fixed rate, determined at the time of borrowing and fixed for the life of the loan. The minimum amount that may be borrowed is \$1,000. The maximum amount that may be borrowed is 50% of the participant's vested account balance or \$50,000, whichever is less. Only one loan may be granted during any one-year period. Only one loan may be outstanding at a time. Principal, interest, and a loan administration charge are paid through payroll deductions. The loan is repaid over a 30-year period if the loan is for the purchase of a home, or over a five-year period for all other reasons. Interest rates on loans shall be the prime rate plus 2% at the time the loan is granted. Upon employee termination prior to the loan balance being repaid, participants will be provided the option to repay the loan balance, or to recognize the balance as income subject to applicable penalty taxes.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### *Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

### *Notes Receivable from Participants*

Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. Defaulted notes are recorded as benefit payments according to the terms of the Plan document. Fees charged by the custodian relating to notes receivable from participants are paid from the related participants' accounts.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to each participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

## **3. Risks and Uncertainties**

The Plan holds investments that potentially subject the Plan to concentrations of risk, such as investments of the Plan's trustee. The Plan provides for various investment securities, which include investments in any combination of pooled separate accounts and a guaranteed annuity contract. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Plan's financial statements. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

### 4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

### 5. Fair Value Measurement

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed, based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies of these items held at December 31, 2024 and 2023.

*Pooled Separate Accounts* - These are valued at their accumulation unit value (AUV) as a practical expedient, which approximates fair value. The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund, the fund's dividends, and the separate account charges (i.e., the daily asset charge). The underlying investments of the pooled separate accounts consist of various registered investment companies whose investment strategies are to seek capital appreciation through investment in common and preferred stocks and debt securities. The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods, and no unfunded commitments.

*Guaranteed Annuity Contract* - This is reported at fair value, which approximates contract value. The fair value equals accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals and fees. The guaranteed annuity contract is not deemed to be a fully benefit-responsive contract.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Party-in-Interest Transactions

Certain investments are issued and managed by Voya. Any purchases and sales transactions of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants and administrative fees paid also qualify as exempt party-in-interest transactions.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to amend or discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, each participant will continue to be 100% vested.

The Plan Sponsor may reduce or suspend Employer matching safe harbor contributions upon satisfaction of certain requirements, including a 30-day advance notice to all eligible employees.

### 8. Tax Status

The Plan adopted Voya's non-standardized 401(k) profit-sharing plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (Code), and that any employer adopting the prototype non-standardized plan is considered to have a qualified plan under the Code and qualify as exempt from taxation. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Subsequent Events

Plan management evaluated the accompanying financial statements for subsequent events through October 14, 2025 and transactions on the date these financial statements were available for issue and has determined that no material subsequent events have occurred that would affect the information presented in the accompanying financial statements or require additional disclosure.
