We have performed audits of the accompanying financial statements of Central Vermont Medical Center Employees Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits in liquidation as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits in liquidation for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

As a result, the accompanying financial statements for the years ended December 31, 2024 and 2023 are prepared on the liquidation basis of accounting. Our opinion is not modified with respect to this matter. As of December 31, 2024, the Plan no longer exists.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### **(1) Description of the Plan**

The following description of the Central Vermont Medical Center Employees Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### ***(a) General***

The Plan was a noncontributory defined benefit pension plan covering eligible employees of Central Vermont Medical Center, Inc. (the “Company” or “Plan Sponsor”). It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2012, the Plan was amended and frozen for employees who were not active participants in the Plan on December 31, 2011, or for any employee who on January 1, 2012, is less than 50 years of age, or for any employee whose date of hire or rehire is on or after January 1, 2012.

Effective December 31, 2022, Porter Medical Center Pension Plan merged into the Plan. On that same date, the Plan elected to terminate. All accrued benefits were liquidated from this Plan over the following 18 month period from December 31, 2023. During 2024 the Plan was annuitized and remaining funds were transferred to Nationwide Life Insurance Company.

#### ***(b) Pension Benefits***

Prior to the freeze, employees with five or more years of service and who were fully vested were entitled to annual pension benefits at normal retirement age (65), or if age 60 with 30 years of service, equal to 1.2% of their final average salary for each year of participation up to 35 years. The final average salary was based on the participant’s annual earnings during the highest five complete calendar years of the participant’s career.

The Plan permitted early retirement at age 55. However, there was a 4% per year early retirement reduction. If employees terminated before rendering five years of service, they forfeited the right to receive their accrued benefits. In general, employees would have receive their benefits as a life annuity payable monthly from date of retirement or as a lump-sum distribution if the actuarial value of the benefit was less than \$5,000; however, employees, if married, would have received their pension benefits in the form of a joint and survivor annuity (unless the spouse signed a waiver).

The amount of a pre-retirement survivor annuity a spouse would have received was equal to 50% of the amount an employee would have received as a qualified joint and survivor annuity. However, for the first sixty months after an employee’s death, a spouse would have also received an additional monthly benefit called a regular death benefit, which was equal to the difference between an employee’s monthly accrued benefit and the pre-retirement survivor annuity. After sixty months, the regular death benefit would have stopped, but a spouse would have continued to receive the pre-retirement survivor annuity.

## **Description of the Plan (continued)**

Due to Plan liquidation, the Plan Sponsor sent election kits to participants in September 2023 providing participants the options to either 1) obtain a lump sum cash withdrawal, or 2) rollover to another retirement account. In December 2023, the Plan executed lump sum payments based on election forms from participants. TransAmerica continued to make annuity payments throughout 2023 and 2024 when annuity distributions were annuitized with Nationwide Life Insurance Company.

## **(2) Summary of Significant Accounting Policies**

### ***(a) Basis of Accounting***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Effective January 1, 2022, the financial statements are prepared on the liquidation basis of accounting.

### ***(b) Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities.

### ***(c) Investment Valuation and Income Recognition***

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Change in value of investments was reflected in the statements of changes in net assets available for plan benefits in liquidation and included realized gains and losses on investments bought and sold and the change in unrealized gains (losses) from one period to the next. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Acquisition costs were included in the cost of investments purchased, and sales were recorded net of selling expenses.

### ***(d) Administrative Expenses***

Expenses of administering the Plan, such as Pension Benefit Guaranty Corporation (PBGC) premiums, investment advisory fees, accounting and actuarial fees, and management fees, were paid from Plan assets. All other administrative fees of the Plan were paid by the Plan Sponsor. Administrative fees paid by the Plan Sponsor were excluded from these financial statements.

#### *(e) Payment of Benefits*

Benefits were recorded when paid.

#### *(f) Subsequent Events*

The Plan evaluated subsequent events through August 19, 2025, the date the Plan's financial statements were available to be issued.

### **(3) Information Certified by the Plan's Trustees**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company and The Northern Trust Company, trustees of the Plan, have certified as being complete and accurate the investments on the statements of net assets available for plan benefits in liquidation as of December 31, 2024 and 2023 and the investment activity reflected in the statements of changes in net assets available for plan benefits in liquidation for the years then ended. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's trustees.

### **(4) Fair Value Measurements**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual and money market funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Fixed income – bonds:* Valued based on recent trading activity and other observable information, including but not limited to market interest rate curves, referenced credit spreads and estimated prepayment rates where applicable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's investments were held in the UVM Health Network Master Trust, ("UVMHN Trust"), which was established in 2018 for the investment of assets of the Plan and several other UVM Health Network Hospital's sponsored retirement plans. Each participating retirement plan has an individual interest in the UVMHN Trust. The assets of the UVMHN Trust were held by The Northern Trust Company.

The value of the Plan's interest in the UVMHN Trust in 2024 and 2023 was based on actual contributions and allocated investment income less actual distributions and allocated administrative expenses. As of December 31, 2024 and 2023, the Plan's interest in the net assets of the UVMHN Trust was approximately 0% and 14%, respectively. Total investment income (including net appreciation/depreciation in the fair value of investments) of the UVMHN Trust was allocated to the individual plans based upon the amount of the time the Plan's assets were invested in the master trust. The net asset balances and activity reported on the financial statements were reflective of the master trust related activity. The Plan was part of one master trust and, therefore, funds were not allocated between master trusts.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used needed to maximize the use of observable inputs and minimize the use of unobservable inputs. The fair value measurement levels of the UVMHN Trust were consistent with the leveling reflected in Note 5.

Following is a description of the valuation methodologies used for assets measured at fair value. There had been no changes in the methodologies used at December 31, 2024 and 2023:

*Partnerships:* Valued based on the capital position reported on the most recent K-1 schedule received by The Northern Trust Company.

The other assets measured are defined in Note 5.

**(6) Funding Policy**

The Company's funding policy was to contribute the amount recommended by the Company's actuary to fulfill ERISA requirements. Contributions were intended to provide not only for benefits attributed to service to date, but also for those expected to be earned in the future. The Company's contribution amounts to the Plan for 2024 and 2023 were sufficient to meet the minimum funding requirement of ERISA. Upon termination, the plan's assets were used to purchase a group annuity contract from Nationwide Life Insurance Company, which will assume the responsibility for paying all future retirement benefits to plan participants and beneficiaries. The annuity contract guarantees the same benefit amounts and payment terms as provided under the plan.

### (7) Plan Termination

On December 31, 2022, a plan termination was approved and effective. On this date, the benefits stopped accruing (see Note 1 for additional information on the Plan termination).

The net assets of the Plan were allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of retirement under the Plan.
- b. All other benefits of participants guaranteed under ERISA.
- c. All other nonforfeitable benefits.
- d. All other benefits.

Certain benefits under the Plan were insured by the PBGC. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan were guaranteed at the level in effect on the date of the Plan's termination. However, there was a statutory ceiling on the amount of an individual's monthly benefit that the PBGC guarantees, which was \$7,108 and \$6,750 for terminations occurring in 2024 and 2023, respectively. Whether all participants receive their benefits at the time of termination or at some future time depended on the sufficiency, at that time, of the Plan's net assets to provide those benefits and also depended on the level of benefits guaranteed by the PBGC.

In connection with the termination, all vested benefits were settled through the purchase of nonparticipating group annuity contracts from Nationwide Life Insurance Company. As a result, the Company has no further obligation to pay benefits to plan participants under the Plan.

### (8) Income Tax Status

The Plan was intended to be qualified under Section 401(a) and exempt from tax on related income under Section 501(a) of the Internal Revenue Code (IRC). The Plan obtained its latest determination letter on March 27, 2012, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator had analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax period in progress. The Plan Administrator believed there is no longer subject to income tax examinations for years prior to 2021.

**(9) Actuarial Present Value of Accumulated Plan Benefits**

Accumulated plan benefits are those future benefit payments attributable under the Plan's provisions to the service that employees have rendered.

The actuarial present value of accumulated plan benefits was determined by actuaries and was the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the benefit information date and the expected date of payment. The effect of Plan amendments was recognized during the year in which such amendments become effective.

Due to the Plan termination on December 31, 2022, there was no recent actuarial valuation performed.

**(10) Parties-In-Interest**

The Plan had several arrangements with service providers. These transactions were considered party-in-interest transactions under ERISA.
