Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note A – Description of Plan

The following description of the PSI-Med, Inc. (Organization) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees except non-resident aliens, members of an excluded class and union of the Organization. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible employees with 12 months and 1,000 hours of service may participate in the plan.

Investment Valuation and Income Recognition - The Group Annuity Contract offers a wide spectrum of investment choices selected by the participant including a General Account (guaranteed return account) plus various Pooled Separate Accounts (PSA) from a variety of investment managers. This allows the participant to select investments that best reflect their investment style - from conservative to aggressive.

Contributions – The Plan allows for the following types of contributions: Employee elective deferrals, Employer matching contributions, Employer nonelective contributions, and Employee rollover contributions.

Employee elective deferrals – An employee may elect to reduce their compensation and make a contribution to the Plan on a pre-tax basis. Federal law limits the amount the employee may elect to defer under this plan and any other retirement plan permitting Elective Deferrals during any calendar year. However, if the employee is age 50 or over, the employee may defer an additional amount.

Employer nonelective matching contributions – For eligible employees in 2024, the employer will contribute 3% of pretax annual compensation, as defined in the Plan.

Employee rollover contributions – The Plan may accept Rollover Contributions on behalf of any Eligible Employee. The Plan Administrator may establish procedures that regulate the method by which rollovers will be accepted.

Participants Accounts - Each participant's account is credited with (a) the Organization's contribution, (b) Employee's contributions and, (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - All contribution source accounts are 100% vested at all times.

Notes to Financial Statements (Continued)

Note A – Description of Plan (Continued)

Notes Receivable from Participants - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through bi-monthly payroll deductions.

Investment Options - Upon enrollment in the Plan, a participant may direct employer contributions in any of the various insurance products offered by Empower Annuity Insurance Company of America.

Participants may change their investment options at any time.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive with a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a five-year period or to satisfy the required minimum distributions rules. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts - At December 31, 2024 there were forfeitures totaling \$186. These accounts will be used to reduce future employer contributions or to pay plan expenses.

Note B - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Note B - Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits - Benefits are recorded when paid.

Note C - Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which level 1 inputs were not available. level 3 inputs would only be used if Level 1 or level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2023 due to additional guidance in 2024.

Level 1 Fair Value Measurements

The fair value of pooled separate accounts based on quoted net asset values of the shares as reported by the insurance company. The funds held by the Plan are priced daily by the insurance company.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Note D - Trust Agreement

The Plan has a trust agreement with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the balances in Group Annuity Contract. The account is credited with earnings on the underlying investments (mutual funds) and charged for Plan withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value which approximates fair value. The value of the investment at December 31, 2024 was \$4,229,202.

Note E - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note F - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan sponsor by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan's Forms 5500, Annual Return/Report of Employee Benefit Plan, are generally subject to examination by the Internal Revenue Service for three years after they are filed.

Note G - Risk and Uncertainties

The Plan invests in Group Annuity Contracts with various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note H - Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

Note I – Related Party Transactions and Party In Interest Transactions

ERISA defines a party-in-interest generally as any fiduciary or employee of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of a person described above. Investment-related expenses are included in net appreciation in fair value of investments. Payments to parties-in-interest consisted of administrative expenses paid to the Insurance and Trust companies and for professional services and for investment administrative services totaling \$31,064 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the plan sponsor at no cost to the Plan, additionally, all of the cost of the plan are paid by the sponsor.

Note J - Information Prepared and Certified by Empower Annuity Insurance Company of America

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Empower Annuity Insurance Company of America.

Note K - Guaranteed Investment Contract with Insurance Company

In 2024, the Plan participants have invested in a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (Empower) which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Note K - Guaranteed Investment Contract with Insurance Company (Continued)

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024, was \$2,821. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
