We have performed audits of the financial statements of The Odom Corporation Salary Savings Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE A - DESCRIPTION OF PLAN

The following description of The Odom Corporation Salary Savings Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was amended and restated on January 1, 2022 to adopt a new pre-approved plan document which was updated with required amendments, regulatory changes, and other enhancements. This did not have a material impact to the Plan.

##### **General**

The Plan is a qualified defined contribution savings plan covering substantially all employees of The Odom Corporation, Coca-Cola Bottling of Alaska, LLC, Coca-Cola Bottling of Hawaii, LLC, NW Beverages, LLC, Odom East LLC, Stein Distributing LLC and C. Stein LLC (collectively, the "Company"). Employees of Stein Distributing LLC and C. Stein LLC became eligible to participate in the Plan effective January 1, 2024. In addition, the Plan was amended effective January 1, 2024, to modify eligibility to include that if an employee fails to be employed for 60 consecutive days of service, the employee is then subject to 1,000 hours of service requirement.

The Plan provides for contributions pursuant to Section 401(a) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Specific details of employer match contributions and vesting can be found in the following footnotes.

##### **Contributions**

Under the provisions of the Plan, participants may defer, on a pre-tax or after-tax basis, any percentage of their annual eligible compensation, as defined by the Plan document, limited to amounts prescribed by Internal Revenue Service ("IRS") regulations. The Company matches 100% of the first 3% of participant contributions and 50% of the next 2% of participant contributions. In addition to the Company matching contributions, the Company may contribute discretionary and non-elective contributions to be allocated to each participant's account. Participants covered by the Aiea Warehouse and Delivery Collective Bargaining Unit receive a 3.50% non-elective contribution, which totaled \$77,467 and \$80,901 for the years ended December 31, 2024 and 2023, respectively, and paid subsequent to year end. There were no other non-elective contributions for the years ended December 31, 2024 and 2023. There were no discretionary employer contributions for the years ended December 31, 2024 and 2023.

##### **Investment Options**

Participants are able to direct their investments (including Company matching, discretionary and non-elective employer contributions) to one of the model allocation investment fund options offered by the Plan.

##### **Participant Accounts**

Participant accounts are credited with the participant's contributions and allocations of the Company's contributions and Plan earnings or losses. The allocation of the Company's contributions is based on the participant's contributions to the Plan. The allocation of Plan earnings or losses is based on the participant's account balance in each respective investment fund into which they have directed contributions.

##### **Vesting**

All participant contributions, Company matching contributions, employer discretionary contributions, and earnings thereon are 100% vested at all times. Effective January 1, 2023, non-elective contributions and related earnings thereon are also 100% vested at all times.

***Notes Receivable from Participants***

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. A participant may have two loans outstanding at a time. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within 10 years. Under the Plan agreement, interest is paid by the borrower at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loan rates ranged between 3.25% and 9.50% with various maturities through September 2034. As of December 31, 2023, the rates of interest on outstanding loan rates ranged between 3.25% and 9.50% with various maturities through October 2028.

***Payment of Benefits***

Benefit distributions will be made in either a lump sum or periodic installments at the normal retirement age of 65 or upon termination of employment from the Company. Participant's contributions and Company contributions may be withdrawn earlier, subject to certain hardship withdrawal provisions of the Plan. Terminated employees with account balances of less than \$1,000 shall be automatically distributed by the Plan.

***Plan Termination***

While the Company intends to continue the Plan, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, assets of the Plan will be used to provide benefits according to the priority described in the Plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), using the accrual method of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts in the statements of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Dividend and interest income is recorded as earned on the accrual basis and allocated to participants based upon the participant's proportionate share of assets in each investment fund. Dividends are recorded at the ex-dividend date.

The Plan presents, in the statements of changes in net assets available for benefits, the net appreciation and depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation and depreciation of those investments.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

***Risks and Uncertainties***

The Plan provides for various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

***Payments of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

All fees are paid by the Plan. Any expenses directly relating to the purchase, sale or transfer of the Plan's investments are charged to the investment fund to which the expense relates. Loan fees are paid by loan participants.

**NOTE C - CERTIFIED INVESTMENT INFORMATION**

The Plan Administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of:

- Investment assets, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Information included on schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE D - FAIR VALUE MEASUREMENTS**

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 or Level 2 inputs as components of the overall fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds:* Valued daily at the net asset value ("NAV") of shares held by the Plan at year end.

*Common Collective Trust Fund:* Valued at the NAV provided by the Administrators of the fund. The NAV is used as the practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant-directed redemptions have no restrictions; however, a liquidation of the Plan's entire share in the fund may be delayed. There are no unfunded commitments as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - TAX STATUS**

The Plan is a non-standardized pre-approved defined contribution plan ("Pre-Approved Plan"). For the adoption agreement effective January 1, 2022, the Pre-Approved Plan obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F - NON-EXEMPT TRANSACTIONS**

During the year ended December 31, 2024, \$269 of participant contributions to the Plan were not remitted to the Plan in a timely fashion. Management funded lost earnings related to the late remittance in March 2025.

During the year ended December 31, 2023, \$638,114 of participant contributions to the Plan were not remitted to the Plan in a timely fashion. Management funded lost earnings related to the late remittances in September 2024.

During the years ended December 31, 2024 and 2023, the only party-in-interest transactions were notes receivable to participants.
