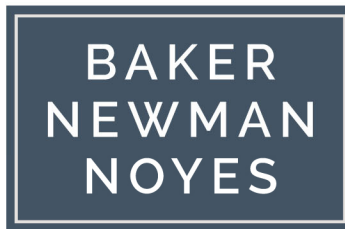

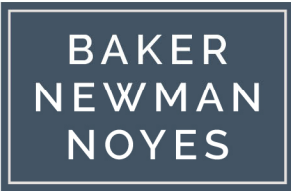

**Opinion**

### 1. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are presented on the accrual basis.

#### Investments

Mutual funds are stated at fair value based on quoted market prices of the underlying investments. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

As described in Accounting Standards Update (ASU) 2015-12, *Plan Accounting: Defined Benefit Pension Plans (Topic 960), Defined Contribution Pension Plans (Topic 962), Health and Welfare Benefit Plans (Topic 965)*, investment contracts, including stable value funds, held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Ocean Properties Ltd. 401(k) Plan (the Plan) has an investment in a guaranteed portfolio fund. The guaranteed portfolio fund contract guarantees participant withdrawals at contract value and is fully benefit responsive. The guaranteed portfolio fund is included in the financial statements at contract value as reported by the third-party administrator. Interest rates are determined quarterly. The average yield earned by the fund and credited to participants was 1.41% and 1.23% in 2024 and 2023, respectively.

The guaranteed portfolio fund is a general account product with an insurance company. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. As such, there are not any specific securities in the general account that back the liabilities of this insurance product and it would be inappropriate to look to the market values of the securities within the insurer's general account to determine a fair value. The guaranteed portfolio fund pays interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the contract. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

#### Notes Receivable from Participants

The Plan allows participants to borrow against their accounts. Such loans shall not exceed the lesser of \$50,000 or 50% of the participants' vested interest in their account. The Plan has established a minimum loan request of \$1,000 per loan. Loans can be for any purpose with a term not to exceed 5 years unless it is for the purchase of a primary residence in which case the term shall not exceed 15 years. Loans bear interest at the prime rate, plus 1%, at the inception of the loan.

#### Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Use of Estimates

Preparation of the Plan's financial statements requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent items at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

#### Payment of Benefits

Benefits are recorded when paid.

#### Contributions

Employee contributions are recorded in the period in which payroll deductions are made. Employer discretionary contributions are determined on an annual basis and are recognized when a commitment to make a contribution is made.

#### Subsequent Events

Events occurring after the date of the statement of net assets available for benefits are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available to be issued.

### 2. Description of the Plan

The Plan is a Section 401(a) defined contribution plan with a 401(k) component covering employees of Ocean Properties, Ltd. and certain affiliated entities (the Company or the Employer). Prior to January 1, 2023, the Plan excluded those who are 5% owners in the Company. Effective January 1, 2023, the Plan no longer excludes those who are 5% owners in the Company. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

#### 2. **Description of the Plan (Continued)**

##### Eligibility and Participation Requirements

Employees are eligible to participate in the Plan after completing one year of service, as defined, and attaining 21 years of age. Eligible employees become participants on the January 1 or July 1 following the date they become eligible to participate in the Plan.

The *SECURE ACT 2.0* expanded eligibility for certain long-term part-time (LTPT) employees. Effective January 1, 2024, part-time employees who have completed at least 500 hours of service in three consecutive years are eligible to participate in the Plan. Effective January 1, 2025, the requirement is being reduced from three to two consecutive years.

##### Participant Contributions

Eligible employees may elect to contribute a percentage of their annual compensation, subject to the limitations established by the Internal Revenue Code (the Code).

##### Employer Contributions

Under the provisions of the Plan, the Employer may contribute a matching contribution to the Plan on behalf of each participant. The decision to make matching contributions and the amount of such contributions will be made each year by the Company. During 2024 and 2023, the Company did not make any matching contributions to the Plan.

The Employer may also make a discretionary profit sharing contribution to the Plan. Profit sharing contributions shall be allocated to each participant who is an eligible employee as defined in the Plan. Profit sharing contributions will be allocated on a pro rata basis in accordance with each eligible participant's compensation for the Plan year. During 2024 and 2023, such contributions totaled \$837,339 and \$812,811, respectively.

##### Rollovers

The Plan permits funds from qualified plans to be transferred into the Plan by eligible employees.

##### Vesting

Participants are immediately 100% vested in their salary deferral and rollover accounts. Participants vest in the employer matching contribution and the employer discretionary account over a five-year period at a rate of 20% per year.

##### Forfeitures

Forfeitures resulting from a terminated participant's failure to be fully vested in the Company's matching contribution and profit sharing contribution will be used to pay Plan expenses with any excess allocated as an additional employer contribution. There were no forfeitures during 2024 and 2023.

##### *Investment Elections*

Participants in the Plan select the accounts in which their contributions will be invested. In 2024 and 2023 contributions may be invested with Fidelity Investments (Fidelity) and State Street or a guaranteed portfolio fund offered by Empower Retirement (Empower).

Earnings and losses from investments are allocated to the participants in proportion to their account balances.

##### *Withdrawals*

Withdrawals may be made from the vested portion of the participant's account for financial hardship, upon termination of employment, or upon attaining the age of 59½.

#### 3. **Expenses of the Plan**

The Company paid substantially all administrative costs of the Plan in 2024 and 2023 but was not obligated to do so. Participants are required to pay service fees which are allocated to participants in proportion to their account balances.

The Plan fee structure is levelization, in that all participants are paying the same percentage of administration and recordkeeping fees of the Plan. All of the funds within the Plan offer revenue crediting to participant accounts except for the State Street Target Date funds, as such funds do not have excess revenue generated within them.

#### 4. **Income Tax Status**

Effective January 1, 2010, the Plan sponsor adopted the prototype non-standardized plan of Great-West Trust Company, LLC, as amended. This non-standardized preapproved profit sharing plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the form of the Plan is acceptable under Section 401(a) of the Code and, therefore, is exempt from federal income taxes. In the opinion of the Plan Administrator, the Plan has continued to operate within the terms of the Plan and the Code and remains qualified under the Code and applicable regulations.

The Financial Accounting Standards Board has issued guidance on accounting for uncertainty in income taxes. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no material uncertain tax positions that require adjustment to the financial statements; therefore, no provision or liability for income taxes has been included in the financial statements.

#### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In this event, all participants shall become 100% vested in their account balance.

#### 6. Fair Value Measurements

Fair value is defined as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active exchange markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active exchange markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the quoted net asset value of shares held by the Plan at year end which are traded in an active market.
