### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **THE HAMLIN SCHOOL RETIREMENT PLAN (the Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## Notes to the Financial Statements

---

### **Note 1 - Plan Description:**

The following brief description of The Hamlin School Retirement Plan (the Plan), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 403(b) plan that was established in 1965 and restated effective January 1, 2009. The Plan is sponsored by The Hamlin School (the School), a private, non-profit educational institution. The Plan was established to provide benefits to eligible employees as defined in the Plan document. The Plan invests in mutual funds, variable and fixed annuity contracts, and a pooled separate account. The Plan approved vendor is Teachers Insurance and Annuity Association (TIAA) and CREF (College Retirement Equities Fund), the Custodians. CREF serves as the issuer of the CREF variable annuities under the Plan and TIAA serves as the issuer of the TIAA Traditional Annuity contracts held by the Plan and is the recordkeeper of the TIAA and CREF assets. The Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective June 2016, the Plan migrated to new accounts and investment platform administered by TIAA and CREF. Employees now choose from a menu of investment options or default to a Target Date Fund. While employees may maintain already existing funds in the former accounts, current employer and employee contributions may only go to the new platform.

Effective January 1, 2019, the Plan was restated to take advantage of the remedial adoption period at January 1, 2010 and to comply with TIAA's ERISA 403(b) volume submitter plan adoption agreement. A favorable opinion letter from the Internal Revenue Service (IRS) was issued on August 7, 2017 regarding the qualified status of the prototype plan on which the terms of the restated Plan are based. The significant changes were to change the Plan name, limit the number of outstanding Plan loans, eliminate the special catch-up contribution provision, and include the provision for mandatory distribution for balances of \$5,000 or less. The Plan's name changed from Hamlin School Retirement Plan to The Hamlin School Retirement Plan. The number of outstanding Plan loans a participant may have changed from unlimited to three loans outstanding at a time. Prior to January 1, 2019, employees that had worked at least fifteen years for the School were allowed to make a special catch-up contribution as described in the plan document. Upon termination, a participant with a vested balance of \$5,000 or less receives his/her vested account paid out in a lump sum distribution. Refer to the restated Plan document for a full description of the provisions.

## Notes to the Financial Statements

Effective April 7, 2020, the Plan adopted the distribution provision of the Coronavirus Aid, Relief, and Economic Security (CARES) Act that was signed into law on March 27, 2020. A CARES Act distribution allows the Plan's participants to take a COVID-19 related distribution up to \$100,000 from the Plan beginning on or after January 1, 2020 and before December 31, 2020. The Plan has also implemented certain other requirements by the CARES Act whose changes to the Plan include, among others, allowing certain eligible individuals to receive coronavirus-related relief for loan repayment, suspending required minimum distributions, and delaying the commencement date for required minimum distributions. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

Effective August 1, 2020, the Plan was restated to adopt TIAA's new Retirement Plan Loan program for participants. Loans are offered with a fixed rate of interest and funded directly from the participant's retirement account. The loan amount is deducted from the participant's account balance, and subsequent loan payments, including interest, are credited to the participant's account. There is a one-time origination fee and an annual maintenance fee for any participant loans. Previously, loans were considered policy loans from the plan's assets and the participant's holdings were used as collateral (Note 1 – Policy Loans). The restatement also included the amendment, effective January 1, 2019, to adopt the hardship distribution provisions of the Bipartisan Budget Act of 2018.

The SECURE 2.0 Act, enacted in December 2022, includes over 90 provisions aimed at improving retirement plan access, participation, and administration. TIAA is actively implementing changes in alignment with the Act. In 2024, consistent with SECURE 2.0, the threshold for mandatory small account distributions increased from \$5,000 to \$7,000.

### Eligibility

All employees, with the exception of students, are eligible to make an elective deferral contribution into the Plan. Employees hired prior to June 30, 2016, with the exception of students, must complete one year of eligible service and have attained the age of 21 to be eligible to receive the employer non-elective contribution. Employees hired after June 30, 2016, with the exception of students, must complete two years of eligible service, have attained the age of 21 and make an elective deferral to be eligible to receive the employer matching contribution.

### Contributions

Eligible employees may contribute up to 100% of pretax annual compensation, as defined by the Plan, not to exceed the amount allowable under current income tax regulations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

For employees hired prior to June 30, 2016, the School makes nondiscretionary nonelective contributions ranging from 5% to 9% of eligible employee compensation as defined by the Plan. The percentages will vary based on years of eligible service as defined by the Plan. Unless otherwise directed by the participant, nondiscretionary contributions will be invested into the appropriate TIAA-CREF Lifecycle Fund based on date of birth.

For employees hired on or after July 1, 2016, the School matches one and a half times the employee deferral up to the maximum contribution of 5% to 7% based on years of eligible service.

### Participant Accounts

The Plan's assets are held in separate funds with TIAA and CREF. Each participant's account is credited with the allocation of the employee contribution, the employer nondiscretionary nonelective contribution, the employer elective match contribution, the participant's share of earnings or losses, and is charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined.

### Vesting

Participants are immediately vested in their contributions, rollover contributions, and the School's contributions plus actual earnings thereon.

### Participant Investment Options

Upon enrollment in the Plan, a participant may direct their account balance in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options as allowed by their contracts throughout the year via TIAA's telephone system or internet website.

### Policy Loans

Plan loans are issued directly from funds owned by TIAA and not directly from participant accounts. TIAA requires adequate security for the loans issued and a portion of the participant's accounts is reserved, or held in collateral, to cover 110% of the outstanding loan in case of default. Effective January 1, 2019, a participant may have up to three loans outstanding at a time. Loan terms range from one to five years, except for loans to purchase a primary residence. Interest rates charged on these loans may be fixed or variable and were determined by the terms of the controlling contract. Repayments on these loans, including principal and interest, are made directly by the participant to TIAA and do not flow through the Plan. The Plan Administrator has concluded that these loans are not plan assets and that such arrangements are exempt transactions. Effective January 1, 2022, TIAA stopped issuing these collateralized policy loans. As of December 31, 2024 and 2023 the outstanding plan loan balance was \$2,113 and \$2,740, respectively. The loan bears an interest rate at 5.28% per annum at December 31, 2024.

### Notes Receivable from Participants

The Plan allows active participants to borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loan repayment terms range from one to five years, except for loans to purchase a primary residence. The loans are secured by the balance in the participant's account and the annual interest rate is set at prime plus 1% as of the date of the loan. Principal and interest are paid directly to TIAA. A participant may have up to three loans outstanding at a time. The interest rate is fixed throughout the duration of the loan. Rates on loans outstanding at December 31, 2024 range from 4.25% to 9.50% per annum.

### Payment of Benefits

Upon termination of service due to severance from employment or death, a participant or its beneficiaries may elect to receive a lump-sum amount, installment payments, an annuity equal to the value of the participant's vested interest in his or her account or ad-hoc distributions. Upon disability, hardship, attaining age 59 ½, or deemed severance from employment while performing military service, a participant may elect to receive a lump-sum amount, installment payments or an annuity equal to the value of the participant's elective deferrals. The individual agreements governing the investment options may further restrict the payout options.

Upon termination, a participant with a vested balance of \$5,000 or less receives his/her vested account paid out in a lump sum distribution. Effective January 1, 2024, the dollar limit for mandatory distributions was increased to \$7,000 from \$5,000 under the Secure 2.0 Act provision.

There were no participant requests to withdraw from the Plan as of December 31, 2024 and 2023 that had not been paid out as of those dates.

### Plan Custodians

The Plan approved vendors are TIAA and CREF and TIAA, FSB, a federal savings association (collectively, the Custodians). CREF serves as the issuer of the CREF variable annuities under the Plan. TIAA serves as the issuer of the TIAA Traditional Annuity contracts and the TIAA Access variable annuities held by the Plan and is the recordkeeper of the TIAA and CREF assets. TIAA, FSB, a federal savings association, is the directed custodian for certain investments that were record kept by TIAA.

## **Note 2 - Significant Accounting Policies:**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments of the Plan are held by the Custodians and invested based solely upon instructions received from participants. The Plan's investments are reported at fair value as of the last day of the Plan year, except for fully benefit-responsive investment contracts (Note 5), which are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The School's management determines the Plan's valuation policies utilizing information provided by the investment advisors, the issuer and/or the Custodians of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation (depreciation) of investments in the Statement of Changes in Net Assets Available for Benefits includes both the unrealized appreciation (depreciation) in the aggregate fair value of investments and realized gains and losses on sale of investments bought and sold as well as held during the year.

The market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is likely that the value of the Plan's investments, both in total and in individual participant accounts, has fluctuated since December 31, 2024.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction to net appreciation (depreciation) in fair value of investments.

### Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

### Contributions

Contributions from Plan participants, the nondiscretionary nonelective employer contributions, and the matching employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments, while others are reflected separately as administrative expenses (See Note 6).

### Revenue Sharing

The Plan recognizes the income from revenue sharing agreements when received. During 2024, the Plan received approximately \$33,700 of revenue sharing income which was utilized for plan expenses by recording it as an offset to administrative expenses in the Statement of Changes in Net Assets Available for Benefits.

### Subsequent Events

The Plan Administrator has evaluated subsequent events from December 31, 2024 through October 9, 2025, the date the financial statements were available to be issued, and there were no material subsequent events that required recognition or additional disclosure in these financial statements.

### **Note 3 - Certified Information:**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participant for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF (the Custodians of the Plan).

### Note 4 - Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying Statement of Net Assets Available for Benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable annuity contracts:* Valued based on the NAV of underlying securities held by the contract at year end, which are generally valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing.

The CREF accounts are valued at the daily unit value published on NASDAQ. The funds are not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the funds. The CREF variable annuity accounts consist of nine investment portfolios: the Stock R1, the Stock R4, Global Equities, Growth, Equity Index, Core Bond, Inflation-Linked Bond, Social Choice, and Money Market funds.

The Plan may redeem units at fair value on any day the New York Stock Exchange is open for business. Participants cannot redeem units from the CREF portfolios (with the exception of the Money Market account) for 90 days if a purchase, sale, and/or repurchase is made within that account within a 60-day period.

The TIAA Access variable annuity accounts are funded through a separate investment account of TIAA registered under the Investment Company Act of 1940, which invests in proprietary and non-proprietary mutual funds through various sub-accounts. Sub-account unit values are calculated daily. The TIAA Access variable annuity accounts are valued based on the net asset values of underlying securities held by the contract at year end, which are generally valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing.

*Pooled separate account:* The TIAA Real Estate account is a pooled separate account in which daily unit values are published on NASDAQ. The fund is not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the account. Redemptions are permitted daily except participant transfers out of the fund, which are limited to one per calendar quarter.

*Fixed annuity contracts:* The TIAA Traditional Annuity Contracts, which are non-benefit-responsive, have been presented at contract value, which approximates fair value, as reported to the Plan by TIAA. This determination is based on TIAA's credit rating and yield during 2024 and 2023 being comparable to similar alternative investments and the interest rate, which re-sets annually, being comparable to a ten-year U.S. Treasury bond. In subsequent periods, if market conditions change, such as the insurance company credit rating or interest rate environment, the difference between contract value and fair value could become significant. There may be certain liquidity restrictions on redemption.

The TIAA Access Nuveen Lifecycle funds seek high total return over time through a combination of capital appreciation and income. Each of the funds is designed to provide a single diversified portfolio managed with a target retirement date in mind. The target date is the approximate date when investors expect to begin withdrawing money from the fund. Each portfolio invests in certain underlying equity and fixed-income funds offered by the TIAA and CREF Funds.

The TIAA Access Nuveen International Equity fund seeks a favorable long-term total return, mainly through capital appreciation, primarily from equity securities of foreign issuers. The fund normally invests at least 80% of its assets in equity securities of foreign issuers, generally in at least three countries other than the United States. The fund's management team looks for companies of any capitalization size that demonstrate an ability to generate free cash flow and strong market share. The fund may invest in stocks of smaller companies and in emerging market securities depending on the prevalence of opportunities.

The TIAA Access Nuveen Mid-Cap Value fund seeks a favorable long-term total return, mainly through capital appreciation, primarily from equity securities of medium-sized domestic companies. The fund normally invests at least 80% of its assets in mid-cap equity securities that the fund's management team believes are undervalued based on an evaluation of their potential worth. The fund may invest up to 20% of its assets in foreign securities.

### **Note 5 - Fully Benefit-Responsive Contracts:**

The Plan has traditional investment contracts and a Stable Value fund with TIAA. The traditional investment contracts are subcontracts, representing both fully benefit-responsive and non-benefit-responsive contracts. For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the traditional investment contract because it is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. These contracts are included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Fully benefit-responsive investment contracts totaled \$2,090,297 at December 31, 2024, which consisted of \$2,066,623 in TIAA Traditional fully benefit-responsive investment contracts and \$23,674 of TIAA Stable Value fully benefit-responsive investment contracts. At December 31, 2023, fully benefit-responsive investment contracts that totaled \$2,277,360, which consisted of \$2,256,507 in TIAA Traditional fully benefit-responsive investment contracts and \$20,853 of TIAA Stable Value fully benefit-responsive investment contracts.

The traditional investment contracts held by the Plan are guaranteed investment contracts held in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the fixed annuity investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited. The average yield earned by the Plan is adjusted to reflect the actual interest rate credited to participants calculated by dividing the annualized earnings credited to participants for all fully benefit-responsive investment contracts by the fair value of all fully benefit-responsive investment contracts.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%. Such interest rates are reviewed and re-set by TIAA on an annual basis. The TIAA contract also offers the opportunity for additional amounts in excess of the guaranteed rate. When declared, additional amounts remain in effect for the 12-month period that begins each March 1.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events may be different under each contract and include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreements without the consent of the issuer.

Participants are permitted to transfer funds between their CREF accounts and into their TIAA Retirement Annuity at any time. However, transfers out of the TIAA annuity into any CREF account by an active participant can only be made through a Transfer Payout Annuity (TPA), which provides for the transfer of funds in substantially equal installments over a period of ten years.

### **Note 6 - Related Party Transactions and Party-in-Interest Transactions:**

Certain Plan investments are managed by either the Custodians or affiliates of the Custodians of the Plan. Such an arrangement, which includes transactions considered party-in-interest under ERISA regulations, is permitted under the provisions of the Plan and is specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employees of the School. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the School.

Effective April 28, 2016, TIAA and CREF provide certain administrative services to the Plan pursuant to a Recordkeeping Services Agreement (RSA) between the School and TIAA and CREF. TIAA and CREF receive revenue from investment service providers for services TIAA and CREF provide to the funds. This revenue is used to offset certain amounts owed to TIAA and CREF for its administrative services to the Plan and to pay other expenses of the Plan.

If the revenue received by TIAA and CREF from such investment service providers exceeds the amount owed under the RSA, TIAA and CREF remit the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, the Plan earned approximately \$33,700 applied as an offset to administrative expenses in the Statement of Changes in Net Assets Available for Benefits. Plan administrative expenses paid for by the Plan for 2024 were approximately \$57,000 included as administrative expenses in the Statement of Changes in Net Assets Available for Benefits. At December 31, 2024, approximately \$33,000 is included in plan assets available for benefits to be applied to pay Plan administrative expenses or allocated to participants in 2025. The Plan or Plan Sponsor may make a payment to TIAA and CREF for administrative expenses not covered by revenue sharing.

### **Note 7 - Plan Termination:**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. All participants are currently 100% vested in their accounts.

## Notes to the Financial Statements

### Note 8 - Income Tax Status:

The Plan is a defined contribution plan designed to qualify as a tax-exempt plan under the Code. The Plan adopted a standardized form of the simplified ERISA 403(b) volume submitter plan sponsored by TIAA. A favorable opinion letter from the IRS was issued on August 7, 2017 regarding the qualified status of the volume submitter 403(b) plan on which the terms of the Plan are based. The Plan has been amended since the volume submitter plan received its opinion letter and qualified status under the Code. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code. Accordingly, no provision for federal or state income taxes has been made.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

### Note 9 - Risks and Uncertainties:

The Plan provides for various investment options in any combination of the investments offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Approximately 91% and 93% of the Plan's investments at December 31, 2024 and 2023, respectively, are held with TIAA and CREF. This is considered to be a concentration of credit risk.

Approximately 20% and 21% of the Plan's investments are held in two accounts with TIAA and CREF at December 31, 2024 and 2023, respectively, as noted below. This is considered to be a concentration of credit risk.
