Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pacific Maritime Group, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pacific Maritime Group, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pacific Maritime Group, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Pacific Maritime Group, Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Pacific Maritime Group, Inc. 401(k) Profit Sharing Plan (the 401(k) Profit Sharing Plan) provides only general information. Participants should refer to the 401(k) Profit Sharing Plan Agreement, as amended, for a more complete description of plan provisions.

General – The 401(k) Profit Sharing Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Pacific Maritime Group, Inc., and Pacific Dredge and Construction (collectively, the Plan), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Pacific Maritime Group, Inc., is the 401(k) Profit Sharing Plan's sponsor and serves as plan administrator.

Eligibility – Employees of the Plan are eligible to participate in the 401(k) Profit Sharing Plan upon reaching age 21 and after completing three months of service. Employees who have completed 1,000 hours of service in a specified 12-month period, are eligible to receive employer match contributions.

Contributions

Participant contributions – Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the 401(k) Profit Sharing Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Unless affirmatively elected otherwise, employees are automatically enrolled in the 401(k) Profit Sharing Plan upon meeting eligibility requirements. The default contribution rate for automatic enrollment is 3% of pre-tax annual compensation. Unless elected otherwise, participant deferrals are automatically escalated on the first day of the plan year, by 1% of compensation, up to a maximum of 10%. Participants may also contribute amounts representing roll overs from other qualified defined benefit or defined contribution plans.

For work performed under prevailing wage contracts, the amount contributed to the 401(k) Profit Sharing Plan by the employer on behalf of the employee is based on the wage rate and job classification of the employee.

Employer match and other employer contributions – The 401(k) Profit Sharing Plan allows for the employer to make discretionary matching contributions. These matching contributions are calculated based on employee pay and elective deferrals for the payroll period providing the eligibility requirements are met. If the employer makes a matching contribution, the percentage of elective deferral matched and the limit of deferrals matched may be different for people in different groups determined by the employer for the plan year. For this purpose, the groups are defined as Union Employees (Group 1) and Nonunion Employees (Group 2). Any percentage chosen by the employer will be effective for the entire year. For the year ended December 31, 2024, the employer contributed discretionary matching contributions equal to 50% of the first 5% of pay (including catch-up contributions) for Group 1 and Group 2 employees.

Pacific Maritime Group, Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

The 401(k) Profit Sharing Plan also allows for the employer to make discretionary contributions which are allocated to eligible employees as of the last day of the plan year. After meeting the initial 1,000 hour requirement to receive other contributions, participants who were active participants at any time during the year and are employed with the Plan on the last day of the year or have more than 500 hours of service during the plan year, are eligible for continued employer matching contributions. The 401(k) Profit Sharing Plan also allows for the employer to make discretionary qualified nonelective contributions, which are allocated to each non-highly compensated employee who was an active participant during the plan year, not to exceed 5% of all eligible participants pay for that year.

In addition, the 401(k) Profit Sharing Plan may make another discretionary qualified nonelective contribution each year to certain non-highly paid employees. There were no discretionary nonmatch contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contributions and Plan matching contributions, as well as allocations of the Plan’s profit sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the 401(k) Profit Sharing Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the 401(k) Profit Sharing Plan.

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Plan’s contribution portion of their accounts is based on years of continuous service. Participants vest in the Plan’s contributions based on the following schedule:

Less than 3	0%

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the 401(k) Profit Sharing Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed the period consistent with the commercial home loan practices. Under the terms of the Plan Agreement, plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50%, with various maturities through November 2029.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or fixed installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the 401(k) Profit Sharing Plan, must be used before year end and will first be used to pay the 401(k) Profit Sharing Plan’s administrative expenses, with any remaining amount used to reduce future Plan contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,456 and \$0, respectively. For the year ended December 31, 2024, employer contributions were reduced by \$5,888 from forfeited nonvested accounts and \$31 was used for payment of administrative expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The 401(k) Profit Sharing Plan’s trustee, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the 401(k) Profit Sharing Plan are paid directly by the Plan and are excluded from these financial statements. Administrative expenses paid by the 401(k) Profit Sharing Plan may include notes receivable and distribution fees charged to participants’ accounts and administrative plan fees. Investment related expenses are included in net appreciation in fair value of investments.

Excess contributions payable – Excess contributions payable represent amounts refunded to participants after year end to comply with regulatory contribution limitations.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The 401(k) Profit Sharing Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The 401(k) Profit Sharing Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The 401(k) Profit Sharing Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the 401(k) Profit Sharing Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the 401(k) Profit Sharing Plan are deemed to be actively traded. Mutual funds held by the 401(k) Profit Sharing Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Pooled separate accounts – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

Collective trusts – Units held in collective trusts (CTs) are valued using the NAV practical expedient of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

The valuation methods used by the 401(k) Profit Sharing Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the 401(k) Profit Sharing Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Plan Document is a prototype basic savings defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the 401(k) Profit Sharing Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC) and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the 401(k) Profit Sharing Plan's tax positions and does not believe the 401(k) Profit Sharing Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The 401(k) Profit Sharing Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The 401(k) Profit Sharing Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 6 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Note 7 – Party-in-Interest Transactions

The 401(k) Profit Sharing Plan paid expenses related to the 401(k) Profit Sharing Plan's operations and investment management to various service providers. Certain plan investments are managed by Principal Financial Group. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the trustee of the 401(k) Profit Sharing Plan and an affiliate of Principal Financial Group and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Plan has the right to terminate the 401(k) Profit Sharing Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the 401(k) Profit Sharing Plan is terminated, amounts allocated to a participant's account become fully vested.
