The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Robert Derector Associates 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical

requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Robert Derector Associates 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Robert Derector Associates 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Robert Derector Associates 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Robert Derector Associates 401k Plan (“the Plan”) provides only general information. Robert Derector Associates (the Company) is the plan sponsor. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**A. General**

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Service Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all employees of Robert Derector P.E.P.C (the Company). The Company adopted this Plan effective January 1, 1987. The Plan was amended July 14, 2022 to be in compliance. The Plan is administered by members of the Plan Committee consisting of the Company’s management. Ascensus Trust Company is the Trustee.

**B. Eligibility**

All employees are eligible to participate in the Plan. The Plan has semi annual entrance dates of January 1 and July 1 of which eligible participants can enter the Plan.

Employees are eligible to participate in the Plan if they are employees and are **not**:

- 1) a member of a union collective bargaining unit and exclusion from coverage under this Plan was part of the union’s negotiated agreement.
- 2) non resident alien that received no earned income from the Company which constitutes income from sources within the United States.

**C. Contributions**

Contributions to the Plan are either pre-tax Salary Deferrals or after tax Roth Deferrals. Participants are immediately vested in their contributions plus actual earnings thereon. A participant may elect to contribute up to 20 percent of their salary to the Plan. In 2024, the maximum deferral amount allowable by the IRS Code was \$23,000 (\$30,500 for participants who have attained age 50 before the end of the year are eligible to make catch-up contributions). Rollover contributions are fully vested and non-forfeitable. At December 31, 2024 and 2023 the Plan had no participant rollover contribution receivable. Participant rollover contributions to the Plan during 2024 equaled \$57,028. The Company can make discretionary matching contributions to any full time employee who has attained the age of twenty one and has worked at least 500 hours during the Plan year for the Company. This discretionary matching contribution is based solely on the Company’s discretion. In December 2024, the Company made a discretionary match contribution equal to .375 cents for each dollar that a participant contributed up to a maximum of \$1,500 per year. For the year ended December 31, 2024 the Plan discretionary match contribution equaled \$127,324 net of plan forfeitures used. Participants direct the Investment of their contributions and the employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for the participants.

**D. Participant Accounts**

Each participant's individual account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution, and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**E. Investment Options**

The assets of the Plan are allocated to the various funds at the direction of the participant. The following investment options are available for the investment. Equity Funds, Fixed-Income Funds, Growth Funds and Money Market Funds.

**F. Notes Receivable from Participants**

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are collateralized by the balance in the participant's account. The interest rate on current outstanding loans bear interest at prime plus 2% which are commensurate with local /prevailing rates. The interest rates on current outstanding loans range from 5.25% - 10.50%. Principle and interest is paid ratably through bi-weekly payroll deductions. At December 31, 2024 and 2023 the participant note receivables balance equaled \$48,126 and \$108,559, respective. The Current interest receivable on these notes equaled \$153 which is reflected in the income from interest on notes receivable amount of \$5,685.

**G. Vesting of Accounts**

Participants are immediately vested in their Contribution plus actual earnings thereon. Vesting in the Company's matching contribution portion of their account plus actual earnings thereon is based on years of continuous service. A participant is fully vested after 6 years of service in accordance with the following schedule:

6 or more	100%

The Plan is subject to top-heavy provisions. The above schedule reflects top-heavy vesting rules. An active Participant shall be 100% vested in their account at their Normal Retirement Date, the date of Disability or death.

**H. Payments of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or an annuity. Normal retirement age is 65 under the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**I. In Service Withdrawals**

While still an employee a participant in the Plan may request:

- 1) a distribution after reaching the age of 59 ½.
- 2) a distribution after reaching normal retirement age of the Plan.
- 3) a hardship withdrawal. The request must be approved by the Plan Administrator and must follow the guidelines of heavy financial need. Before a hardship distribution can be made, employee must take all other distributions and nontaxable loans available under the Plan.

**J. Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,256. and \$4,302, respectively. As of December 31, 2024 the cumulative forfeiture/suspense balance was \$10,230. These accounts will be used to reduce employer contributions or to pay administrative expenses of the Plan. In 2024 Plan forfeited non-vested accounts equal to \$68,320 were used towards the Company employer match contribution of \$195,644 and for Plan expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**C. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**D. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plans valuation policies. See Note 4 for discussion of fair value measurement. Money market balances and cash accounts are valued at cost, which equals current value. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**E. Notes Receivable From Participants**

Notes receivable from participants are valued at their unpaid principle balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**F. Payment of Benefits**

Benefits are recorded when paid.

**G. Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE 4 - FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to un-observable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1   Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2   Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 4 - FAIR VALUE MEASUREMENT (CONTINUED)**

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. No Level 2 or 3 inputs were available to the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with The Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 6 - RISK AND UNCERTAINTIES**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall volatility risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service has determined and informed Ascensus LLC. by a letter dated June 30, 2020 that their Prototype Non-Standardized Profit Sharing Plan with CODA (Cash or Deferred Arrangement), was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan adopted Ascensus LLC's Prototype Non-Standardized Profit Sharing Plan with CODA. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Ascensus Trust Company is the trustee of the Plan's investments, Ascensus LLC is the record keeper and BOA/Merrill Lynch is the Plan's investment advisor and therefore certain transactions qualify as party-in-interest transactions. Accordingly during 2024 administrative fees of \$20,890. were paid to Ascensus LLC from the Plan and Plan investment fees of \$90,730. were paid through investment transactions to BOA/Merrill Lynch as per the Revenue Information Report received. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

The Company directly pays other fees related to the Plan's operations.

**NOTE 9 - SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end of December 31, 2024. Subsequent events have been evaluated through October 3, 2025, which is the date these financial statements were available to be issued,
