INDEPENDENT AUDITOR'S REPORT

Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Jet East Gama 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jet East Gama 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Jet East Gama 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Jet East Gama 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of the Jet East Gama 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement and summary plan description for a complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering all eligible employees of Gama Aviation (Engineering) Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and qualifies under Section 401(a) of the Internal Revenue Code ("IRC").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Eligibility

The Plan covers substantially all employees of the Company with the exception of employees covered by a collective bargaining agreement and nonresident aliens. An employee will become eligible for participation in the Plan once they reach eighteen years of age and complete three months of employment with an entry date equivalent to the first day of the month coinciding with or next following the date the requirements were met.

Contributions

Plan participants may contribute a percentage of pre-tax annual compensation, not to exceed the dollar limitation contained in Section 402(g) of the IRC, through a salary reduction election. For the year ended December 31, 2024, the annual limitation was \$23,000. All participants who are eligible to make elective deferral contributions may elect to designate all or any portion of their elective deferral contributions as pre-tax or post-tax ("Roth") deferral contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For the year ended December 31, 2024, the annual limitation for catch-up contributions was \$7,500.

The Company has elected a safe harbor matching contribution for the Plan. As noted within the Plan Document, the Company implements a matching contribution of up to 100% for each eligible participant's elective deferral contribution to the Plan up to 4% of a participant's eligible compensation. The employer may also make profit sharing contributions for eligible participants. For the year ended December 31, 2024, no profit sharing contributions were declared.

1. DESCRIPTION OF THE PLAN (continued)

Participant accounts

The Plan maintains an account for each participant, which is credited with participant contributions, Company matching contributions, an allocation of the Plan's earnings, and charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are 100% vested in their voluntary contributions and the Company's safe harbor matching contributions plus realized earnings thereon. Participant's become vested in the Company's profit sharing contributions after three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Payment of benefits

The Plan provides for retirement benefits to begin upon retirement. Retirement age for the Plan is age 65. Under current law, payment of benefits shall commence no later than the attainment of 72 years of age.

On termination of service, participants with account balances of \$7,000 or less will receive a lump sum amount equal to the value of their vested account balance. Participants with account balances greater than \$7,000 may elect to receive a distribution as an immediate lump sum distribution or to receive distributions as substantially equal installments. Participants age 59 ½ and over may elect an in-service distribution.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have no more than two loans outstanding at any point in time. The maximum loan term is five years, unless the loan is acquired for the purchase of a primary residence. The loans are secured by the balance in the participant account and bear interest at a rate that is consistent with the provisions of the IRC, U.S. Department of Labor, and other applicable legal requirements, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Forfeitures

At December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$3,995, respectively. These amounts will be used to reduce future administrative fees and/ or employer contributions. Forfeitures of \$14,882 were utilized to reduce administrative expenses or employer contributions during the year ended December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in accordance U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimated amounts.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (quoted market prices). The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement.

Contributions and contributions receivable

Contributions from participants and related receivables are recorded based on the date the contributions have been separated from a participants' pay (pay date). Contributions from the Company are recorded in the year earned to coincide with the year in which the Company records the contributions to its general ledger. The Plan records receivables for contributions based upon the contribution recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions from participants are recorded based on the date the contributions are received by the Custodian.

Benefits paid to participants

Benefits are recorded when paid.

Expenses

The Plan's expenses including, but not limited to, trustee, custodial, and audit fees are paid from the assets of the Plan. Fees related to participant-directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. CERTIFICATION OF INVESTMENT INFORMATION BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, Ascensus Trust Company and Newport Trust Company, LLC, the Trustee and Custodian of the Plan, determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of:

Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.

Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

4. INVESTMENTS - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in the inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defined party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Vanguard Group, Inc. ("Vanguard") has entered into an agreement with Ascensus to provide certain administrative services on its behalf. Ascensus is the trustee and custodian of the Plan assets and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services totaled \$111,688 for the year ended December 31, 2024. The fees paid by the Plan for the investment management services are netted against the net appreciation in fair value of investments on each investment option of the Plan for the year ended December 31, 2024.

6. TAX STATUS

The Plan uses a prototype plan document sponsored by Red Bank Pension Services Inc., the Plan's third party administrator and recordkeeper. The IRS has determined and informed Red Bank Pension Services Inc. by a letter dated June 30, 2020, that the prototype document is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself. Although the Plan has been amended and restated since the date of the letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During the years ended December 31, 2022 through 2024, the Company failed to remit timely certain employee deferrals to the Plan aggregating \$6,706,767. The Company has corrected the late employee deferral contributions for the years ended December 31, 2022 through 2024 and remitted lost earnings to the Plan on January 2, 2025.

10. SUBSEQUENT EVENT

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan merged into the West Star Aviation, LLC 401(k) Plan and the assets were transferred on January 15, 2025.
