Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of S.W. Cole Engineering Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for more information.

General

The Plan is a defined contribution retirement and savings plan sponsored by S.W. Cole Engineering, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Vanguard Group, Inc. is the recordkeeper of the Plan. The Vanguard Group, Inc. outsources substantially all administrative, recordkeeping and reporting functions to Ascensus, Inc. and, therefore, Ascensus, Inc. also serves as the recordkeeper of the Plan. Ascensus Trust Company, a wholly owned subsidiary of Ascensus, Inc., is the trustee of the Plan.

Eligibility

The Plan is available to substantially all Company employees. Eligible employees may begin making elective deferrals to the Plan and are eligible for the employer contributions upon attaining age 18 and completing at least 1,000 hours in the first 6 months of employment. Employee's may enter the plan on January 1, April 1, July 1, and October 1. Long-term part-time employees can enter the plan after three consecutive years of working at least 500 hours.

Contributions

Eligible employees will receive a safe harbor matching contribution equal to 100% of the amount contributed to the plan up to the first 3% of plan compensation plus 50% contributed between 3% and 5% of plan compensation. Employees may receive a discretionary contribution decided by their employer for each year. The employer may decide not to contribute for a given year and may decide to give a different contribution amount. This contribution may be determined as a percentage of compensation or as a dollar amount.

The total amount of any employer profit sharing contribution (employer contribution) is determined annually by the Company and is subject to certain limitations on the amount that can be contributed on behalf of any single participant. During the year ended December 31, 2024, the Company made a \$175,000 profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Forfeitures resulting from the application of vesting provisions, as defined, are used to offset future employer contributions.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and Company's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses, and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All employee and employer safe harbor matching contributions and earnings thereon are fully vested immediately. Vesting in employer discretionary contributions and earnings thereon is based on years of service. A participant is fully vested in employer contributions and earnings thereon after five years of service, with partial vesting beginning after two years of service.

Notes Receivable from Participants

Participants may borrow from the Plan a minimum of \$10,000 up to the lesser of 50% of their vested account balance or \$50,000. Participants are limited to no more than two loans outstanding at any given time. Notes receivable from participants are secured by the balance in the participant's accounts. Principal and interest are paid through payroll deductions.

Payment of Benefits

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 65 and early retirement is age 60 with one year of service in which the employee works 1,000 hours or more), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive benefit payments in a single lump-sum or a monthly annuity.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses of the Plan are generally paid by S.W. Cole Engineering, Inc., Subsidiary and Affiliates. Certain expenses related to maintaining a self-directed brokerage account under the Plan are specifically charged to those participants.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued based on quoted market prices of shares held by the Plan at year-end.

Life Insurance: Valued based on policy value including and dividend additions and net of outstanding policy indebtedness.

4. Party-in-Interest Transactions

Certain of the Plan's investments are managed by the Plan's trustee; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and certain administrative expenses amounted to \$13,550 for the year ended December 31, 2024.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Tax Status

The Plan operates under a pre-approved prototype plan document and is intended to qualify for tax-exempt status under the applicable sections of the Code. The Internal Revenue Service has determined and informed EPIC Advisors Inc., by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. Accordingly, the plan administrator believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Information Prepared and Certified by Trustee

The investments, investment transactions, notes receivable from participants, net appreciation in fair value of investments, and interest and dividend amounts were obtained by management and agreed to or derived from the information certified by the trustee, as complete and accurate. This information is included in the following:
