## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Retirement Plan for Employees of Southampton Hospital Association (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in note 6 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter - Plan Termination**

As described in note 1 the financial statements, during 2025 the plan sponsor resolved to terminate the Plan and purchased annuities to fund the remaining pension benefits associated with the Plan.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

## (1) Description of Plan

The following is a brief description of the Retirement Plan for Employees of Southampton Hospital Association (the Plan) and provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

### (a) General

The Plan is a noncontributory defined-benefit pension plan sponsored by Southampton Hospital Association (SHA or Plan Sponsor) for non-union employees. The Southampton Hospital Association Finance Committee and the Plan administrator control and manage the operation and administration of the Plan. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) serves as the custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective December 31, 2003, the Plan was frozen, and the accrual of benefits ceased. As such, no employee can be or become an active participant, as defined in the Plan, after December 31, 2003. Also, a participant's monthly normal retirement benefit cannot exceed their accrued benefit, as defined in the Plan document, as of December 31, 2003.

As of August 1, 2017, SHA transferred certain assets to StaffCo of Brooklyn, LLC (StaffCo) and affiliates of StaffCo. In connection with such transaction, all employees of SHA who were employed as of August 1, 2017 incurred a severance from employment with SHA. SHA remained the sponsor of the Plan on and after August 1, 2017. Other than the aforementioned, there were no other direct effects to the Plan participants.

In March 2025, SHA resolved to terminate the Plan and subsequently purchased annuities to fund the remaining pension benefits associated with the Plan.

### (b) Participation

All eligible non-union employees of SHA, prior to December 31, 2003, became participants in the Plan after completing one year of service in which they worked 1,000 or more hours, or 780 or more hours for employees who became eligible from January 1, 2003 through December 31, 2003.

### (c) Funding Policy

The Plan's funding policy is for the Plan sponsor to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. The Plan sponsor made contributions of \$58,813 for 2024 and \$374,837 for the 2023 Plan year. The Plan sponsor's contributions have met the minimum funding requirements of ERISA.

(d) Plan Benefits

The Plan provides for normal retirement benefits upon reaching age 65, and has provisions for early retirement, death, and disability benefits. A participant's monthly retirement benefit shall become payable as of the date of a severance from employment, on or after the normal retirement date. Benefits under the Plan are determined based upon a final pay formula. Generally, the final pay formula is calculated as a percentage of earnings multiplied by years of credited services with certain adjustments, up to December 31, 2003, as provided in the Plan. Participants may elect to receive their pension benefits in the form of a qualified joint survivor annuity or other optional forms of payment.

In September 2024, the Plan sponsor resolved to amend the Plan to allow a window through November 30, 2024 under which an eligible participant may elect on a limited time basis to receive a lump sum distribution of their entire benefit due under the Plan.

(e) Vesting

A participant becomes vested upon the earlier of completing five years of service or upon reaching age 65 during service with SHA.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements of the Plan are prepared on under the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

### (2) Summary of Significant Accounting Policies, Continued

#### (c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the exchange in price that would be received for an asset, or paid to transfer a liability, in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Purchases and sales of investments are recorded on a trade-date basis, interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### (d) Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### (e) Benefits to Participants

Benefits to participants are recorded when paid.

(f) Plan Administration Fees

For the years ended December 31, 2024 and 2023, administrative costs of \$35,838 and \$333,748 were expensed by the Plan. These expenses were for custodial fees and Pension Benefit Guaranty Corporation (PBGC) insurance premiums. Certain other administrative expenses are borne by SHA, at SHA's discretion. Administrative expenses paid by SHA for the Plan are excluded from these financial statements.

(g) Concentrations

Two investment held by the Plan collectively represents approximately 91% and 44% of net assets available for benefits as of December 31, 2024 and 2023, respectively.

(h) Subsequent Events

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

(3) Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

(4) Actuarial Present Value of Accumulated Plan Benefits

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service the employees rendered until December 31, 2003. The actuarial present values of accumulated Plan benefits as of January 1, 2024 and 2023 were determined by an independent actuary from Principal and are the amounts that result from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as for death, disability, withdrawal, or retirement) between the valuation dates and the expected payment dates. The effect of Plan amendments on accumulated Plan benefits is recognized during the year in which such amendments become effective. Had the 2024 valuation been prepared as of December 31, 2024, the total actuarial present value of accumulated plan benefits would have decreased significantly due to the lump sum window offered (note 1(d)). Had the 2023 valuation been prepared as of December 31, 2023, there would be no material difference.

The significant actuarial assumptions used in determining accumulated Plan benefits are as follows:

(5) Fair Value Measurements

The Plan's assets recorded at fair value have been categorized based upon a fair value hierarchy in accordance with Financial Accounting Standards Board ASC 820, Fair Value Measurement. See note 2 for a discussion of the Plan's policies regarding this hierarchy and valuation methods. A description of the valuation techniques applied to the Plan's major categories of assets and liabilities measured at fair value is as follows:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*PSAs* - PSAs are valued at the NAV of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Principal Life Insurance Company and T. Rowe Price, is used as a practical expedient to estimate fair value. NAV would not be used if it were probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There was no change in the methodology used at December 31, 2024 and 2023.

(6) Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the custodian, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the ERISA-required supplemental schedules.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedules, including assessing whether the supplemental schedules are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

(7) Income Tax Status

The Internal Revenue Service has determined and informed the Plan by a determination letter dated January 8, 2011 that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended on several occasions since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations prior to 2021.

(8) Plan Termination

During 2025, the Plan sponsor resolved to terminate the Plan and purchased annuities to fund the remaining pension benefits associated with the Plan. When the Plan terminates, the net assets of the Plan will be allocated, as prescribed ERISA and its related regulations.

(9) Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by an affiliate of Principal and these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$28,360 and \$22,000 for the years ended December 31, 2024 and 2023, respectively.

This assumption does not have material impact on the results of this report and has been selected based on our best estimate of active workforce.

**Withdrawal** None. Due to the size of the plan and limited experience, we're not recognizing a withdrawal assumption prior to retirement.

**Form of benefit** Participants are assumed to receive their benefits on the normal form at the assumed retirement age.

This assumption is based on the results of recent experience analysis and anticipated future experience.

#### Methods prescribed by law

##### Liability measure

Funding target is the present value of the benefits accrued on the valuation date. Included in Funding Target is the value of any missed required minimum distributions (defined in IRC §401(a)(9) and Treasury Regulation §1.401(a)(9)), equal to back payments with interest at 7.00%.

Target normal cost is based on benefits expected to accrue during the current plan year and includes an estimate of plan expenses for the year.

#### Methods selected by plan sponsor

##### Asset method

The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years.

The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

##### Yield curve rates

Full yield curve. Use the rates through the month of December

##### PBGC premium basis

Variable rate premiums are calculated using census, market value of assets and interest rates in effect on the current valuation date. Interest rates are the full yield curve rates used for annual cost defined in IRC §430(h)(2)(D)(ii). You elected the Alternative interest method for the 01/01/2020 plan year and this method must be used for five years before a change can be made.

#### Methods elected by actuary

##### Retirees

Assets and liabilities for current and future retirees are included.

##### Vested benefits

A benefit is included in vested benefits if it meets the requirements under PBGC. The benefit is multiplied by the participant's vesting percentage applicable to each benefit on the valuation date.

The following ancillary benefits are always treated as nonvested: disability benefits payable to retirement age unless in pay status, pre-retirement death benefits in excess of the survivor annuity death benefit and post retirement death benefits for non-retired participants except as noted in the Plan provisions.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. The Total dataset base rate table was selected based on information provided by the plan sponsor.

**Mortality improvement** Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe “Approach 1” is reasonable for this plan.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
