Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to the Financial Statements

Program of Hospital-Medical Benefits for Eligible Pensioners and Surviving Spouses of The Cleveland-Cliffs Iron Company, Empire Iron Mining Partnership and Tilden Mining Company L.C.

Note 1 Description of the Plan

The following description of the Program of Hospital-Medical Benefits for Eligible Pensioners and Surviving Spouses of The Cleveland-Cliffs Iron Company, Empire Iron Mining Partnership and Tilden Mining Company L.C. (the "Plan") provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

General

The Plan was established in 1993 to provide various employee benefits for certain retired hourly employees and certain surviving spouses who, at the time of their retirement, were covered by a collective bargaining agreement among The Cleveland-Cliffs Iron Company (the "Company"), Empire Iron Mining Partnership ("Empire"), Tilden Mining Company L.C. ("Tilden") and the United Steelworkers of America (the "USW"). A restatement of the Plan was adopted effective January 1, 2002 and provides for eligible surviving spouses of active employees and for eligible retired hourly employees of participating companies, their surviving spouses and their eligible dependents, where applicable, medical benefits and prescription drug benefits through insurance or otherwise. The Plan is a health and welfare plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan's participants include certain retired employees of the Company who were covered by a collective bargaining agreement between the Company, Empire, and Tilden and the USW, surviving spouses and dependents who met the eligibility requirements of the Plan at the time of the retired employee's retirement.

Anthem administers the payment of medical claims, Express Scripts administers the payment of prescription drug claims and MetLife administers the payment of life insurance claims. Payments by Anthem and Express Scripts are reimbursed to Anthem and Express Scripts on an "as required" basis directly by the Company's ultimate parent, Cleveland-Cliffs Inc. ("Parent Company"). In addition, the Parent Company pays life insurance premiums to MetLife. The Empire-Tilden-Cleveland Cliffs Iron Michigan Central Shops Retiree Benefit Trust (the "VEBA Trust") (described in Note 4) has been established as a funding vehicle for the Plan.

Eligibility

The Plan provides that the Company shall pay eligible medical benefits to certain eligible retired employees (and eligible surviving spouses and dependents) who were covered by the Agreement at the time of their retirement, have at least fifteen years of service and were hired prior to September 1, 2016.

Investment Options

The Bank of New York Mellon (the "Trustee") serves as trustee for the Plan, under a welfare trust agreement by and between the Company and the Trustee (the "Welfare Trust Agreement").

The assets of the Plan held by the Trustee are invested in the VEBA Trust based on investment objectives established by the Cleveland-Cliffs Inc. Investment Committee (the "Investment Committee"). SEI Investments Management Corporation (the "Investment Advisor") serves as the Investment Advisor to the Investment Committee.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting:

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments

Investments held by the VEBA Trust are stated at fair value. Investments are stated at aggregate current values determined as follows: Securities traded on a national securities exchange on the last business day of the year are valued at the last reported sales price and securities not traded on the last business day of the year are valued at the average of the last reported bid and ask price. Securities traded in the over-the-counter market are valued at the

average of the last reported bid and ask price. Securities which do not have an established market are valued by the investment advisors, investment managers or third party appraisers. Realized gains or losses on security transactions are recorded as the difference between net proceeds received and cost. In accordance with the policy of stating investments at fair value, changes in net unrealized appreciation or depreciation are reflected in the Statement of Changes in Net Assets Available for Benefits. Dividend income is recorded on the ex-dividend date and income from other investments is recorded as earned on an accrual basis. Purchases and sales are recorded on a trade-date basis.

Actuarial Present Value of Accumulated Plan Benefits

The actuarial present value of the Plan's accumulated Plan benefits is determined using the projected unit credit method and is comprised of those estimated future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered to the valuation date. Accumulated benefits under the Plan include benefits expected to be paid to retired and terminated employees or their beneficiaries, beneficiaries of employees who have died, and present employees or their beneficiaries. Benefits payable under all circumstances, such as retirement, death, disability and termination of employment, are included to the extent they are considered attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated benefits under the Plan is determined by an independent consulting actuary and results from applying actuarial assumptions to adjust the accumulated benefits under the Plan to reflect the time value of money and probability of payment between the valuation date and the expected date of payment.

Benefit Obligations

Current medical benefits are paid to eligible participants by the Parent Company in accordance with the Trust Agreement, as more fully described in Note 4. These benefit obligations are not included in the Statement of Net Assets Available for Benefits and Statement of Changes in Net Assets Available for Benefits; such obligations are included in the Plan benefit obligations and changes in Plan benefit obligations described in Note 5.

Funds for future medical benefits are contributed to the VEBA Trust based upon amounts determined by the Company in accordance with the provisions of the Welfare Trust Agreement, as more fully described in Note 4.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments include an investment in a master trust holding various investments with varying degrees of risk, such as interest rate risk, credit risk and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Plan contributions and actuarial present value of accumulated Plan benefits are prepared based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Administrative Fees

The Plan pays the trustee fees, actuarial fees, audit fees and expenses of the Plan. Other administrative expenses of the Plan, such as salaries and use of facilities are paid by the Company.

Subsequent Events

Management evaluates events occurring subsequent to year end in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 13, 2025, which is the date that the financial statements were available to be issued.

Plan Termination

Subject to the requirements of the collective bargaining agreement, the Welfare Trust Agreement and the VEBA Trust created thereby may be terminated by the Company at any time by written notice to the Trustee. Upon termination, the assets of the VEBA Trust shall be used to discharge the obligations of the VEBA Trust as of the date of its termination, and any remaining assets shall be used to provide similar benefits to participants covered by the Plan. Assets of the VEBA Trust may not be distributed to or revert to the Company.

Note 3 Tax Status

The VEBA Trust funding the Plan has received an exemption letter from the Internal Revenue Service dated December 21, 1994, stating that the VEBA Trust is tax-exempt under the provisions of Section 501(c)(9) of the Code as a Voluntary Employee Beneficiary Association ("VEBA"). Once qualified, the Plan and VEBA Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the VEBA Trust. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions. However, currently no audits for any tax periods are in progress.

Note 4 Empire-Tilden-Cleveland Cliffs Iron Michigan Central Shops Retiree Benefit Trust

The VEBA Trust was established as of August 1, 1993, in response to a requirement of a collective bargaining agreement with the USW to fund the welfare benefits provided under the Plan.

Prior to October 15, 2016, the VEBA Trust was comprised of pooled assets separated into accounts established pursuant to the Welfare Trust Agreement to record the interest of each component plan in the VEBA Trust. The component plans are each a portion of the Plan that were designated as separate plans with separate accounts adopted by each employer (the Company, Empire and Tilden).

Effective October 15, 2016, the VEBA Trust was amended to consolidate the separate accounts of the Company, Empire and Tilden such that separate accounts ceased to be maintained under the Welfare Trust Agreement. Consistent with that amendment, a contribution of \$14,100 thousand will be made annually in arrears, by February 15 following each calendar year to the VEBA Trust, when the VEBA funding is under 90 percent of the Plan's Postretirement Benefit Obligation ("ASC 715"). The Company and the USW must agree to an appropriate adjustment to the level of funding for the VEBA as part of the labor negotiations. The funding obligation is suspended when the Plan's share of the value of the assets in the VEBA reaches 90 percent of the ASC 715 obligation. At December 31, 2024, the VEBA funding met the 90 percent threshold. Additionally, the Company may pay current benefit claims from the VEBA Trust as long as the VEBA Trust fund equals 70 percent or more of the Plan's ASC 715 obligation. At December 31, 2024 and December 31, 2023, the Company's share of VEBA funding met this threshold and \$5,118 thousand and \$4,657 thousand, respectively, of Plan funds were used to pay benefit claims. The Company made no contributions during 2024 and does not expect to make any contributions during 2025. For calendar year 2025, current benefit claims may continue to be paid from the VEBA Trust.

At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was 100% for both years.

Note 5 Postretirement Benefits

The Plan benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31, 2024. The Plan benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and dependents and (2) active employees hired prior to September 1, 2016 and dependents after retirement from service. Health claims incurred by retired participants but not reported at year-end are included in the postretirement benefit obligations. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

On September 30, 2022, the Company reached an agreement with the USW that impacted retiree insurance benefits. The new agreement established the set fixed monthly medical premiums for non-medicare eligible participants who retired prior to January 1, 2015. These fixed premiums begin January 1, 2023 and expire on December 31, 2026 and revert to increasing premiums based on a cost-sharing formula thereafter. Additionally, the Company agreed to provide Medicare-eligible retirees coverage under an Anthem Medicare Advantage plan effective January 1, 2023.

The actuarial present value of the expected Plan benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

In 2024, the assumed health care cost trend rate for self insured plans was maintained at 6.25%, which grades down on a linear basis to 4.50% by 2032. In 2024, the health care trend rate for the Medicare Advantage Prescription Drug plans assumes a 16.25% rate, which is primarily driven by our expectation that the impacts from the Inflation Reduction Act will negatively impact Medicare Advantage Prescription Drug plan costs for the next year. The assumed healthcare trend rate for the Medicare Advantage Prescription Drug plans will realign with the self insured plans after the one time increase.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 by \$1,190 thousand.

The following were other significant assumptions used in the valuations to calculate the Plan's total benefit obligation as of December 31, 2024 and 2023:

Mortality tables issued by the Society of Actuaries are used for the mortality assumption. We use Pri-2012 mortality tables with adjustments for blue collar. Mortality is projected using Scale MP-2021 with generational projections for both years.

Changes in actuarial assumptions and other actuarial losses for December 31, 2024 resulted in a \$8,655 thousand loss. The net increase in postretirement benefit obligations is primarily attributable to updated per capita health care costs, including Medicare Advantage Prescription Drug plans and updates to other demographic changes. The net increase in postretirement benefit obligation was partially offset by a 47 basis point increase in the discount rate compared to the prior year.

Changes in actuarial assumptions and other actuarial gains for December 31, 2023 resulted in a \$8,326 thousand gain. The net decrease in postretirement benefit obligations is primarily attributable to updates for demographic experience. The Plan experienced adjustments relating to retirements, participation, persistency and census data updates.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Note 6 Information Prepared and Certified by Trustee

Certain information related to investments disclosed in the accompanying financial statements, Note 4 and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and *Investment Income from Master Trust* for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee.

Note 7 Party-in-Interest Transactions

Certain Plan investments are in shares of mutual funds and alternative investments that are managed by the Investment Advisor and held in Trust by the Trustee and, therefore, these transactions qualify as party-in-interest. Usual and customary fees were paid by the mutual funds and alternative investments for the investment management services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest.

Note 8 Medicare Subsidy

On December 8, 2003, the Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the "Act") for employers sponsoring postretirement health care plans that provide prescription drug benefits was signed into law. The Act introduced a prescription drug benefit under Medicare as well as a Federal subsidy to sponsors of retiree health care benefit plans providing a benefit that is at least actuarially equivalent to Medicare Part D. Under the Act, the Medicare subsidy amount is received directly by the Plan sponsor and not the related Plan. Further, the Plan sponsor is not required to use the subsidy amount to fund postretirement benefits and may use the subsidy for any valid business purpose. As the Plan is not directly entitled to the subsidy, the accumulated postretirement benefit obligation and the changes in the benefit obligation have not been adjusted for any amount associated with the Medicare subsidy. During 2024 and 2023, the Plan sponsor used the Medicare Part D Subsidy to reduce the costs of the Plan.

Note 9 Fair Value of Financial Assets

ASC 820, *Fair Value Measurements and Disclosures*, establishes a three-level valuation hierarchy for classification of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an

asset or liability as of the measurement date. Inputs refer broadly to the assumptions that market participants would use in pricing an asset or liability. Inputs may be observable or unobservable. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources. Unobservable inputs are inputs that reflect management's own views about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The three-tier hierarchy of inputs is summarized below:

- Level 1 — Valuation is based upon quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 — Valuation is based upon quoted prices for similar assets and liabilities in active markets, or other inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 — Valuation is based upon other unobservable inputs that are significant to the fair value measurement.

The classification of assets and liabilities within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement in its entirety.

Investments classified as Level 1 primarily include equity investments and fixed income mutual funds that are based on observable quoted market prices on an active exchange. Fixed income investments classified as Level 2 include U.S. Treasury STRIPS which are priced daily through a bond pricing vendor as well as corporate bonds, mortgage-backed securities and non-US bonds which have valuations based on their bid-ask spreads or quoted prices of securities with similar characteristics.

Hedge funds, structured credit and real estate investments are classified as Level 3 due to the absence of quoted market prices and inherent lack of liquidity. These investments are generally valued at estimated fair value based on financial inputs from investment advisors, investment managers or third party appraisers. Certain Level 3 investments may be lagged up to three months if there are no financial inputs available. Real estate withdrawals are permitted on the last business day of each quarter subject to a 95-day prior written notice. Historically, redemption requests for structured credit investments have been considered quarterly, subject to notice of 90 days, although the advisor is currently only requiring notice of 65 days.
