Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Align Aerospace 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The Align Aerospace 401(k) Plan (the “Plan”) was established on November 4, 2011 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees, as defined in the Plan, of Align Aerospace LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The assets of the Plan are held in a trust by Fidelity Management Trust Company (the “trustee”).

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Participation

Company employees are eligible to participate in the Plan upon employment. Residents of Puerto Rico, leased employees, those covered by a collective bargaining agreement, non-resident aliens with no U.S. source income and independent contractors are not eligible to participate.

B. Benefits

Benefits under the Plan begin when a participant retires, becomes disabled, dies or ceases to be an employee, whichever applies. Normal retirement age is 65. Hardship withdrawals are permitted.

C. Vesting

A participant is fully vested immediately as to voluntary contributions, rollover contributions, qualified non-elective contributions, Employer safe harbor matching contributions and related earnings. Employer matching and non-elective contributions are 100% vested after two years of service. Non-elective contributions are 100% vested immediately, effective October 1, 2023.

D. Contributions

Participants may contribute to the Plan through tax-deferred salary reductions up to 50% of eligible compensation, as defined in the Plan, up to a statutory maximum as determined by the Internal Revenue Code (the “Code”). Catch-up contributions are permitted. The Plan allows for automatic enrollment at 6% of eligible compensation. The Plan allows Roth rollover contributions, effective October 1, 2023.

The Company makes a safe harbor matching contribution equal to 100% of participant salary deferrals up to 3% of compensation, plus 50% of salary deferrals on the next 2% of compensation. Matching contributions totaled \$232,578 for the year ended December 31, 2024. The Company may, at its discretion, make additional matching contributions or non-elective contributions; there were no additional matching contributions or non-elective contributions for the year ended December 31, 2024.

E. Notes Receivable from Participants

A participant is allowed to borrow a maximum of 50% of his or her vested account balance up to \$50,000. The minimum loan amount is \$1,000. Loans must be repaid through payroll deductions within five years (except that loans for the purchase of a primary residence may be repaid over ten years). All loans bear interest of prime rate plus 1%.

F. Forfeitures

Forfeited balances of terminated participants' non-vested accounts are applied to reduce administrative expenses and employer contributions. There were no forfeitures for the year ended December 31, 2024. Forfeitures available to be used totaled \$25,595 and \$24,671 as of December 31, 2024 and 2023, respectively.

G. Expenses

Most administrative expenses are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Fair Value Measurements

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of a money market fund and mutual funds valued at fair value based on quoted market prices. Interest and dividends are recorded on the accrual basis. Capital gains are recorded as interest and dividends. Purchases and sales of securities are recorded on a trade-date basis.

D. Payments of Benefits

Benefits are recorded when paid.

E. Risks and Uncertainties

Investments are exposed to interest rates, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 3 - INCOME TAX STATUS

The Plan is based upon a Prototype Volume Submitter Profit Sharing Plan with CODA document that received its most recent tax exempt status from the Internal Revenue Service in a letter dated March 31, 2014. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts, and Plan assets would be distributed based upon the participants' account balances at that time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedules were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued and managed by the trustee or its affiliates. Transactions related to these investments qualify as party-in-interest transactions; however, they are exempt from the prohibition under ERISA.

NOTE 7 - DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, the Company failed to remit \$34,359 of participant contributions within 15 business days after the month in which they were withheld as required by the Department of Labor. Failure to remit or untimely remittance of participant contributions constitutes a prohibited transaction under Department of Labor regulations. The Company has advised corrections will be made in 2025.

NOTE 8 - AMENDMENT

During 2024, the Plan adopted the following amendments:

- To adopt safe harbor contribution provisions, effective January 1, 2024.
- To adopt after tax contribution provisions, effective November 14, 2024.

NOTE 9 - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to increase safe harbor matching equal to 100% of salary deferrals up to 5% of compensation, and 50% of salary deferrals on the next 1% of compensation.

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued. Except as noted above, there were no other material subsequent events that required recognition or additional disclosures in these financial statements.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Participation

Company employees are eligible to participate in the Plan upon employment. Residents of Puerto Rico, leased employees, those covered by a collective bargaining agreement, non-resident aliens with no U.S. source income and independent contractors are not eligible to participate.

B. Benefits

Benefits under the Plan begin when a participant retires, becomes disabled, dies or ceases to be an employee, whichever applies. Normal retirement age is 65. Hardship withdrawals are permitted.

C. Vesting

A participant is fully vested immediately as to voluntary contributions, rollover contributions, qualified non-elective contributions, Employer safe harbor matching contributions and related earnings. Employer matching and non-elective contributions are 100% vested after two years of service. Non-elective contributions are 100% vested immediately, effective October 1, 2023.

D. Contributions

Participants may contribute to the Plan through tax-deferred salary reductions up to 50% of eligible compensation, as defined in the Plan, up to a statutory maximum as determined by the Internal Revenue Code (the “Code”). Catch-up contributions are permitted. The Plan allows for automatic enrollment at 6% of eligible compensation. The Plan allows Roth rollover contributions, effective October 1, 2023.

The Company makes a safe harbor matching contribution equal to 100% of participant salary deferrals up to 3% of compensation, plus 50% of salary deferrals on the next 2% of compensation. Matching contributions totaled \$232,578 for the year ended December 31, 2024. The Company may, at its discretion, make additional matching contributions or non-elective contributions; there were no additional matching contributions or non-elective contributions for the year ended December 31, 2024.

E. Notes Receivable from Participants

A participant is allowed to borrow a maximum of 50% of his or her vested account balance up to \$50,000. The minimum loan amount is \$1,000. Loans must be repaid through payroll deductions within five years (except that loans for the purchase of a primary residence may be repaid over ten years). All loans bear interest of prime rate plus 1%.

F. Forfeitures

Forfeited balances of terminated participants' non-vested accounts are applied to reduce administrative expenses and employer contributions. There were no forfeitures for the year ended December 31, 2024. Forfeitures available to be used totaled \$25,595 and \$24,671 as of December 31, 2024 and 2023, respectively.

G. Expenses

Most administrative expenses are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Fair Value Measurements

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of a money market fund and mutual funds valued at fair value based on quoted market prices. Interest and dividends are recorded on the accrual basis. Capital gains are recorded as interest and dividends. Purchases and sales of securities are recorded on a trade-date basis.

D. Payments of Benefits

Benefits are recorded when paid.

E. Risks and Uncertainties

Investments are exposed to interest rates, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 3 - INCOME TAX STATUS

The Plan is based upon a Prototype Volume Submitter Profit Sharing Plan with CODA document that received its most recent tax exempt status from the Internal Revenue Service in a letter dated March 31, 2014. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts, and Plan assets would be distributed based upon the participants' account balances at that time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedules were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued and managed by the trustee or its affiliates. Transactions related to these investments qualify as party-in-interest transactions; however, they are exempt from the prohibition under ERISA.

NOTE 7 - DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, the Company failed to remit \$34,359 of participant contributions within 15 business days after the month in which they were withheld as required by the Department of Labor. Failure to remit or untimely remittance of participant contributions constitutes a prohibited transaction under Department of Labor regulations. The Company has advised corrections will be made in 2025.

NOTE 8 - AMENDMENT

During 2024, the Plan adopted the following amendments:

- To adopt safe harbor contribution provisions, effective January 1, 2024.
- To adopt after tax contribution provisions, effective November 14, 2024.

NOTE 9 - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to increase safe harbor matching equal to 100% of salary deferrals up to 5% of compensation, and 50% of salary deferrals on the next 1% of compensation.

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued. Except as noted above, there were no other material subsequent events that required recognition or additional disclosures in these financial statements.
