NOTE 1 - DESCRIPTION OF PLAN

The following description of TSC Construction LLC Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. A complete description of the Plan may be obtained from the Plan Administrator, TSC Construction, LLC.

General

The Plan is a defined contribution profit sharing plan under Section 401(k) of the Internal Revenue Code that was established on January 1, 2006 for the purpose of providing retirement benefits for eligible employees of TSC Construction, LLC and TSC Contracting, LLC (the Companies). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan's salary deferral option when they reach the age of 18 and have been employed with the Companies for six months.

Contributions

The Plan allows participants to defer up to 100% of their eligible compensation, but participants are limited to the annual threshold set by the Internal Revenue Service. Participants have the option of making Roth elective deferrals. Participants may also contribute funds representing distributions from other qualified plans or individual retirement accounts in the form of direct rollover contributions.

The Companies match 100% of each participant's deferral, up to a maximum of 3% of compensation and 50% of each participant's deferral which are over 3% but are not over 5% of compensation. The Companies may also make discretionary profit sharing contributions each year.

The Plan provides that all employee contributions to the Plan will be invested in certain funds as directed by each participant. The Plan currently offers a variety of mutual funds, pooled separate accounts, and common investment trusts for participants to choose from.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Companies' contributions, (b) Plan earnings, and (c) forfeitures of terminated participants' accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan is a participant-directed Plan.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their elective deferral contributions. There is a six-year graded vesting schedule with regard to the Companies' contributions of 20% vesting after two years of service, and an additional 20% vesting for each additional year of service. In addition, a participant's account balance will become fully vested upon reaching retirement age, becoming disabled or dying while employed by the Companies. Normal retirement age is 65.

Payment of Benefits

Upon termination of employment, participants may receive all or part of their vested account balance paid at any time. If the value of the terminated participant's vested interest is \$5,000 or less, the balance is automatically distributed to the participant in a lump-sum amount. Active participants may receive a portion of their vested accounts once they reach age 65. Required minimum distributions are made once a participant reaches age 70½. Additionally, active participants may make hardship withdrawals to satisfy financial hardships as specified in the Plan document.

Forfeited Accounts

Forfeited, non-vested accounts are retained in the Plan and may be used to pay administrative expenses, used to reduce the contribution of the employer, or allocated to participants' accounts. During the years ended December 31, 2024 and 2023, administrative expenses were not reduced by forfeitures.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on an accrual basis in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The Plan uses estimates and assumptions in preparing financial statements in accordance with generally accepted accounting principles. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan's investments in mutual funds, common investment trusts, and pooled separate accounts are stated at fair market value. If there is no readily available market, the investment's value is the fair value of the underlying investments held in the separate account as determined by the Plan custodian using generally accepted accounting practices and applicable law. The fair value of the pooled separate account (PSA) and common investment trust (CIT) investments held by the Plan are determined by publicly quoted pricing inputs that are used to determine net asset values, which are not publicly quoted.

The Plan's investment in a guaranteed interest contract is considered fully benefit-responsive and is reflected at contract value.

The net realized and unrealized appreciation (depreciation) in fair value of investments reflects the change in market value from beginning of year to end of year, realized gains and losses on sale of underlying investments, and investment earnings.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan sponsor in addition to those paid by the Plan.

Subsequent Events

Management has evaluated events and transactions that have occurred through October 11, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFICATION

The Plan Administrator has obtained a certification from Principal Life Insurance Company, that the following information provided in the annual report to the Plan Administrator is complete and accurate.

(a) In accordance with Subtopic 820-10 certain investments that are measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets.

Generally accepted accounting principles establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

Pooled Separate Accounts (PSA) and Collective Investment Trusts (CIT)

All pooled separate accounts (PSA) and collective investment trusts (CITs) held by the plan are measured at net asset value (NAV) per share of the underlying assets of the fund. The NAV is not a publicly quoted price in an active market and is computed in accordance with investment company measurement principles. Currently all redemptions for PSA's and CITs are at that day's computed NAV.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2024, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$106 and \$-0-, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events might limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Principal Financial Group. Principal Financial Group has physical and administrative control of certain assets of the Plan and executes transactions therein and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$55,181 and \$38,134 for the years ended December 31, 2024 and 2023.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 - INCOME TAX STATUS

The Plan is a prototype plan. The Internal Revenue Service has determined and informed the trustee by a letter dated June 30, 2020 that the prototype plan and the related trust established under the plan are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - PLAN ADMINISTRATION

Certain administrative functions are performed by employees of the Companies. No such employee receives compensation from the Plan.

NOTE 11 - TERMINATED PARTICIPANTS

The value of terminated participants' accounts at December 31, 2024 and 2023 was \$1,032,444 and \$691,929.
