Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Reliable Community Bancshares Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

Note 1: Description of Plan

The following description of the Reliable Community Bancshares Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Reliable Bancshares, Inc. (the "Sponsor") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Newport Trust Company and Ascensus LLC are the Plan Trustees and recordkeepers. Substantially all employees who have completed at least 1 month of service with the Sponsor, as defined in the Plan document are eligible to participate in the Plan.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the provision increasing the age at which participants must begin taking required minimum distributions from age 72 to 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Contributions

Participants may contribute up to 90% of pretax annual compensation, as defined in the Plan document, subject to the limits of the Internal Revenue Service ("IRS"). Participants may also designate some or all of the participant's contributions as a Roth deferral contribution. In addition to regular pretax and/or Roth contributions, participants age 50 and older may make catch-up contributions, subject to the annual dollar limit. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation on a pre-tax basis. Participants may also contribute amounts representing distributions from other qualified plans ("rollover" contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan made safe harbor matching contributions equal to 100% of participant's contributions up to 3% of their eligible compensation and 50% of the participants' deferral over 3% of eligible compensation up to 5% of eligible compensation. To be eligible for Sponsor contributions, participants must have completed at least one year of service with the Sponsor and attained the age of 21. The Plan may make nonelective discretionary contributions. No nonelective discretionary contributions were made by the Plan in 2024.

Note 1: Description of Plan (Continued)

Investment Options

Participant contributions and Sponsor matching contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor matching contributions, discretionary nonelective discretionary contributions, and an allocation of the Plan's earnings (losses). Allocations of Sponsor discretionary contributions are based on the participant's eligible compensation as defined in the Plan document. Allocations of Plan earnings (losses) are based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus any earnings (losses) thereon. Participants who leave the Plan because of death, early or normal retirement, or disability, as defined in the Plan document, are considered 100% vested. Participants are also immediately vested in the Sponsor matching contributions. Nonelective discretionary contributions and earnings (losses) vest as follows :

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's nonelective discretionary contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$279, respectively. Forfeitures are used to pay administrative expenses or reduce Sponsor contributions. Forfeitures of \$3,586 were used to offset 2024 Sponsor contributions. There were no forfeitures used to offset administrative expenses during 2024.

Payment of Benefits

Upon separation from service due to death, retirement, or termination, a participant or a designated beneficiary will receive the value of the participant's vested interest account balance as a partial payment or in the form of a lump-sum. If a separated participant's account does not exceed \$7,000, the benefit will be distributed in a lump sum within a reasonable time after termination of employment. Under certain circumstances, participants may qualify to receive a hardship distribution (less applicable income taxes and penalties) from their account balance. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates and are subject to change in the near future.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses and investment transaction fees are paid by the Plan. Plan expenses are allocated on a pro rata basis to the participants' individual account balance. Professional fees and certain other Plan expenses are paid by the Sponsor.

Subsequent Events

The Plan has evaluated subsequent events through Thursday, October 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Collective investment trusts: Fair value is estimated using net asset value ("NAV") per unit by the issuer and is based on the NAV of the underlying investments held in the collective investment trust. Investments in collective investment trusts can be purchased or sold continuously. These funds are directly invested in open-ended mutual funds. A one day notice of redemption is required. The Plan has no obligation to buy additional units.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Mutual fund whose investments are primarily or exclusively in the short-term debt securities designed to maximize current income with liquidity and capital preservation, usually maintaining per share NAV at a constant amount, such as one dollar.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

Note 5: Tax Status

The IRS has determined and informed the Sponsor by a letter, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 6: Information Prepared and Certified by Custodians

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Newport Trust Company and Ascensus LLC, the custodians of the Plan.

Note 7: Party-in-Interest Transactions

At December 31, 2024 and 2023, certain Plan investments are shares of collective investment trust funds of the Bank of Missouri. The Bank of Missouri provides investment management services to the Plan and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
