### **1. Description of Plan**

The following description of California Vocations, Inc. Employer Matching Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a 403(b) defined contribution plan covering all eligible employees of California Vocations, Inc. (“CVI”) as defined in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### **Contributions**

CVI’s plan contributions are discretionary and are determined at the beginning of the plan year based on the availability of funds. All employees are eligible to participate upon hiring. CVI may contribute to the Plan up to 3% of compensation that a participant contributes to the Plan. To be eligible for employer matching, employees must have completed one year of employment. A year of employment is defined as twelve consecutive months of employment beginning on the date of hire (or rehire) and at least one-thousand hours of service during that year.

Effective January 1, 2016, the Plan was amended to allow ROTH contributions.

Participants may contribute any percentage of their annual compensation, as defined in the Plan, up to the maximum limit as permitted by the Internal Revenue Code (“the Code”). In addition, participants who are at least age 50 by December 31 of the calendar year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. Plan earnings are allocated to all participant-directed accounts, with each participant having a separate and distinct basis for earnings allocation, and may be valued at any time during the year.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, CVI's matching contributions, and the Plan's earnings. Investment allocations are based on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

#### **Vesting**

Participants’ contributions are fully and immediately vested. Vesting for employer contributions is pro-rated on years of continuous service. A participant is 100% vested after five years of credited service.

**1. Description of Plan, continued**

**Plan Loans**

Participants may borrow up to 50% against the vested portion of their annuity account balance to a maximum loan of \$50,000. The minimum loan is \$1,000. The maximum loan term is five years, although it may be longer for the purchase of a primary residence. A participant may have a maximum of two loans at any given time. Loan payments of principal and interest must be in level amortized payments, either monthly or quarterly by electronic fund transfer from a checking or savings account.

When a loan is processed, an amount equal to the outstanding principal of the loan is transferred to a loan reserve account. The funds held in the loan reserve account serve as the only acceptable collateral for the loan and access to the account is not allowed. The funds in the loan reserve account are invested in the fixed account. As the loan is repaid, the loan reserve account is reduced by the amount of the loan repayment applied to the principal and transferred to the same source of contributions from which the loan was made. The loan reserve account earns interest at an annual rate of 4.5% while the loan rate of interest is an annual rate of 7%. Unpaid loan amounts will be taxed as ordinary income and may incur a 10% federal tax penalty if the participant is under age 59½, see Note 3.

**Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered by the trustee. Participants may change their investment options at any time.

**Forfeitures**

Amounts of participants forfeited non-vested accounts are applied to pay plan expenses before being used to reduce employer matching contributions. Forfeitures of non-vested amounts are triggered when there is a complete distribution after termination of employment. Otherwise, the non-vested balances remain in the participant's account. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$124 and \$712, respectively. Forfeitures used during 2024 and 2023 were \$600 and \$1,700, respectively.

**Payment of Benefit**

Upon attaining age 59½ or the termination of employment for any reason, a participant may request a complete distribution of their account in a single sum or as even installments over a period not to exceed the participant's life expectancy. Hardship withdrawals are also available. Distributions that are neither based on hardship nor installments over a ten-year period or more will ordinarily be eligible for rollover to another eligible retirement plan.

**Death Benefits**

If an active employee dies, the employee's benefit becomes 100% vested and the beneficiary will receive the balance of the employee's account.

2. **Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

**Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

**Administrative Expenses**

CVI absorbs all administrative expenses of the Plan other than the contract services charged by the trustee. During the years ended December 31, 2024 and 2023, the total contract charges were \$2,822 and \$3,061, respectively.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

**Subsequent Events**

Management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

**3. Plan Loans**

Plan loans are loans funded by the trustee and accordingly, they are not reflected in the Plan. These plans are loans in which participants request loans using the assets of their accounts as collateral. As of December 31, 2024 and 2023, outstanding loans totaled \$81,589 and \$86,328, respectively.

**7. Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$2,822.

The Plan's investment options include funds managed by Lincoln National Life Insurance Company. As custodian and recordkeeper, Lincoln National Life Insurance Company's transactions qualify as exempt parties-in-interest transactions.

**8. Plan Termination**

Although it has not expressed any intent to do so, CVI has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**9. Tax Status**

The Plan presently does not have a tax determination letter from the Internal Revenue Service (“IRS”) since 403(b) plans currently are not required to submit plans to the IRS for determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
