Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed

to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 – Description of the Plan**

---

The following description of the Hurt & Proffitt, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement, as amended and restated, for a more complete description of the Plan’s provisions.

*General*

The Plan is a defined contribution plan covering substantially all employees of Hurt & Proffitt, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Administration*

The Company is the Plan Administrator. All assets of the Plan are held by the Trustee, Matrix Trust Company.

*Eligibility*

All employees who have reached 18 years of age and completed 2 months of service are eligible to participate in the Plan starting the first day of the next Plan quarter. Employees, if any, who are governed by a collective bargaining agreement, are excluded from participating in the Plan. Part time employees who are scheduled to work less than 1,000 hours during the Plan year will be excluded from all Plan Sponsor contributions.

*Participant Contributions*

Participants may contribute up to 100% of their eligible annual compensation as pre-tax or Roth deferrals to the Plan, subject to certain *Internal Revenue Code (IRC)* limitations. For the year ended December 31, 2024, participants could contribute up to \$23,000. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution.

The Plan includes an automatic enrollment provision which stipulates that eligible Plan participants are deemed to have made a 3% pre-tax salary deferral election in the event the participant fails to make a salary deferral election and does not affirmatively elect out of participating in the Plan. Additionally, the Plan includes an automatic escalation provision which stipulates each participant’s salary deferral percentage will automatically increase annually on March 1 by 1% up to a maximum contribution percentage of 6%, unless a participant elects a different contribution percentage.

*Catch-Up Contributions*

For the year ended December 31, 2024, if a participant is eligible to make deferrals and reaches age 50 before the end of any calendar year, the participant may defer an additional \$7,500 into the Plan as a pre-tax contribution subject to certain *IRC* limitations. Effective January 1, 2025, this limit will be increased to the greater of \$10,000 or 50 percent more than the regular catch-up amount for individuals who have attained ages 60, 61, 62, and 63. Effective January 1, 2026, catch-up contributions will be made on a Roth basis for individuals with compensation of \$145,000 or more.

*Company Matching Contribution*

The Plan provides for a Company safe harbor matching contribution to eligible participants equal to 100% of the participant's contributions up to 1% of eligible compensation plus 50% of the participant's contributions that exceed 1% but do not exceed 6%. The Company may also make a discretionary profit-sharing contribution; however, no discretionary profit sharing contributions were made during the year ended December 31, 2024.

*Participant Accounts*

Each participant's account is credited with the participant's contribution, matching contribution, Company's discretionary contribution, if any, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Participant Investment Options*

Under the Plan, the participant may direct the investment of both the Company and his or her contributions. Participants may change their investment options daily.

*Vesting*

Participants are immediately vested in their salary deferral contributions, rollover contributions, and actual earnings thereon. A participant also becomes 100% vested upon death, becoming permanently disabled, or reaching the normal retirement age, as defined by the Plan.

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000. Total loans outstanding may not exceed 50% of a participant's vested account balance. Repayment terms for the loan are five years

unless the loan is used to purchase the principal residence of the participant, in which case the loan term may not exceed thirty years, with the loan balance amortized in equal installments over the life of the loan. Each loan is secured by the participant's vested account balance. The interest rate is determined on the first business day of each month and applied to all loans applied for in that month. The interest rate utilized is the current prime rate listed by the Trustee plus 1.00%. As of December 31, 2024, interest rates on notes receivable from participants ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

### *Benefit Payments*

Distributions to participants can be made due to retirement, death, disability, attainment of age 59½, or termination of employment and are subject to the applicable provisions of the Plan agreement. Up to 100% of the participant's account balances can be paid as a direct rollover to another qualified plan or as a lump sum to the participant or their beneficiaries.

Upon showing of "financial hardship", a participant may withdraw part or all of the vested portion of their accounts, except any Qualified Non-Elective Contribution account and certain earnings of a participant's Elective Deferral account.

### *Forfeitures*

Plan forfeitures are used to reduce Company contributions, pay Plan expenses, or reallocated to Plan participants. No forfeitures were utilized to reduce the Company safe harbor matching contributions or plan expenses during 2024. Forfeiture balances as of December 31, 2024 and 2023, were \$756 and \$1,747, respectively. In 2024, \$7,153 in forfeitures were used to pay Plan expenses.

## **Note 2 – Summary of Significant Accounting Policies**

---

### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Valuation of Investments and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expense and are expensed when they are incurred.

*Payment of Benefits*

Benefit payments to participants are recorded when paid.

*Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

*Subsequent Events*

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

---

**Note 6 – Tax Status**

The Plan has adopted a volume submitter plan sponsored by Employee Fiduciary, LLC which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**Note 7 – Party-in-Interest Transactions**

---

The Plan receives investment management and advisory services from Evolution Advisers, Inc. The Plan pays investment management fees to Evolution Advisers, Inc. and, therefore, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan paid investment management and advisory fees of \$44,763, which are included in administrative expenses in the accompanying statement of changes in net assets available for benefits. In addition, notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services.
