## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
Research Foundation for Mental Hygiene, Inc. Emeriti Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Research Foundation for Mental Hygiene, Inc. Emeriti Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Research Foundation for Mental Hygiene, Inc. Emeriti Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Research Foundation for Mental Hygiene, Inc. Emeriti Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Research Foundation for Mental Hygiene, Inc. Emeriti Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Research Foundation for Mental Hygiene, Inc. Emeriti Plan (the “Plan”) provides only general information. Participants should refer to the Research Foundation for Mental Hygiene, Inc. Emeriti Plan summary plan description and plan document for a more complete description of the Plan’s provisions.

#### General

The Plan, effective October 1, 2015, provides post-retirement health benefits, covering the employees of Research Foundation for Mental Hygiene, Inc. (the “Foundation”) and their covered dependents. The Plan is a defined contribution health model plan that is funded through employer and employee Voluntary Employees’ Beneficiary Association (VEBA) Trusts designed in part by Emeriti Retirement Health Solutions, a not-for-profit company. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options. The Emeriti Retirement Health Solutions Company appointed Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively “TIAA”) as the trustee of the Plan (the “Trustee”). The Foundation is the Plan sponsor and administrator of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Eligibility

All employees who are age 21 or older and are in an eligible class of employment, as defined in the Plan document, are eligible to participate.

#### Contributions

Participants, including those no longer employed by the Foundation, may make after-tax contributions into an account, provided the account maintains a positive balance. Once an eligible participant attains the earlier of age of 40 or has completed 10 years of service, the Foundation will begin to make a contribution for each full month in which the employee is in benefit eligible status. Employer contributions will also be made annually based on the participant’s sick leave balance. Certain retired participants receive contributions into their accounts based on their age at retirement, length of service, and year of retirement from the Foundation.

#### Participant Accounts

Participant accounts are credited with contributions, an allocation of the Plan’s earnings/losses and interest (net of administrative expenses), based on the participant’s selected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting and Forfeiture

Participants are immediately vested at the time employee contributions are deposited into their accounts. Participants must meet two requirements to vest in employer contributions, (1) participant must have 15 years of service; and (2) years of service added to the participant’s age must be greater than 70 at the time of termination.

**Vesting and Forfeiture** (Continued)

All employer asset sources in the Emeriti Retiree Health Account are forfeitable upon termination if the vesting requirements are not met. The Trustee will transfer the forfeitable balance to the forfeiture account at the direction of the Foundation. These accounts will be used to pay either future administrative expenses or reduce future employer contributions. Forfeited amounts were approximately \$334,000 and \$1,060,000 at December 31, 2024 and 2023, respectively. Forfeitures of approximately \$1,133,100 and \$1,479,500 were used to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively.

**Payment of Benefits**

The Plan makes available certain health benefits to retired participants of the Plan. Retirees may elect an Emeriti Health Insurance option when they achieve age 60 and have 15 years of continuous service with age and years of service totaling a minimum of 70 years as of the date they cease employment. The plans have the option for prescription coverage. Participants may obtain Health Insurance by making a timely election, as provided in the Plan Document. The spouse of a retiree may also enroll in health coverage. Monthly insurance premiums are incurred by the selection of a health insurance option and are deducted from the participants' VEBA account. If the participants' account is exhausted, participants may retain coverage under the Emeriti Health Insurance option by paying insurance premiums directly from a personal checking or savings account. COBRA is available for dependents of retirees who lose eligibility.

A participant is eligible for reimbursement benefits payable from the non-forfeitable balance in their VEBA account when they achieve 15 years of continuous service with age and years of service totaling a minimum of 70 years as of the date they cease employment. Participants may submit qualified medical expense claim forms along with the required documentation for reimbursement. In the event of the death of a participant, the dependent named on the account may submit qualified medical expenses for reimbursement until the account is exhausted.

**Termination of Plan**

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA.

**Administrative Expenses**

All administrative expenses except those relating to the investment transactions are paid by the Foundation. Expenses relative to the investment transactions are netted against investment income when reported by the insurance companies or custodian.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting and Use of Estimates**

The accompanying financial statements have been prepared on the accrual basis of accounting. The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value using quoted market prices.

Net appreciation (depreciation) in fair value of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses and unrealized appreciation or depreciation. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represents the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest earned on investments is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

**Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – inputs include: quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset and; inputs derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – inputs are unobservable and cannot be corroborated by observable market data.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used.

*Registered Investment Company Accounts:* Registered investment companies investments are valued daily at the net asset value of the shares or units held.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 — INFORMATION CERTIFIED BY TRUSTEES**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We have been informed by the Plan Administrator that:

- Teachers Insurance and Annuity Association of America (TIAA), trustee, held the Plan's investment assets and executed investment transactions at December 31, 2023 and for the period from January 1, 2023 to December 17, 2024.
- Alta Trust, trustee, held the Plan's investment assets and executed investment transactions at December 31, 2024 and for the period December 18, 2024 to December 31, 2024.

Accordingly, TIAA and Alta Trust have furnished certain financial information to the Plan Administrator and certified as to its completeness and accuracy. These certifications are as of and for the years ended December 31, 2024 and 2023, and includes investment information related to investments, net appreciation in fair value of investments, and dividend and interest income that is included in the Plan's financial statements and supplemental schedule of assets (held at end of year).

**NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS**

Plan investments were managed by TIAA for the period January 1, 2023 through December 17, 2024. TIAA was the insurance company and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

**NOTE 6 — INCOME TAX STATUS**

The Plan obtained its latest determination letter on February 8, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
